### NOTES TO FINANCIAL STATEMENTS June 1, 2024 and December 31, 2023

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of DWA Healthcare Communications Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was organized effective January 1, 2006, as a defined contribution retirement savings plan covering all eligible employees of DWA Healthcare Communications Group, Inc. (the Employer) who have at least 30 consecutive days of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Senior Investment Committee of the Employer is responsible for oversight of the Plan. The 401(k) Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Senior Investment Committee.

**Plan Merger:** On March 28, 2024, the Employer adopted an amendment to the Plan Agreement to change the Plan Sponsor's name to Real Chemistry, Inc (EIN: 26-2729056) and to cease all Plan contributions, effective April 1, 2024. All Plan participants became participants in The Real Chemistry 401(k) Savings Plan as of April 1, 2024, and all Plan contributions ceased as of that date. In addition, the Plan Agreement was amended to merge the Plan into and with The Real Chemistry 401(k) Savings Plan, effective as of June 1, 2024. All of the Plan's assets and related liabilities were transferred to and/or assumed by The Real Chemistry 401(k) Savings Plan as of June 1, 2024, at which time the Plan and its related trust ceased to exist.

**Contributions:** Each year, participants could authorize the Employer to contribute to the Plan up to 100% of their eligible annual compensation, subject to the maximum annual amount permitted under Section 402(g) of the Internal Revenue Code (IRC). Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants could also make rollover contributions from amounts representing distributions from other qualified plans and certain Individual Retirement Accounts (IRA) as defined in the Plan Agreement. Contributions were subject to certain limitations under the IRC.

The Plan included an auto-enrollment provision whereby certain employees were automatically enrolled in the Plan unless an affirmative election not to participate in the Plan was executed. Automatically enrolled participants had their contribution rate set at 6% of eligible compensation and their contributions were invested in a designated fund until changed by the participant.

The Employer could elect to make discretionary matching contributions to the Plan. For 2024, the Employer declared a matching contribution allocation equal to 50% of the first 6% compensation that each participant contributed to the Plan. As a result of the Plan's merger, the 2024 Employer's matching contribution will be calculated and funded to The Real Chemistry 401(k) Savings Plan by the appropriate due date in 2025.

Participants directed the investment of their contributions, as well as those made by the Employer, into various investment options offered by the Plan.

**Participant Accounts:** Each participant's account was credited with the participant's contributions and the Employer's matching contributions, as well as allocations of the Plan's earnings. Participant accounts could also be charged with an allocation of certain administrative expenses of the Plan. Allocations were based on participant earnings or account balances, or specific participant transactions, as defined in the Plan Agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

## NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

**Vesting and Forfeitures:** Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their account was based on years of service. A participant became 20% vested after one year of service, increasing by 20% per additional year, with full vesting after five years of credited service.

At June 1, 2024, forfeited nonvested accounts of terminated participants totaling \$45,997 were transferred to The Real Chemistry 401(k) Savings Plan. At December 31, 2023, forfeited nonvested accounts of terminated participants totaled \$30,275. These accounts could be used to reduce future Employer contributions and/or pay Plan expenses, as defined in the Plan Agreement. In 2024, forfeited nonvested accounts of \$14,297 were used to pay Plan expenses.

**Notes Receivable from Participants:** Participants could borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment terms of the notes could not exceed five years per the Plan Agreement. The notes were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest were paid ratably through regular payroll deductions.

**Benefits:** Upon the occurrence of a distributable event due to separation from service by termination, death, disability, retirement, or other reasons, as defined by the Plan Agreement, a participant could elect to receive a lump-sum cash distribution, partial payments, or installments equal to the value of the participant's vested interest in their account. Hardship and in-service withdrawals, as well as, required minimum distributions, rollover contribution account distributions, and automatic distributions to former participants, as defined in the Plan Agreement, were also permitted from a participant's account.

**Plan Termination:** Prior to the Plan's merger, the Employer had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Investment Committee determined the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** The Plan's notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. No allowance for credit losses was recorded as of June 1, 2024 or December 31, 2023. If a participant ceased to make repayments and the Plan Administrator deemed the note receivable from the participant to be in default, the balance of the note receivable from the participant was reduced and a benefit payment was recorded per the Plan Agreement.

**Payment of Benefits:** Benefits were recorded when paid.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Expenses:** Administrative expenses for maintaining the Plan could be paid by the Employer or the Plan, at the Employer's discretion. Certain administration fees were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Tax Status:** The Plan was based on a pre-approved defined contribution plan document whose sponsor has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with the applicable sections of the IRC. Although the Plan and the pre-approved defined contribution plan document had been amended since receiving the opinion letter, the Plan Administrator believed that the Plan was designed and operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believed that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

**Subsequent Events:** The Plan Administrator has evaluated the financial statements for subsequent events occurring through March 4, 2025, the date the financial statements were available to be issued.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. In situations where there is little or no market activity for the asset or liability, the Plan makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

### NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used by the Plan for assets that were measured at fair value on a recurring basis. There have been no changes in the methodologies used at June 1, 2024 and December 31, 2023.

**Registered Investment Companies (Mutual Funds) and Money Market Fund Shares:** Valued at the daily closing price as reported by the funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

**Collective Trust Funds:** Valued at the unit price reported by the sponsoring bank or trust company. The underlying investments owned by the funds can include money market funds, stable value funds, fixed-income securities, registered investment companies, common stocks, corporate bonds, U.S. Government securities, other collective trust funds, or guaranteed investment contracts priced by the sponsoring insurance company using applicable interest rates and contract provisions. The unit price is based on the fair value of these underlying investments owned, less any accrual of fees and expenses borne by the fund, and divided by the number of units outstanding. The unit price is readily determinable and quoted on the active private market on which participants can transact daily with no redemption restrictions on these investments.

The preceding methods could produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

Following is a summary, within each level of the fair value hierarchy, of the Plan's assets that were measured at fair value on a recurring basis as of December 31, 2023. Due to the Plan's merger, there were no investments measured at fair value as of June 1, 2024:

### NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE (UNAUDITED INFORMATION)

All Plan information related to investments and notes receivable from participants held at June 1, 2024 and December 31, 2023, and net appreciation or depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2024 to June 1, 2024, disclosed in the accompanying financial statements and supplemental schedule was obtained by the Plan's management and agree to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, the Plan's trustee, in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### NOTE 5 - PLAN AMENDMENTS

Effective January 29, 2024, the Employer amended the Plan Agreement to update the Plan's definition of eligible compensation to exclude certain transaction bonuses arising from the sale of the Employer to Real Chemistry, Inc., with respect to all contribution types.

## **NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan had arrangements with several third-party service providers. The Plan paid certain expenses related to the Plan's operation, administration, and investment activity. The Plan's expenses could be paid directly to the respective service provider or indirectly through the Plan's investments returns. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

The Plan could receive revenue-sharing compensation from certain Plan investment options. This revenue, if any, was used to offset certain recordkeeping and administration services to the Plan and/or was allocated to participant accounts as additional earnings.

The Employer provided certain accounting, administrative and investment management services to the Plan for which it received no compensation.

Notes receivable from participants were permitted party-in-interest transactions.

## **NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan's investment securities were exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
