I am writing today to provide an explanation as to why my company's 2023 Form 5500 (final filing) was not filed with the U.S. Department of Labor. In 2023, I terminated our 401(k) plan held with ADP. The effective date of this plan termination was 9/29/23. After funds were drawn down to \$0.00 via Plan Termination Distribution checks all taking place in October 2023, ADP was to prepare the final Form 5500 within 5 months and email me further credentials to submit the final 2023 filing.

To date and after an exhaustive good faith search across all my active email accounts, no such email message can be found on my end. A phone call between myself and an ADP retirement services representative took place on 1/16/25 confirming the final Form 5500 as still outstanding and confirming the email account these final filing instructions were supposedly sent to. Again, no email of final filing instructions was ever received by myself, the plan administrator.

In consideration of never receiving the final filing instructions from ADP, I do not believe my company should be subject to additional penalties/fees for a late filing and I respectfully ask the U.S. Department of Labor to agree with such position. I am happy to continue to work with ADP to gain access to the final filing instructions and forms to conclude this matter.
