Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Open Sky Wilderness 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 25, 2024 (in Liquidation) and December 31, 2023 (Ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through September 25, 2024 (in Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of September 25, 2024 and December 31, 2023 and for the period from January 1, 2024 through September 25, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the Plan Sponsor terminated the Plan effective March 31, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used to present the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to Financial Statements

September 25, 2024 (in Liquidation) and December 31, 2023 (Ongoing)

Note 1 – Description of the Plan

The following description of the Open Sky Wilderness 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan was a defined contribution plan, which went into effect January 1, 2015, that was generally available to all employees of ACF Enterprises, LLC (the "Company," "Employer," "Plan Sponsor," or "Plan Administrator"). The Plan excluded union employees, leased employees, and non-resident aliens. Employees became eligible after attaining age 21 and completing one year of eligibility service. Employees were able to enter the Plan on the first day of the first month and seventh month of the Plan year coincident with or next following the date the Plan's eligibility requirements were met. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Plan Termination. Effective March 31, 2024, the Plan document was amended to terminate the Plan. In connection with the Plan's termination the following occurred:

- All participants in the Plan as of March 31, 2024, are 100% vested in their entire account balance;
- No further contributions will be made to the Plan;
- The Plan was amended to ensure document compliance with the most recent statutory or regulatory changes;
- The Plan's termination created a distributable event for all the Plan's participants and the Plan was fully liquidated on September 25, 2024; and
- As further discussed in Note 2, the Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting.

Contributions. The following types of contributions were allowable under the Plan:

- Elective Deferral Contributions – Participants had the option to contribute a percentage of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Participants also had the option to contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. A participant's total elective deferral contributions cannot exceed \$23,000 (\$30,500 if age 50 or over) in calendar year 2024.
- Safe Harbor Employer Matching Contributions – The Employer made safe harbor matching contributions each plan year equal to 100% of the participant's elective deferrals that did not exceed 3% of their compensation, plus 50% of the participant's elective deferrals that exceed 3% but that did not exceed 5% of their compensation.
- Discretionary Employer Matching Contributions – The Employer had the option to contribute matching amounts to eligible participants based on such participants' elective deferrals contributed to the Plan. Such contribution was limited to 4% of eligible compensation. For the period ended September 25, 2024, the Employer did not make a discretionary Employer matching contribution.

Note 1 – Description of the Plan (continued)

- **Discretionary Employer Non-Elective Contributions** – The Employer had the option to make a discretionary non-elective contribution to eligible participants who had completed 1,000 hours of service during the Plan year and were employed on the last day of the Plan year. Participants who had a severance from employment due to death, disability, or attainment of normal retirement age were also eligible to receive an allocation. Such contribution would be allocated to each eligible participant's account in the ratio that each participant's compensation bears to the compensation of all eligible participants. For the period ended September 25, 2024, the Employer did not make a discretionary Employer non-elective contribution.
- **Rollover Contributions** – Certain amounts distributed to eligible participants from other qualified employee benefit plans were able to be rolled into the Plan.

All contributions were allocated to the Plan's investment funds at the direction of the participants.

Investment Options. Participants were able to direct their investments into various registered investment companies.

Participant Accounts. Each participant's account was credited with the participant's contributions (elective deferrals and rollovers, if any) and an allocation of (a) the Employer's contributions (safe harbor, discretionary matching, and discretionary non-elective, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Vesting. Participants were immediately vested in their salary deferral contributions, safe harbor Employer matching contributions, rollover contributions, and related earnings thereon. Participants vested in discretionary Employer matching contributions and discretionary Employer non-elective contributions based on a two-six year graded vesting schedule, whereas a participant became 20% vested after two years of service and 20% for each additional year of service until they became 100% vested after six years of service. Additionally, employed participants became 100% vested in their accounts upon attainment of normal retirement age, termination, or partial termination of the Plan.

Forfeitures. When certain terminations of participation occur, the non-vested portion of a participant's account represented a forfeiture. Forfeitures were able to be used to reduce Employer contributions or pay administrative expenses of the Plan. As of September 25, 2024 and December 31, 2023, the balance in the forfeitures account totaled \$0 and \$259, respectively.

Payment of Benefits. Benefits to participants or beneficiaries generally were payable as a lump sum equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than \$5,000 had the option to be automatically paid out by the Plan upon termination. Additionally, participants were able to request in-service withdrawals of their rollover contributions account or certain portions of their account upon attainment of age 59½, upon a deemed severance, for a qualified reservist distribution, or if they incurred a financial hardship, as defined, if certain criteria were met.

Note 2 – Summary of Significant Accounting Policies

Change in Basis of Accounting. As further discussed in Note 1, the Plan was terminated effective March 31, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used to present the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements.

Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

Benefits Payments. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Included in administrative expenses are distribution and other fees. Additionally, certain investment related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 3 – Fair Value Measurements (continued)

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at September 25, 2024 and December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies ("RICs") are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Certified Information

The following information disclosed in the accompanying financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, the trustee of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of September 25, 2024 (in Liquidation) and December 31, 2023 (Ongoing);
- Investment amounts as shown in Note 3; and
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 through September 25, 2024 (in Liquidation).

Note 5 – Tax Status

The Plan Sponsor has adopted a Qualified Pension Services Inc Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the IRS on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of September 25, 2024 and December 31, 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 25, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Party-In-Interest Transactions

The Company provided to the Plan certain accounting and administrative services for which no fees were charged.

Certain Plan investments were shares of RICs offered by American Funds. As American Funds and Capital Bank and Trust Company, the trustee of the Plan, are related entities of the Capital Group, these transactions qualified as party-in-interest transactions. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.
