Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements Southwest Network, Inc. 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

1) Summary of Significant Plan Provisions

The following description of the Southwest Network, Inc. 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established effective July 1, 2006. The Plan covers all employees of Southwest Network, Inc. and Open Skies Healthcare, Inc. an affiliate of Southwest Network, Inc. (the “Company” or “Employer”). The Plan was amended and restated effective July 1, 2019, and adopted a volume submitter 403(b) plan sponsored by FIS Business Systems LLC. The Plan allows immediate participation to employees for pretax and after-tax salary deferral contributions. Employees are eligible to participate in the Company’s discretionary matching contribution and nonelective contribution portions of the Plan after one year of service, as defined in the Plan document. To receive the nonelective contribution, the participant must be employed as of the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan document, limited to the annual statutory maximum as determined by the Internal Revenue Service. Additional catch-up contributions may be made by participants who have attained age 50 before the end of the Plan year. Participants are also allowed to make after-tax contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Upon enrollment in the Plan, participants direct the investment of all contributions in a variety of investment options offered by the Plan. The Plan currently offers various mutual funds (i.e., registered investment companies) as investment options for participants. For the Plan year ended June 30, 2024, the Company made discretionary matching contributions to the Plan equal to 40% of the first 10% of eligible compensation that a participant contributed to the Plan. For the Plan year ended June 30, 2024, the Company elected not to make a discretionary nonelective contribution to the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer’s contribution, and allocations of Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the excess of participant's highest outstanding notes balance during the 12-month period ending on the date of the note over the participant's current outstanding note balance on the date of the note. The notes must be repaid over a period of not more than five years unless the note qualifies as a home loan, as defined by the Plan document. The notes are secured by the balance in the participants account and bear interest at a rate equal to 1% above the prime rate. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's matching contribution, plus earnings thereon, is based on years of service as defined by the Plan. A participant is 100% vested after four years of credited service. A participant shall become full vested upon death, disability, or normal retirement as defined by the Plan document.

Payments of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or installment payments. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used to pay Plan administrative expenses or reduce future Employer contributions. At June 30, 2024 and 2023, forfeiture balances were \$6,808 and \$22,454, respectively. During the Plan year ended June 30, 2024, \$23,458 in forfeited accounts were used to reduce Company contributions.

2) **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. The notes receivable from participants are secured by participants account balance and bear interest at a reasonable rate defined by the Plan, which ranges from 4.25% to 9.50% as of June 30, 2024.

Risk and Uncertainties

The Plan invests in a variety of investment funds. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan permits, but does not require, the Employer to pay significant costs of Plan administration. At any time, the Employer may elect for the Plan to pay administration costs. The Employer paid a majority of the Plan's expenses for the year ended June 30, 2024, which are excluded from these financial statements. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through February 11, 2025, the date which the financial statements were available to be issued.

3) Investments and Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds: Shares of registered investment companies (mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4) Information Prepared and Certified by the Custodian (Unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, current custodian of the Plan, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment income reflected on the accompanying statement of changes in net assets available for benefits for the years ended June 30, 2024.
- Investments reflected on the supplemental schedule of assets (held at end of year).

Notes receivable from participants and interest income on notes receivable from participants are not certified.

5) Fully Benefit Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya), which is an obligation of Voya's general account. The fixed accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed income guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investments choices have a portfolio investment rate design in which all deposits in the particular investment choice are credited with the same interest rate on a daily basis. Such interest rates are reviewed on a semiannual basis for resetting.

Average yield earned for the fully-benefit responsive fixed income accounts with an adjustment to reflect the actual interest rate credited to participants is calculated by dividing annualized earnings credited to participants by the contract value of the investment. The average yields based on actual earnings and crediting interest rate credited to participants for the 2024 year was approximately 3.00%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that no events have occurred or are probable of occurring that would limit the Plan's ability to transact at contract value with participants. The fixed income guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6) Plan Termination

Although it has not expressed intent to do so, the Employer, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

7) Income Tax Status

The Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and believes the Plan is tax-exempt under the Code Section 403(b). The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Services in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan is operating under a volume submitter document with a non-standardized adoption agreement. The Internal Revenue Service (IRS) has determined and informed the prototype plan sponsor by letter dated March 31, 2017, that the plan, as then designed, is in compliance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan is no longer subject to income tax examinations for years prior to 2021.

8) Related-Party and Party-In-Interest Transactions

The Plan investments are managed by Voya Retirement Insurance and Annuity Company, current custodian. These transactions qualify as exempt party-in-interest transactions. In addition, the Employer provides certain accounting, administrative, and management services to the Plan for which no fees are charged. For the year ended June 30, 2024, fees paid by the Plan for administrative expenses, such as third-party administrative fees were \$59,826.
