## Independent Auditors' Report

To the Retirement Committee  
Eckerd Youth Alternatives, Inc. Retirement Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Eckerd Youth Alternatives, Inc. Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of May 21, 2024 (in liquidation) and June 30, 2023 (in liquidation), the related statement of changes in net assets available for benefits for the period from July 1, 2023 to May 21, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of May 21, 2024 and June 30, 2023 and for the period from July 1, 2023 to May 21, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

### **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 1 to the financial statements, the Board of Directors of Eckerd Youth Alternatives, Inc., the Plan’s sponsor, voted on July 12, 2023 to terminate the Plan effective June 30, 2023. In accordance with accounting principles generally accepted in the United States of America, the Plan is being presented on the liquidation basis. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors’ Responsibilities for the Audit of the Financial Statements**

**(1) Description of Plan**

The following description of the Eckerd Youth Alternatives, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

**(a) General**

The Plan is a money purchase defined contribution plan sponsored by Eckerd Youth Alternatives, Inc. (the “Organization”), for the benefit of its employees who have completed one year of service as defined in the Plan. Employees may enter the Plan immediately upon satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was effectively frozen as of July 1, 2015. There were no new entrants to the Plan and no additional contributions were made to the Plan subsequent to this date. As discussed in Note 7, the Plan was terminated effective June 30, 2023. During the period from July 1, 2023 to May 21, 2024, the Plan was fully liquidated.

**(b) Participant Investment Account Options**

The Plan currently offers various mutual funds, a collective investment trust and a guaranteed interest account as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**(c) Participant Accounts**

Each participant’s account is credited with an allocation of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Prior to the termination of the Plan, on termination of service due to death, disability, or retirement (after attainment of normal retirement age, defined in the Plan as age 65) or other reasons, a participant would receive a distribution in the form of a qualified joint and survivor annuity ("QJSA"), unless the QJSA was waived pursuant to a qualified election. If such an election was made, participants could also elect to receive a lump-sum distribution, partial lump-sum distributions or installment payments. If a participant's vested account did not exceed \$5,000, the participant could only elect to receive the distribution as a lump sum. If the participant's vested account was less than \$5,000 but greater than \$1,000, and the participant made no election, the amount would be automatically rolled over to an IRA. All vested accounts less than \$1,000 would be automatically distributed to the participant upon termination as soon as administratively feasible.

With the termination of the Plan effective June 30, 2023, participants could elect to receive their vested account as an annuity or lump-sum distribution.

**(g) Forfeited Accounts**

At May 21, 2024 and June 30, 2023, forfeited nonvested accounts totaled \$0 and \$23,889, respectively. For the period from July 1, 2023 to May 21, 2024, \$23,997 of forfeited nonvested accounts were used to pay plan expenses.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Accounting**

In accordance with accounting principles generally accepted in the United States of America, the Plan's basis of accounting was changed to the liquidation basis effective June 30, 2023, the date on which liquidation of the Plan was considered imminent.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**(c) Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(d) Payment of Benefits**

Benefits are recorded when paid.

**(e) Administrative Expenses**

Certain expenses of the Plan are paid by the Organization and are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments.

**(3) Information Prepared and Certified by the Trustee and Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the trustee, and Empower Annuity Insurance Company of America on behalf of Massachusetts Mutual Life Insurance Company ("MassMutual"), the custodian, have certified that the following data included in the accompanying financial statements are complete and accurate with respect to investments:

- Mutual funds, at fair value
- Collective investment trust, at fair value
- Guaranteed interest account, at contract value
- Net appreciation in fair value of investments
- Dividends
- Interest on guaranteed interest account

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

**(4) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Codification Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**(4) Fair Value Measurements - Continued**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 21, 2024 and June 30, 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

No investments at fair value were held as of May 21, 2024.

**(5) Fully Benefit-Responsive Investment Contract**

The Plan has a fully benefit-responsive guaranteed interest contract with MassMutual. MassMutual maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified rate of interest that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting interest rate is reviewed on a quarterly basis for resetting. The guaranteed interest contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**(5) Fully Benefit-Responsive Investment Contract - Continued**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. Aside from the termination of the Plan as described in Note 7, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants. During the period from July 1, 2023 to May 21, 2024, the guaranteed interest account was liquidated after the provisions of the guaranteed interest contract for termination and liquidation were satisfied.

**(6) Party-in-Interest Transactions**

Certain Plan investments are a mutual fund and fully benefit-responsive investment contract managed by MassMutual. MassMutual is a custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

The Plan paid approximately \$85,200 to Empower for recordkeeping services to the Plan, approximately \$27,600 to FRC for third-party administrative services to the Plan and approximately \$6,400 to investment advisors for the period from July 1, 2023 to May 21, 2024. While these transactions qualify as party-in-interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

**(7) Plan Termination**

On July 12, 2023, the Board of Directors of the Plan voted to terminate the Plan effective June 30, 2023, at which time all participants' account balances became 100% vested. As a result, the net assets of the Plan were allocated as prescribed by ERISA and its related regulations.

**(8) Tax Status**

The Plan has adopted a pre-approved plan document provided by Hill Ward & Henderson PA (“HWH”). The Internal Revenue Service (“IRS”) has determined that the pre-approved plan document is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and informed HWH of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of May 21, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**(10) Subsequent Events**

The Plan has evaluated subsequent events through March 12, 2025, which is the date the financial statements were available to be issued.
