### Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of The Blake School Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Blake School Defined Contribution Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2024 and 2023, and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### NOTE 1 - DESCRIPTION OF PLAN

The following description of The Blake School Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 403(b) Plan which provides for employee elective deferrals, employee mandatory contributions, and employer contributions. The employee mandatory and employer contribution cover all employees of The Blake School (the School), who are scheduled to work more than 1,000 hours as measured on a 12-month rolling basis and excludes those who are scheduled to work under 1,000 hours, are temporary employees, or are employees with an employment contract of less than 0.50 FTE. There are no minimum age or service requirements for employee elective deferrals.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

#### Contributions

Eligible participants must make a mandatory deferral of 4% as a condition of employment. The School contributes 8% of each eligible participant's compensation, as defined by the Plan. Participants may make elective deferrals to the Plan, and participants who have turned age 50 before the end of the calendar year may make additional catch-up contributions. Participants may also contribute amounts representing distributions from individual retirement accounts or annuities (rollover).

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options in accordance with the individual agreements governing the investments. Participants make initial investment elections and subsequent changes to investments directly with the Plan custodians. The Plan currently offers various mutual funds, annuities, pooled separate accounts, and insurance contracts as investment options for participants.

Contributions are subject to certain statutory limitations.

#### Participant Accounts

Individual custodial accounts are established with TIAA and CREF for each participant and the account is credited with the participant's elective and mandatory contribution, employer's contribution, earnings, and administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and earnings thereon. Vesting in the School's contribution portion of their accounts is based on years of service. A participant is 100% vested after five years of credited service, attainment of retirement age of 65, death, disability, or termination of the Plan. Participants will vest based on the following schedule: Less than 2 Years - 0%, 2 Years - 25%, 3 Years - 50%, 4 Years- 75%, 5 Years - 100%

#### Plan Loans

Prior to September 2020, participants could enter into loan agreements directly with the insurance companies and custodians of the Plan. Participants must provide collateral equal to 110% of the loan balance. The loans bear reasonable interest rates. Loans must be repaid in level payments over a maximum of five years, unless it is for the purchase of a principal residence, which payments will be over ten years. As the notes receivable from participants issued prior to September 2020 are made directly with the insurance company, the amount outstanding is not included in the Statement of Net Assets Available for Benefits. Notes receivable from participants issued after September 2020 are secured by the balance in the participant's account.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid through payroll deductions.

#### Payment of Benefits

Qualified distributions can be made upon the participant's attaining age 59 ½, incurring a disability, or severance of employment. Participants request distributions through the Plan's custodians. Once eligible for distributions, a participant may leave the value of the account in the plan until a later date, receive a lump sum payment, receive partial payments, receive installment payments, receive an annuity payout, or roll over the account to another 403(b) plan or IRA account. Account balances of \$1,000 or less are distributed in a lump sum.

#### Expense Budget Account

The Plan uses an Expense Budget Account (EBA). Annual EBA credits equal to 0.100% of total assets as defined in the EBA agreement are applied semi-annually. At the discretion of the Plan fiduciary, these credits can be used to pay reasonable administrative expenses of the Plan or can be distributed to Plan participants. The EBA balance at August 31, 2024 and 2023 was \$39,598 and \$74,592. During 2024, the EBA paid \$49,245 of administrative expenses and \$50,000 was reallocated to participants.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Forfeited Accounts**

At August 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,359 and \$98,144. Forfeitures may be used to reduce employer contributions. In 2024, employer contributions were reduced by \$384,049 from forfeited nonvested accounts.

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Contributions Received and Receivable**

Contributions from the Plan participants and the employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

#### **Investments Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, insurance companies and the custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment related expenses are included in the net appreciation of fair value of investments.

#### Subsequent Events

Subsequent events were evaluated through March 11, 2025, the date the financial statements were available to be issued.

### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at August 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended August 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF and TIAA, FSB (the insurance companies and custodians of the Plan).

### NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Investment Committee determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Observable inputs such as unadjusted quoted prices in active markets.

Level 2 - Inputs, other than quoted prices in active markets, which are observable either directly or indirectly; and,

Level 3 - Unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at August 31, 2024 and 2023.

*Mutual Funds:* Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

*TIAA Traditional Annuities (Non-Benefit Responsive):* The TIAA Traditional Annuities (Non-Benefit Responsive) are reported at fair value. The fair value of the TIAA Traditional Annuities (Non-Benefit Responsive) is based on the estimated value of the underlying investments, as determined by the custodians of the Plan on a daily basis. The TIAA Traditional Annuities (Non-Benefit Responsive) are not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable.

*Registered Investment Companies:* Investments are valued at the net asset value of accumulation units held using market quotations or prices obtained from independent pricing sources, which may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Unit values of the CREF Variable Annuity Accounts are determined on a daily basis and are available to the Plan Administrator and plan participants on TIAA and CREF's website. The registered investment companies' investments held by the plan are deemed to be actively traded.

Following is a description of the valuation methodologies used for assets that are measured at NAV as the practical expedient to estimate fair value and are aggregated in the fair value hierarchy as follows:

*TIAA Real Estate Pooled Separate Account:* The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Unit values are calculated daily and are available to the Plan Administrator and plan participants on TIAA and CREF's website. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter.

#### TIAA Real Estate Pooled Separate Account

The TIAA Real Estate Account (REA) invests 75% - 85% in real estate properties and real estate related investments with the goal of producing favorable long-term returns primarily through rental income and appreciation. The REA will also invest 15% - 25% in non-real estate related publicly traded securities and short-term higher quality liquid investments that are easily converted to cash to enable the REA to meet participant redemption requests, purchase or improve properties, or cover other expense needs.

### NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit responsive guaranteed investment contracts with TIAA (TIAA Traditional Annuities) totaling \$9,095,383 and \$7,866,016 for 2024 and 2023, respectively. TIAA maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3% (except for certain contracts where the guaranteed interest is between 1-3%). The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreements prior to the scheduled maturity date.

These contracts meet the fully benefit responsive contract criteria and are therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participant if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the Plan's ability to transact at contract value with TIAA. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA and (e) premature termination of the plan. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation, (d) a material amendment to the agreement without the consent of the issuer.

### NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

During fiscal years 2024 and 2023, TIAA and CREF were parties-in-interest as defined by ERISA. The Plan invests in fixed and variable annuities, pooled separate accounts, and mutual funds sponsored by TIAA and CREF, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the plan made a direct payment to the third-party administrator of \$116,211 which was not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

Prior to September 2020, plan participants could obtain loans directly with TIAA. Such loans are not assets of the Plan as the loan is directly between the participant and TIAA. The participant's account in the Plan is used as collateral for such loans with TIAA. Participants must provide collateral equal to 110% of the loan balance. The collateral required for the loan is the TIAA traditional annuity investment. Participants make loan principal and interest payments directly to TIAA. Interest rates are variable. In the event of a loan default, the collateral will be liquidated by TIAA. Such liquidation will be treated as a distribution paid to the participant by the Plan.

As of August 31, 2024 and 2023, there were \$115,066 and \$143,799, respectively, of loans outstanding between participants and TIAA. As of August 31, 2024, loan maturity dates ranged from 2025 to 2030 and interest rates ranged from 4.24% to 5.73%.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the adopting employer has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### NOTE 8 - TAX STATUS

The Plan uses a Volume Submitter Profit Sharing Plan document sponsored by TIAA. TIAA received an opinion letter from the IRS, dated August 7, 2017, which states that the volume submitter document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan document has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

### **NOTE 8 - TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### **NOTE 10 - NONEXEMPT TRANSACTIONS**

During the Plan year ended August 31, 2024, employee withholdings in the amount of \$90,751 were not remitted within the appropriate period by the Company. These transactions constitute prohibited transactions as defined by ERISA.
