## Independent Auditors' Report

### The Participants and Plan Administrator Hawthorne Foundation Inc. Retirement Plan & Trust

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Hawthorne Foundation Inc. Retirement Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements

June 30, 2024

### 1. Description of Plan

The following description of the Hawthorne Foundation Inc. Retirement Plan & Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Hawthorne Foundation Inc. (the "Foundation"). In addition, the Plan excludes from participation employees covered under a collective bargaining agreement, non-resident aliens who do not receive any compensation from U.S. sources and leased employees. In order to participate in the Plan, an employee must be at least age 21 and have completed one year of service and work at least 1,000 hours during the 12-month period immediately following their date of hire. The participant enters the plan on the July 1 or January 1 coincident with or next following completion of the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

The Foundation may make discretionary contributions to the Plan. The contribution amount is allocated to participants based on a disparity allocation formula. Participant's salary deferral contributions were frozen as of September 1, 2005. For the 2024 Plan year the Foundation's contribution was \$336,954.

#### ***Participant Accounts***

Each participant's account is credited with allocations of the Foundation's contributions and Plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their own contributions. A participant vests in the Foundation's contribution at the following rate: 0% vested before completing three years of credited service and 100% vested after three years of credited service.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

### 1. Description of Plan (*continued*)

#### ***Payment of Benefits***

Benefits are paid upon retirement, death, disability, or termination of employment. Participants may elect to receive lump-sum payments in cash or they may elect to rollover their benefits payment to an individual retirement account or to another qualified plan.

#### ***Forfeited Accounts***

Forfeitures resulting from non-vested portions of participants' account balances will be used to reduce future employer contributions, pay Plan expenses or will be allocated to participants' accounts. At June 30, 2024 and 2023, forfeited account balances held in non-participant directed accounts were \$12,850 and \$1,121. For the year ended June 30, 2024, no forfeitures were used toward employer contributions.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Separate accounts are reported at fair value to the Plan by the insurance company which represents the fair value of the underlying investments comprising the accounts.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses on investments are recognized upon the sale of the related investments, and unrealized appreciation or depreciation is recognized at year end when the carrying values of the related investments are adjusted to their estimated fair value.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. If a participant ceases making loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

The majority of administrative expenses are paid by the Plan. Any administrative expenses not paid by the Plan are paid by the Foundation.

Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### ***Subsequent Event Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is March 10, 2025.

### 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at June 30, 2024 and 2023, interest on notes receivable and the net appreciation in fair value of investments for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement (“Empower”), the custodian of the Plan and a qualified institution.

### 4. Investments

### 5. Plan Termination

Although it has not expressed any intention to do so, the Foundation has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### 6. Party-in-Interest

Empower Retirement, the custodian of the Plan, holds the Plan's assets and cash received and initiates distributions to participants.

Certain administrative functions of the Plan are performed by employees of the Foundation. No such employee receives compensation from the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 7. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the prototype document preparer by a letter dated June 30, 2020, the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
