## Independent Auditor's Report

To the Board of Directors  
Caring Health Center, Inc. Matched Retirement Savings Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements*

We were engaged to perform an audit of the financial statements of the Caring Health Center, Inc. Matched Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2022 Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from qualified institutions as of and for the year ended June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Disclaimer of Opinion on the 2022 Financial Statements*

We do not express an opinion on the accompanying 2022 Financial Statements of the Plan. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion on the 2022 Financial Statements* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the 2022 Financial Statements.

### *Basis for Disclaimer of Opinion on the 2022 Financial Statements*

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to July 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying 2022 Financial Statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan may have excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to July 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and related income and distributions be included in the accompanying financial statements.

### *Responsibilities of Management for the 2022 Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### *Auditor's Responsibilities for the Audit of the 2022 Financial Statements*

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue our auditor's report. However, because of the matters described in the *Basis for Disclaimer of Opinion on the 2022 Financial Statements* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

### *Other Matters*

#### *2022 Supplemental Schedules Required by ERISA*

The supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a) for the year ended June 30, 2022 and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) as of June 30, 2022 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion for the 2022 Financial Statements* section of our report, it is inappropriate to and we do not express an opinion on these supplemental schedules.

### *Auditor's Report on the 2021 Financial Statements*

We were engaged to audit the 2021 financial statements of the Plan. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information certified by qualified institutions. Further, the Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to July 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

The Plan has excluded from the 2021 financial statements certain annuity contracts and custodial accounts issued to current and former employees prior to July 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the 2021 financial statements. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the 2021 financial statements.

In our report dated January 20, 2023, we indicated that because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2021 financial statements.

**Note 1 - Description of Plan**

The following description of Caring Health Center, Inc. Matched Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement, and any amendments thereto, for a more complete description of the Plan's provisions.

**General**

The Plan is a contributory Internal Revenue Code ("IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of Caring Health Center, Inc. (the "Center"). All employees are eligible to make salary deferral contributions to the Plan immediately following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

On December 31, 2020, Empower Retirement, LLC ("Empower Retirement") acquired the retirement business of MassMutual. Certain Plan records as of and for the year ended June 30, 2022 have been provided and certified by Great-West Life & Annuity Insurance Company ("Great-West"), an affiliate of Empower Retirement, with respect to Empower Retirement's role as the administrator of the business, on MassMutual's behalf and pursuant to a Power of Attorney granted to Great-West, an affiliate of Empower Retirement.

The Plan's investment options are provided through a multiple vendor arrangement with Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company and Massachusetts Mutual Life Insurance Company) and Voya Retirement Insurance and Annuity Company ("Voya"). Plan investments held by Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company and Massachusetts Mutual Life Insurance Company) including a variety of variable annuity contracts as well as a guaranteed investment contract managed by Talcott Resolution Life Insurance Company ("Talcott Resolution") (formerly Hartford Life Insurance Company). There were no new contributions to Voya balances during the year ended June 30, 2022. All participant account balances and Plan contributions are participant-directed.

**Contributions**

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan. Participants may designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Center may, at its discretion, make matching contributions to the Plan. For the year ended June 30, 2022, the Center elected to make matching contributions to the Plan on a weekly basis equal to 100% of the first 2% of eligible compensation that a participant contributes to the Plan. Employees are eligible for discretionary matching contributions on the first day of the month following the completion of 30 days of service. Leased employees are not eligible to receive any of the Plan's discretionary matching contributions. Contributions are subject to certain IRC limitations.

**Participant accounts**

Each participant's account is credited with the participant's contributions and any Center discretionary matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the balance in the participant's vested account.

**Vesting**

Participants are vested immediately in all employee contributions to the Plan plus actual earnings thereon. Vesting in the Center's matching contribution portion of their account is based on years of continuous service. A participant is 100% vested after three years of credited service.

**Payment of benefits**

On termination of service due to death, disability, normal retirement or other termination of employment, a participant with an account balance of \$1,000 or less will receive a lump-sum distribution. For terminated participants with a vested account balance greater than \$1,000, but less than \$5,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designed by the Plan administrator. Participants with account balances greater than \$5,000 may elect an amount equal to the value of the participant's vested interest in his or her account either as a lump-sum, a single sum distribution of a portion of their account balance, installment payments, one of the various forms of annuity provided by the Plan, or defer payment of benefits until a later date.

Withdrawals from a participant's salary deferral contributions, Roth contributions or rollover contributions may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Participants who are at least 59½ years of age may withdraw all or a portion of their salary deferral contributions, Roth contributions or rollover contributions prior to termination.

**Notes receivable from participants**

Participants may borrow from the Empower portion of their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's Empower account. The loan interest rate on borrowings from Empower is determined quarterly and is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

**Forfeited accounts**

At June 30, 2022 and 2021, forfeited nonvested accounts totaled \$11,230 and \$16,691, respectively. Forfeited nonvested matching contributions may be used to pay Plan expenses or to reduce future employer matching contributions. In 2022, forfeited nonvested accounts of \$22,440 were used to reduce employer matching contributions.

**Note 2 - Summary of accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan was established in 2003 and was historically viewed as an amalgamation of individual annuity accounts and the Plan administrator and its service providers did not maintain financial information at a Plan level. Because historical records were not maintained or are not available at the Plan level, the Plan may have excluded from the accompanying statements of net assets available for benefits certain annuity accounts, and related activity, issued to current and former employees prior to July 1, 2009. In recognition of these recordkeeping matters, the Department of Labor ("DOL") released Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* ("FAB 2009-02") as transitional relief to address situations where a Plan's management is not able to obtain historical records. If FAB 2009-02 is implemented, the DOL has indicated that they will not reject the Form 5500 where contracts are excluded, as long as certain conditions were met. Further, FAB 2009-02 suggests that plan administrators make good faith efforts to include known contracts. While the Plan administrator has, in good faith, included all known contracts, because of certain incomplete records, there is uncertainty that all contracts have been included. However, the Plan administrator believes that excluded annuity accounts, if any, would meet the conditions of FAB 2009-02. As discussed in Note 3, the Plan has received certified statements of completeness and accuracy from the Plan's custodians as of June 30, 2022 and 2021 and for the year ended June 30, 2022.

As part of historical records not being maintained since the Plan was initially established, participants may have individual balances with legacy custodians which are not reflected in the net assets available for benefits.

**Investment valuation and income recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date and are included in the net depreciation in fair value of investments. Net depreciation also includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2022 and 2021.

**Payment of benefits**

Benefits are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan unless otherwise paid by the Center. Expenses that are paid by the Center are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other transactional fees are charged directly to the participant's account and are included in administrative expenses. Other administrative expenses may be paid through available forfeitures. Indirect investment management fees are included in the net depreciation in fair value of investments.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Subsequent events**

The Plan has evaluated subsequent events through February 13, 2025, the date the financial statements were available to be issued.

**Note 3 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at June 30, 2022 and 2021, and investment income (loss) and interest income on notes receivable from participants for the year ended June 30, 2022, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company and Massachusetts Mutual Life Insurance Company) and Voya, the custodians of the Plan.

**Note 4 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022 and 2021.

*Variable annuity contracts:* The Plan invests in variable annuity contracts with Empower. The accounts are valued at the accumulation unit value ("AUV") of units held by the Plan at year-end. The AUV is based on the value of underlying investments, which are valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing less its liabilities and account charges, plus any applicable dividend income, then divided by the number of units outstanding. The accounts allow for daily redemptions and contributions.

*Non-fully benefit-responsive guaranteed investment contract:* The guaranteed investment contract that is not benefit-responsive is valued at fair value by the insurance company. Fair value is based upon the accumulated cash contributions and interest credited to the account, less withdrawals and expenses. The crediting interest rate of the investment contract is based upon the combination of a guaranteed rate and an established discretionary rate agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. The fully benefit-responsive guaranteed investment contract is valued as described in Note 5.

*Pooled separate accounts:* Valued using the AUV, which is based on the fair value of the underlying assets of the account. The AUV is deemed equivalent to net asset value ("NAV"), which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

**Note 5 - Investment contract with insurance company**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Talcott Resolution Life Insurance Company totaling \$817,868 and \$810,105 as of June 30, 2022 and 2021, respectively. Talcott Resolution Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Talcott Resolution Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The contract with Talcott Resolution Life Insurance Company is reinsured by Empower Annuity Insurance Company of America. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**Note 6 - Related party and party-in-interest transactions**

Plan investments include units of variable annuity contracts and a guaranteed investment contract managed by Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company and Massachusetts Mutual Life Insurance Company). Plan investments also include pooled separate accounts and a guaranteed investment contract managed by Voya.

Empower Annuity Insurance Company of America and Voya are custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid directly by the Plan to these custodians totaled \$1,233 for the year ended June 30, 2022. Indirect fees incurred by the Plan for investment management services are included in the net depreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against their account balances which are also considered party-in-interest transactions.

**Note 7 - Plan termination**

Although it has not expressed any intent to do so, the Center has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 8 - Plan loans**

In addition to the notes receivable from participants described in Note 1, participants may also borrow from Voya using the assets in the participant's Voya portion of their account as collateral. Under this arrangement, Voya has the right to collect the collateral in the event of a default. Principal and interest payments are made directly by participants to Voya. As of June 30, 2022 and 2021, there were no Plan loans outstanding under this arrangement.

**Note 9 - Tax status**

The Plan has been designed using a volume submitter 403(b) plan document designed by MassMutual. MassMutual received an advisory letter dated March 31, 2017, in which the IRS stated that the volume submitter 403(b) plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the advisory letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain salary deferral contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Center for the year ended June 30, 2022. The Center is currently working with its third-party administrator to correct the delinquent participant contributions relating to payroll periods for the year ended June 30, 2022. The Center believes that these transactions should not affect the tax-qualified status of the Plan.

**Note 12 - Subsequent events**

The Plan administrator made the decision to change its primary plan service provider from Empower Retirement with assets held by Empower Annuity Insurance Company of America to The Standard with assets held by Reliance Trust Company. In conjunction with this change in service providers, the Plan was amended and restated with an effective date of November 1, 2022, however, no significant changes were made to the existing Plan provisions. Although the majority of Plan assets were transferred to Reliance Trust Company, due to certain withdrawal restrictions, the Plan continues to maintain a portion of its assets with Empower and Voya.
