We have audited the financial statements of the Loom 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) for the period ended April 30, 2024 (in liquidation) and for the year ended December 31, 2023 (in liquidation), and we will issue our report thereon dated November 25, 2024. As permitted by ERISA Section 103(a)(3)(C), our audits did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, the qualified institution, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audits. We have communicated such information in our letter to you dated February 26, 2024 with the addendum dated June 18, 2024. Professional standards also require that we communicate to you the following information related to our audits.

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. There were no new accounting policies that were adopted, and the application of existing policies was not changed during 2023 or 2024, except for the adoption of the liquidation basis of accounting in 2023. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected.

The most sensitive estimate affecting the financial statements was:

- Your estimate of the fair value of the Plan's investments is based on specific valuation methods as described in the notes to the financial statements. We evaluated the key factors and assumptions used to develop these fair values of investments in determining that they are reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

- The governing body of Loom 401(k) Plan, the Plan's Sponsor, decided on November 29, 2023 to terminate the Plan effective November 29, 2023. All participants in the Plan on November 29, 2023 are 100% vested in the benefit that they have already earned under the Plan. The governing body have submitted all appropriate written information with the PBGC and Internal Revenue Service ("IRS"). PBGC and IRS approvals have taken place. All required distributions were distributed to plan participants as of April 19, 2024. Management has determined that liquidation is imminent.
- The accompanying financial statements of the Plan are prepared using the accrual basis of accounting as of the year ended December 31, 2022. In November 2023, the Plan Sponsor approved the termination of the Plan. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 and 2024 financial statements. The liquidation basis of accounting is considered appropriate when, among other things, liquidation is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimate net realized cash value and liabilities are stated at their anticipated settlement amounts. The net realizable cash value for investments as of April 30, 2024 and December 31, 2023 would be fair value.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audits.

Difficulties Encountered in Performing the Audits

We did encounter delays on requested information and delayed responses on posed questions which caused delays in our testing and added additional time to our audits.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audits, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements identified during the audits.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audits.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated November 25, 2024.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Review of SOC Reports

Management should review the SOC reports for Paylocity and Fidelity Workplace Services. It was noted during the audits that the SOC reports were not reviewed in a timely manner. SOC reports provide insight into the control environment of Paylocity and Fidelity Workplace Services and provide a list of controls that need to be put in place at the Company. Not reviewing the SOC reports increases the risk controls that could prevent and detect errors will not be maintained. We recommend that Plan management review the SOC reports in a timely manner and adjust their internal controls dependent on the results found in the SOC reports.

Maintaining Meeting Minutes

Management should establish a process for the maintaining of meeting minutes. It was noted during the audits the Plan Sponsor did not maintain meeting minutes for any of their meetings during 2023 and 2024. Not taking minutes can be costly in time and money as the recollections of any participants may differ. Meeting minutes also provide a legal record of the topics discussed and decisions agreed upon during the meetings. We recommend management implement a process for the recording of meeting minutes and should meet at least quarterly to discuss the plan investments.

Reconciliation of Deposit Schedule to Fidelity Records

It is good practice to keep track of remittance information on a per payroll basis. It will also facilitate deposit testing documentation for future audits. Differences were also noted between the contributions for employees and employer when compared to the records from Fidelity. These differences could be indicative of prohibited transactions. We recommend management implement a control to compare and reconcile payroll amounts to amounts received by Fidelity during each payroll cycle, so that plan management can identify differences in amounts from payroll records or timely detect late deposits.

Plan Administrator Access

During our audits, we inquired as to whether management revoked access to TPA site for the Plan Administrators who were terminated in 2023. It came to our attention that the access was not revoked. We recommend that Plan management have the proper procedures and controls in place to ensure that this information is communicated in a timely manner to the TPA.

Contribution Errors

During the audits, several errors were made during the testing of participant contributions. It was noted that one participant had an incorrect deferral percentage applied during one payroll period. We recommend a review process be implemented to monitor participant contributions. We also recommend management review all participants for similar errors and correct the accounts of all participants with errors.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

The purpose of an ERISA Section 103(a)(3)(C) audit is to express an opinion on whether the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States and that the information regarding assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the certified investment information.

- 2) The financial statements referred to above are fairly presented in conformity with U.S. GAAP, the notes include all disclosures required by laws and regulations to which the Plan is subject, including the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and the supplemental schedules referred to above are fairly presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- 3) We acknowledge our responsibility for administering the plan and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.
- 4) We acknowledge our responsibility for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.
- 5) We acknowledge our responsibility for the design, implementation, and maintenance of internal control to prevent and detect fraud.
- 6) The methods, significant assumptions, and data used in making accounting estimates and their related disclosures are appropriate to achieve recognition, measurement, or disclosure that is reasonable in accordance with U.S. GAAP.
- 7) Related-party relationships and transactions and relationships and transactions with parties-in-interest, as defined in ERISA Section 3(14) and regulations thereunder, have been appropriately accounted for and disclosed in accordance with U.S. GAAP and ERISA Section 3(14) and regulations thereunder.
- 8) All events subsequent to the date of the financial statements and for which U.S. GAAP requires adjustment or disclosure have been adjusted or disclosed.
- 9) We are in agreement with the adjusting journal entries you have proposed, and they have been posted to the Plan's accounts.
- 10) We are not aware of any pending or threatened litigation, claims, or assessments or unasserted claims or assessments that are required to be accrued or disclosed in the financial statements in accordance with U.S. GAAP, and we have not consulted a lawyer concerning litigation, claims, or assessments.
- 11) Other matters (e.g., breach of fiduciary responsibilities, nonexempt transactions, loans or leases in default, events reportable to the PBGC, or events that may jeopardize the tax status) that legal counsel have advised us that must be disclosed have been properly disclosed.
- 12) Material concentrations have been properly disclosed in accordance with U.S. GAAP.
- 13) Financial instruments with concentrations of credit risk have been properly recorded or disclosed in the financial statements.
- 14) Guarantees, whether written or oral, under which the Plan is contingently liable, have been properly recorded or disclosed in accordance with U.S. GAAP.
- 15) The supplemental schedules or financial statements disclose the following:
 - a) All non-exempt party-in-interest transactions as defined in ERISA Section 3(14) and regulations thereunder.
 - b) Investments or loans in default or considered to be uncollectible.
 - c) Reportable transactions as defined in ERISA Section 103(b)(3)(H) and regulations thereunder.
- 16) We acknowledge our election to have an ERISA Section 103(a)(3)(C) audit does not affect our responsibility for the financial statements and for determining the following:
 - 1) The circumstances permit an ERISA Section 103(a)(3)(C) audit.
 - 2) A qualified institution has prepared and certified the investment information as described in 29 CFR 2520.103-8.
 - 3) The certification meets the 29 CFR 2520.103-5 requirements.
 - 4) The certified investment information is appropriately measured, presented, and disclosed in accordance with U.S. GAAP.

Information Provided

- 17) We have provided you with:
 - a) Access to all information, of which we are aware, that is relevant to the preparation and fair presentation of the financial statements, such as records (including information obtained from outside of the general and subsidiary ledgers), documentation, and other matters.

- b) A substantially complete draft of Form 5500.
 - c) Additional information that you have requested from us for the purpose of the audit.
 - d) Unrestricted access to persons within the Plan from whom you determined it necessary to obtain audit evidence.
 - e) Current Plan instruments, trust agreements, insurance contracts, or investment contracts and amendments to such documents entered into during the year, including amendments to comply with applicable laws.
- 18) All material transactions have been recorded in the accounting records and are reflected in the financial statements.
- 19) We have disclosed to you the results of our assessment of the risk that the financial statements may be materially misstated as a result of fraud.
- 20) We have no knowledge of any fraud or suspected fraud that affects the Plan and involves:
- a) Management,
 - b) Employees who have significant roles in internal control, or
 - c) Others where the fraud could have a material effect on the financial statements.
- 21) We have no knowledge of any allegations of fraud or suspected fraud affecting the Plan's financial statements communicated by employees, former employees, participants, regulators, beneficiaries, service providers, third-party administrators, or others.
- 22) We have no knowledge of any instances of noncompliance or suspected noncompliance with laws and regulations (including ERISA, DOL, and IRS regulations) whose effects should be considered when preparing financial statements.
- 23) We have disclosed to you all known actual or possible litigation, claims, and assessments whose effects should be considered when preparing the financial statements.
- 24) We have disclosed to you the names of all of the Plan's related parties and parties in interest and all the related-party and party-in-interest relationships and transactions, including any side agreements.
- 25) The Plan has satisfactory title to all owned assets, which are recorded at fair value, and all liens, encumbrances, or security interests requiring disclosure in the financial statements have been properly disclosed.
- 26) The Plan was terminated on November 29, 2023.
- 27) Amendments to the Plan instrument, if any, have been properly recorded or disclosed in the financial statements.
- 28) The Plan has complied with all aspects of debt and other contractual agreements that would have a material effect on the financial statements in the event of noncompliance.
- 29) The methods and significant assumptions used to estimate fair values of financial instruments, including nonreadily marketable securities, are as follows: The following methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's policy is to recognize transfers between Levels 1, Level 2, and Level 3 as of the end of the year. There were no transfers between Level 1, Level 2, and Level 3 for the period ended April 30, 2024 and the year ended, December 31, 2023. The methods and significant assumptions used result in a measure of fair value appropriate for financial measurement and disclosure purposes.
- 30) All required amendments to and filings of plan documents with the appropriate agencies have been made.
- 31) The Plan (and the trust established under the Plan) is qualified under the appropriate section of the Internal Revenue Code and we intend to continue them as a qualified plan (and trust). The Plan sponsor(s) has operated the Plan (and trust) in a manner that did not jeopardize this tax status. Required nondiscrimination testing related to Code Section 401(k) and 401(m) arrangements, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations.
- 32) The Plan has complied with the DOL's regulations concerning the timely remittance of participant contributions to trusts containing assets for the Plan, except as disclosed in the Financial Statements.

- 33) The Plan has complied with the fidelity bonding requirements of ERISA.
- 34) We have apprised you of all communications, whether written or oral, with regulatory agencies concerning the operation of the Plan.
- 35) We have obtained the service auditor's report from our service organizations, Fidelity and Paylocity. We have reviewed such reports, including the complementary user controls. We have implemented the relevant user controls, and controls were in operation for the period ended April 30, 2024 and the year ended December 31, 2023.
- 36) We have obtained appropriate fee disclosures from covered service providers and have concluded the fees are reasonable. The Plan is in compliance with DOL regulations regarding ERISA Section 408(b)(2).
- 37) In regards to the financial statement preparations and other non-attest services performed by you, we have:
 - a) Assumed all management responsibilities
 - b) Overseen the service by designating an individual who possesses suitable skill, knowledge, and/or experience to oversee the services.
 - c) Evaluated the adequacy and results of the services performed
 - d) Accepted responsibility for the results of the services
 - e) Ensured that the data and records are complete and we have sufficient information to oversee the services.
- 38) It is our responsibility to post an electronic version of the financial statements and audit report on the DOL Website in conjunction with EFAST 2 filing. We will ensure that there are no differences in the content between the electronic version of the financial statements and audit report uploaded to the DOL Website as compared to the signed version of the financial statements and audit report provided to us by your firms.
- 39) The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.
- 40) We have analyzed the tax positions taken by the Plan and conclude that as of April 30, 2024, December 31, 2023, and December 31, 2022 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.
- 41) The governing body of Loom 401(k) Plan, the Plan's Sponsor, decided on November 29, 2023 to terminate the Plan effective November 29, 2023. All participants in the Plan on November 29, 2023 are 100% vested in the benefit that they have already earned under the Plan. The governing body have submitted all appropriate written information with the PBGC and Internal Revenue Service ("IRS"). PBGC and IRS approvals have taken place. All required distributions were distributed to plan participants as of April 19, 2024. Management has determined that liquidation is imminent.
- 42) Per the plan termination letter, the last date for participants to request a distribution was before market close on April 4, 2024. Accordingly, if a distribution request was not made by April 4, 2024, IRA rollovers were processed and made payable to Millenium Trust Company on April 5, 2024, or as soon as administratively feasible. The distributions were processed on April 8, 2024.

The methods of measurement and presentation of the supplemental schedules have not changed from these used in the prior period, and we have disclosed to you any significant assumptions or interpretations underlying the measurement and presentation of the supplemental schedules.
