Notes to the Financial Statements

For the Periods January 1, 2024 to May 10, 2024 and January 1, 2023 to December 31, 2023

1. Description of Plan

The following description of the G5 Enterprises, Inc. 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of G5 Enterprises, Inc. (the Company) and its subsidiaries. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan termination: The Company elected to terminate the Plan effective December 31, 2023. Contributions to the Plan ceased and participants were given until May 3, 2024 to request a 100% distribution. Effective May 10, 2024, any participants with remaining balances were distributed and their amounts were rolled into IRA accounts.

Contributions: Prior to Plan termination, participants could contribute a percentage of their eligible wages by way of pre-tax contributions or as after-tax Roth contributions, subject to certain limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan accepted rollover contributions on behalf of any eligible employee, regardless of whether such employee met the service requirements of the Plan.

The Company could also make discretionary matching and profit sharing contributions each year as determined by company management. These contributions were allocated based on the ratio of a participant's eligible compensation to all eligible compensation. During the periods ended May 10, 2024 and December 31, 2023, the Company did not make any such contributions. In addition, the Company could make a contribution to an employee in lieu of paying prevailing wages. Prevailing wage contributions totaled \$18,730 for period ended December 31, 2023.

Participants directed the investment of all contributions into one or more investment options offered by the Plan.

Participant accounts: The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with (a) the participant's contribution; (b) the Company's discretionary and matching contributions (if any), and (c) Plan earnings. Plan earnings are allocated to each participant based upon the earnings of the investment plan selected by the participant, and the participant's account balance. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of benefits: Prior to December 31, 2023, participants who terminated service received a lump-sum amount equal to the value of his or her account. Benefit payments to participants were recorded upon distribution.

In accordance with the Plan's cash out and required rollover rules, if the vested account balance payable to a terminated individual was less than or equal to \$5,000, such account would be distributed to the participant without the participant's consent.

Notes to the Financial Statements

For the Periods January 1, 2024 to May 10, 2024 and January 1, 2023 to December 31, 2023

Vesting: Participants were immediately 100% vested in their voluntary contributions, as well as any contributions made in lieu of paying prevailing wages, plus actual earnings thereon. Vesting in the remainder of their accounts was based on years of continuous service. A participant was 100% vested in employer profit sharing and matching contribution accounts after six years of service. The nonvested balance was to be forfeited upon termination of service. Participants became immediately 100% vested upon termination of the Plan.

Forfeitures: Forfeitures not used to pay Plan administrative expenses could be applied to reduce employer contributions or be reallocated as Company contributions. At May 10, 2024 and December 31, 2023, there were no forfeited nonvested accounts.

Notes receivable from participants: Participants could borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans were secured by the balance in the participant's account bearing an interest rate determined by the administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest were paid ratably through payroll deductions. Upon termination of the Plan, all loans were reclassified as deemed distributions and a benefit payment was recorded.

2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are presented in accordance with U.S. generally accepted accounting principles.

Use of estimates: The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses was recorded at May 10, 2024 or December 31, 2023.

Investment valuation and income recognition: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent events: Management has evaluated subsequent events between the end of the most recent fiscal year end and March 14, 2025 the date the financial statements were available to be issued.

3. Risks & Uncertainties

Prior to termination, the Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

Group variable annuity pooled separate accounts: Valued at the net asset value of the units held by the group annuity contract provider using the quoted net asset value of the shares of the underlying mutual funds adjusted for any dividends or distributions received by John Hancock Life Insurance Company and the daily equivalent of any fee charged pursuant to the contract. Mutual funds are registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. The Plan Sponsor elected to terminate the Plan effective December 31, 2023. Effective May 10, 2024, all assets of the Plan were distributed.

6. Plan Tax Status

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 10, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at May 10, 2024 and December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable for the periods ended May 10, 2024 and December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian).

8. Related-Party Transactions & Party In Interest Transactions

Certain Plan investments were shares of mutual funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company was the asset custodian and, therefore, these transactions qualify as party in interest transaction. Investments in these funds totaled \$1,772,104 at December 31, 2023, respectively. Due to Plan termination, there were no investments held at May 10, 2024.

Certain fees incurred by the Plan for investment management services were included in net appreciation in fair value of investments, as they are paid by revenue sharing, rather than direct payment. For the periods ended May 10, 2024 and December 31, 2023, the Plan made direct payments to third party administrators of \$7,357 and \$7,234 respectively, which are not covered by revenue sharing.

A portion of the administrative costs of the Plan are paid by the Company. Certain employees of the Company serve as the Plan's administrator and trustees. They do not receive any compensation for services rendered to the Plan.
