VI. Actuarial Assumptions

A. Funding - The following actuarial assumptions were used in the calculation of the required/allowable contributions:

- 1) Interest Rate – Segment rates of 4.21%/4.75%, 4.86%/4.87% and 4.87%/5.59% were used for the Maximum and Minimum respectively. The Effective Interest rate is 4.96%.
- 2) Mortality Table - The 2024 Applicable Mortality Table (Unisex Basis) was used for the post-retirement period.
- 3) Salary Scale – Salaries are not relevant since there are no active employees.
- 4) Severance Discount – No severance discount was assumed in the calculation of the Target Normal Cost.
- 5) Retirement Age - It was assumed that all employees would retirement on their Normal Retirement Date or immediately if later.
- 6) Asset Valuation - Assets were valued at market value for all purposes.
- 7) Actuarial Cost Method – No longer applicable. Method is now mandated.

B. Eligibility - On the January 1 nearest one Year of Service and attainment of age 21.


