1. Description of Plan

The following brief description of the Child and Family Services of Newport County, Inc. 401(k) and Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information or to the Summary Plan Description that is available from the human resources department of Child and Family Services of Newport County, Inc. (the “Agency” or “Plan Sponsor”).

General

The Plan is a defined contribution plan qualified under Section 401(a) of the Internal Revenue Code (“IRC”), with a deferred arrangement qualified under Section 401(k) of the IRC. Pursuant to the requirements of Section 401(a) 27 of the IRC, the Plan is also a profit sharing plan. The Plan covers all employees of the Agency who elect to contribute to the Plan and meet the eligibility requirements of the Plan. The Plan initially became effective July 1, 1985 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees who are 21 years of age and have completed three months of service are eligible to make contributions to the Plan. The Plan has an automatic enrollment feature that results in eligible participants being enrolled in the Plan with an initial deferral percentage of two percent. Participants who enter the Plan through automatic enrollment will receive a one percent increase annually up to a deferral rate of six percent. Participating employees become eligible for matching contributions after fulfilling a one year service requirement.

Contributions

Participants may elect to contribute a percentage of their pre-tax compensation within the limits prescribed by Section 401(k) of the IRC. These contributions and earnings thereon, are not subject to federal income taxes until withdrawn from the Plan. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans. The Plan provides for discretionary matching and discretionary profit sharing contributions from the Agency. The Agency elected to make a discretionary matching contribution of 50% of the first 5% of base compensation that a participant contributes to the Plan for the year ended June 30, 2024. The discretionary matching contributions totaled \$99,673 for the year ended June 30, 2024. The Agency made no discretionary profit sharing contribution for the year ended June 30, 2024. All contributions to a participant’s account are allocated among the various investments based on each participant’s elections.

The Plan also allows Roth 401(k) contributions through either a participant’s deferral from compensation or rollover of designated Roth contributions.

1. Description of Plan (*continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the corresponding employer matching and profit sharing contribution, and an allocation of Plan earnings and (losses). Allocations are based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their pre-tax and Roth contributions and any amounts rolled over or transferred into the Plan. Vesting for employer contributions, if any, and associated earnings is based on years of continuous service. The portion of a participant's account attributable to the matching and profit sharing contributions are 20% vested after two years of credited service, with vesting incrementally increasing 20% per year thereafter, with participants becoming 100% vested after six or more years of credited service as defined by the Plan.

Payment of Benefits

Upon retirement of service, achievement of normal retirement age as defined by the Plan, total and permanent disability, termination of employment or death, a participant may elect to receive the value of his or her account balance in a lump sum distribution or annuity, in accordance with the provisions of the Plan. If a participant reaches age 59 ½ while still employed by the Agency, that participant may elect to receive all or a portion of his or her pre-tax contributions account. In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. At any time, a participant may also elect to receive all or a portion of his or her rollover contributions. Terminated participants with vested account balances greater than \$5,000 may maintain their account in the Plan or receive a lump sum distribution.

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Forfeitures

Any balance in the employer contribution account of a participant who has separated from service, to which he or she is not vested, is forfeited and is used to first pay administrative expenses and then used to reduce the employer's contribution. Forfeited nonvested accounts of \$19,361 were used to pay administrative expenses during the year ended June 30, 2024. Forfeited nonvested accounts of \$0 were used to reduce employer contributions during the year ended June 30, 2024. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$3,233 and \$13.

Notes Receivable from Participants

Participants may borrow, for specified reasons, the lesser of \$50,000 or 50% of the vested interest in their account balance, with the consent of the plan administrator. Principal and interest on loan payments are recorded as contributions to the funds from which the loan was borrowed. The loan repayment period may not exceed five years, except for loans used to purchase or construct a primary residence. Loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. The interest rate on outstanding loans ranges from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to September 15, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At June 30, 2024 and 2023, all of the Plan's investments were valued using Level 1 inputs.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The money market fund and mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission.

Investment Valuation and Income Recognition (continued)

These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year, as well as held at year-end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain other fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is February 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the trustee of the Plan.

4. Tax Status

The Internal Revenue Service (“IRS”) ruled on June 30, 2020 that the Plan qualifies under Section 401(a) of the IRC and therefore, the related trust is not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Sponsor believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

5. Party-in-Interest Transactions

Certain fees paid to Ascensus, Inc. for the investment management services and recordkeeping for the Plan are considered exempt party-in-interest transactions. Also, participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

6. Plan Termination

Although it has not expressed any intention to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan’s net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements.
