### **Independent Auditor's Report**

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Description of Plan**

The following description of the Gateway Community Services Matched Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General:**

The effective date of the plan is September 1, 1993, restated July 15, 2010. The Plan is a defined contribution plan covering all employees who meet the eligibility requirements of the Plan. An employee is eligible to participate in the Plan on the first day of their employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions:**

Participants may elect to make salary deferral contributions to the Plan in an amount up to 100% of their salary with a total amount not to exceed \$23,000 and \$22,500 in the calendar year ended December 31, 2024 and 2023, respectively. Eligible participants age 50 or over and employees with 15 years of service may also elect to defer additional catch-up contributions. The maximum catch-up contribution for the calendar year ended December 31, 2024 and 2023 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### **Participant Accounts:**

Each participant’s account is credited with the participant’s elective contributions, allocations of the employer contributions and Plan earnings and administration fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting:**

Participants are immediately vested in their voluntary contributions and earnings. After three years of service, participants are 100% vested in employer contributions plus actual earnings thereon.

#### **Forfeitures:**

Forfeitures of non-vested employer contributions may be used by the Plan as payment of employer match contributions or allocated to participant accounts.

## NOTES TO FINANCIAL STATEMENTS

### **Note 1. (Continued)**

#### **Plan Loans:**

Plan loans are issued directly from Corebridge Financial ("Corebridge") and not directly from a participant's account. A portion of the participant's account is reserved, or held in collateral, to cover the outstanding loan in case of default. For the years ended June 30, 2024 and 2023, plan assets used as collateral for these loans were \$40,595 and \$40,618, respectively.

Participants may borrow up to a maximum of \$50,000 or 50% of their voluntary contributions and earnings in the Plan, whichever is less. The administrator will determine a reasonable rate of interest by reviewing the interest rates charged for similar types of loans by other lenders.

#### **Notes Receivable from Participants:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participant loans are secured by the balance in the participant's account and bear interest at market rates on the date the loans were initiated. Participants may only have one loan outstanding at any one time. Principal and interest is paid through payroll deduction over a period not exceeding five years. Notes receivable from participants was \$12,372 and \$12,701 for the years ended June 30, 2024 and 2023, respectively.

#### **Payment of Benefits:**

On termination of service due to death, disability, retirement, or other reasons, a participant receives an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, a monthly payment or, if the benefits qualify as eligible rollovers, all or a portion of the benefits may be rolled over to another qualified plan or IRA.

### **Note 2. Summary of Significant Accounting Policies**

#### **Basis of Accounting:**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Estimates:**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Subsequent Events:**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through February 6, 2025, the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS

### **Note 2. (Continued)**

#### **Investment Valuation and Income Recognition:**

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Payment of Benefits:**

Benefits are recorded when paid.

#### **Plan Expenses:**

Plan expenses are allocated ratably to the participant's accounts.

### **Note 3. Investments**

During the year ended June 30, 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$279,926.

### **Note 4. Information Prepared and Certified by Custodians**

### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, Gateway Community Services, Inc. has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 6. Tax Status**

The Internal Revenue Service is not issuing tax status letters to 403(b) plans at this time.

## NOTES TO FINANCIAL STATEMENTS

### **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

### **Note 8. Party-in-Interest Transactions**

Certain investments of the Plan are shares of funds managed by Corebridge Financial (formerly known as AIG Retirement Services") and Empower Retirement. Corebridge Financial and Empower Retirement are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

### **Note 9. Fair Value Measurements**

The Plan applies generally accepted accounting principles for fair value measurements of financial assets and liabilities. These accounting principles define fair value and establish a hierarchy that prioritizes fair value measurements based on the types of inputs used for the various valuation techniques. The three levels of inputs used to measure fair value are as follows:

- Level 1 - Values measured using quoted prices in active markets for identical investments.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

Following are descriptions of the valuation methodologies used for assets measured at fair value:

Insurance company general account: This investment is not available for sale or transfer on any securities exchange. Transactions are not observable in a public marketplace, however values are considered approximately fair value based on the willingness of buyers and sellers.

Registered separate accounts: Includes products funded through an account which invests in proprietary and nonproprietary mutual funds through various subaccounts. Also, includes portfolios that fund variable annuity contracts that invest principally in equity securities, fixed-income instruments and short-term investments. Value is determined as net asset value per share at the close of each business day as reported by each fund and adjusted accordingly.
