## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform an audit of the financial statements of Tenere Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 5, 2024, December 31, 2023 and 2022, the related statements of changes in net assets available for benefits for the period from January 1, 2024 to March 5, 2024 and for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 5, 2024, December 31, 2023 and 2022, and for the period from January 1, 2024 to March 5, 2024 and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

## **Basis for Opinion**

As discussed in Note 1 to the financial statements, on July 25, 2023, the Board of Directors of Cadrex LLC, the Plan's sponsor, approved to merge the Tenere Inc. 401(k) Retirement Plan into the Cadrex LLC 401(k) Savings & Retirement Plan in 2024. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. #### Note 1. Description of the Plan

The following description of Tenere Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan was a defined contribution plan covering certain employees of Tenere Inc. and Subsidiaries (the Company), as defined within the Plan. Employees were eligible to make salary deferrals to the Plan and receive Company matching contributions on the earliest monthly date after attaining age 18 and completion of one month of service, as defined by the Plan. Participants who were employed on the last day of the Plan year, had attained age 18 and had completed one year of service, as defined by the Plan, were eligible to receive a discretionary Company profit sharing contribution. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan's Charter and Compensation Committee was responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Plan's trustee, Ascensus Trust Company (the Trustee), was responsible for administering the Plan's assets.

**Plan merger:** In July 2022, Cadrex LLC acquired 100% of the issued and outstanding stock of Tenere Inc. In connection with this acquisition, on July 25, 2023, the Board of Directors of Cadrex LLC, the Plan's sponsor, approved to merge the Tenere Inc. 401(k) Retirement Plan into the Cadrex LLC 401(k) Savings and Retirement Plan. Total assets of approximately \$18,483,000 were transferred in two installments with the final assets transferred on March 5, 2024.

**Financial statement presentation:** These financial statements include the years ended December 31, 2023 and 2022, and the short period from January 1, 2024 to March 5, 2024. The Plan elected to defer the filing of its financial statements with its Form 5500 for the year ended December 31, 2023, as permitted by 29 CFR 2520.104-50, since the following period from January 1, 2024 to March 5, 2024, is a short year of seven months or less. Accordingly, the Plan has included statements of net assets as of March 5, 2024, December 31, 2023 and 2022, along with statements of changes in net assets for the short period from January 1, 2024 to March 5, 2024, and the year ended December 31, 2023, as required by DOL regulations when such election is made.

**Contributions:** Each year, participants were allowed to contribute up to 100% of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants could designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the Plan year were also eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan included an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also included an automatic-increase feature, which automatically increased the amount deducted each year by 1% until the maximum 6% had been attained. Participants could opt out of this automatic-increase feature if they changed their deferral rate. In connection with the Plan merger that occurred in 2024, participants were no longer allowed to make contributions during the period from January 1, 2024 to March 5, 2024.

#### Note 1. Description of the Plan (Continued)

The Plan also permitted safe harbor Company matching and discretionary profit-sharing contributions. For the year ended December 31, 2023, a safe harbor matching contribution was made in the amount of 100% of the first 1% of eligible compensation deferred and 50% of eligible compensation deferred greater than 1% up to 6%. There were no discretionary profit-sharing contributions for the year ended December 31, 2023. There were no Company contributions made for the period from January 1, 2024 to March 5, 2024.

**Participant accounts:** Each participant account was credited with the participant contributions, Company contributions, if any, and investment results. Participant accounts were charged with an allocation of administrative expenses paid by the Plan. Allocations were based on the participant's eligible compensation, account balances, or specified transactions, as defined in the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Investment options:** Upon enrollment in the Plan, a participant could direct contributions in a variety of investment options, which were described in more detail in the Plan's literature. Participants could elect, on a daily basis, to have all or part of their account balances and future contributions transferred from one fund to another, or in any combination.

**Vesting:** Participants were vested immediately in their contributions, plus actual earnings thereon. Participants fully vested in Company matching contributions after two years of credited service. Participants vested in Company discretionary profit-sharing contributions, plus actual earnings thereon, at 20% after one year of credited service and at a rate of 20% per year thereafter until 100% vested after five years of credited service. According to Plan provisions, a year of service was credited when the participant completed 1,000 hours of service during any Plan year. Participants who left the Plan because of death, early or normal retirement, or permanent disability retirement, as defined in the Plan, were considered 100% vested.

**Notes receivable from participants:** Participants could borrow from their fund accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account plus interest at rates that ranged from 4.25% to 9.50% as of March 5, 2024 and December 31, 2023, which reflected local prevailing rates at inception of the loan, as determined quarterly by the Plan Administrator. Principal and interest were paid ratably through payroll deductions. Terms ranged from one to five years, or greater if the loan was for the purchase of a primary residence. The loans matured on various dates through June 2033 and were merged into the Cadrex LLC 401(k) Savings and Retirement Plan.

**Payment of benefits:** Benefits could be paid to the participant or beneficiary upon death, permanent disability, retirement, hardship, termination of employment, or during employment, as defined in the Plan agreement. The Plan provided for normal retirement at age 65 and provided for in-service withdrawals at age 59 ½. If the vested account balance did not exceed \$5,000, a lump-sum distribution, net of tax, would be made. If the vested account balance exceeded \$5,000, the participant could elect to keep the vested balance in the Plan, receive a lump-sum distribution, net of tax, roll over the entire vested portion to another qualified plan, or receive installment payments. Participants experiencing financial hardship could withdraw a portion of their account balance, as defined in the Plan, if certain criteria were met.

**Forfeited accounts:** Forfeited nonvested accounts totaled \$0, \$37,849 and \$1,359 as of March 5, 2024, December 31, 2023 and 2022, respectively. During the period from January 1, 2024 to March 5, 2024 and the year ended December 31, 2023, there were no forfeitures used to partially fund Company contributions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Charter and Compensation Committee determined the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants were measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were recognized when they were incurred. No allowance for credit losses was recorded as of March 5, 2024 and December 31, 2023 or 2022. If a participant ceased to make loan repayments, and the Plan Administrator deemed the participant loan to be in default, the participant's loan balance was reduced and a benefit payment was recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

**Payment of benefits:** Benefit payments to participants were recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan were paid directly by the Company, and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account, and are included in administrative expenses, along with other expenses of maintaining the Plan. Investment-related expenses are included as an offset to net appreciation or included in net depreciation in fair value of investments.

**Risks and uncertainties:** The Plan provided for investment in a variety of investment securities. Investment securities, in general, were exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it was reasonably possible that changes in the values of the investment securities would occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through February 5, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 5, 2024, December 31, 2023 and 2022.

**Registered investment companies:** Investments in registered investment companies are valued daily at publicly quoted market prices of shares held by the Plan.

**Collective trust fund:** The collective trust fund is a stable value fund that is composed primarily of fully benefit-responsive investment contracts. The collective trust is measured using the net asset value (NAV) per share practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Were the Plan to initiate a full redemption of the collective trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Tax Status

The Plan had adopted a non-standardized pre-approved plan sponsored by Ascensus LLC. Ascensus Solutions LLC had received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter had been relied upon by this Plan. The Plan Administrator believes the Plan was designed and operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6. Related Party and Party-In-Interest Transactions

All Plan investments held during the period from January 1, 2024 to March 5, 2024 and at December 31, 2023 and 2022, were managed by Ascensus Trust Company, the trustee of the Plan. Therefore, all transactions qualify as party-in-interest transactions. All Plan assets were transferred out of the Plan during the period from January 1, 2024 to March 5, 2024.
