To the Trustees, Administrative Committee and Management of

LONGUST DISTRIBUTING, LLC RETIREMENT SAVINGS PLAN AND TRUST

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Longust Distributing, LLC Retirement Savings Plan and Trust** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 19, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period ended December 19, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 19, 2024 and December 31, 2023, and for the period from January 1, 2024 to December 19, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

The following description of Longust Distributing, LLC Retirement Savings Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. **General** – The Plan was a defined contribution plan. The Plan was originally established September 1, 1979 as a profit sharing plan. Effective September 1, 1998, the Plan was amended to add a 401(k) component. Effective July 27, 2024, the Plan was amended to terminate. The Plan covered all employees of Longust Distributing, LLC (the “Sponsor”) and Longust Flooring Company, LLC (collectively referred to as the “Company”). All employees were eligible to participate in the elective deferral portion of the Plan upon hire unless such employee was (1) a leased employee, (2) a bargaining unit employee, (3) a non-resident alien, or (4) a person classified by us as independent contractor. To participate in the employer contribution portion of the Plan, employees who were 18 years of age or older were eligible after one year of service and completion of 1,000 hours of service during 12 consecutive months. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. **Contributions** – Each year, participants could elect to contribute pre-tax and/or Roth up to 100% of eligible compensation as defined in the Plan, subject to certain limitations established by the Internal Revenue Service. In addition, the Plan allowed participants attaining the age of 50 before the end of the Plan year to make additional catch-up contributions not exceeding \$7,500 for the period ended December 19, 2024. The Plan had an automatic enrollment feature where participants were automatically enrolled in the Plan at a pre-tax contribution rate of 3%. These contributions began approximately 30 days after their date of hire, unless a participant made an election to contribute a different percentage or unless a participant declined participation in the Plan. These participants’ investments would default to one of the Vanguard target date funds, based upon each participant’s projected retirement date, unless otherwise directed by the participant. The automatic deferral would increase by 1% each plan year starting with the second full plan year, up to a maximum of 10%.

Participants could also contribute amounts representing distributions from other plans. The Company could make a discretionary participant deferral match to the Plan. For the period ended December 19, 2024, the Company did not make a matching contribution. The participant would have to be employed on the last day of the plan year to receive the matching contributions for that plan year. The Company could also make a discretionary profit-sharing contribution, which would be allocated to all eligible Plan participants in the ratio the participant’s compensation bears to the total compensation of all eligible participants for the plan year. For the period ended December 19, 2024, the Company did not make a discretionary profit-sharing contribution.

- C. **Participant accounts** – Individual accounts were maintained for each participant. Each participant’s account was credited with the participant’s contribution and allocations of the Company’s contributions, and Plan earnings. Allocations were based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

- D. **Vesting** – Participants were immediately vested in their pre-tax, Roth, and rollover contributions and actual earnings thereon. Vesting in the Company’s matching and profit-sharing contributions plus actual earnings thereon was based on years of service as follows:

The Plan defined a year of credited service to be a Plan year with the participant rendering at least 1,000 hours of service.

As of July 27, 2024, the effective date of the Plan termination amendment, all funds credited to a participant’s account became fully vested and nonforfeitable, including the Company’s matching and profit-sharing contributions.

- E. **Notes receivable from participants** – Participants could borrow against their vested account balances a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the vested balance in the participant’s account and bore interest at a fixed rate based on the U.S. prime rate plus 2.0% at the time the loan was distributed. Loans were expected to be repaid over a period of no more than 5 years, unless such loan was used to acquire the principal residence of the participant. Principal and interest were paid ratably through bi-weekly payroll deductions.
- F. **Payment of benefits** – Participants could withdraw their vested account balances in full or partial lump sums or installments upon retirement, disability or termination. Beneficiaries could withdraw vested account balances upon the death of a Plan participant. Participants could also withdraw all or a portion of their contributed account balances for specific hardship reasons subject to approval by the Plan Administrator. Lastly, participants who reach age 59½ could take a lump sum distribution of: (1) up to 100% of their pre-tax and Roth contribution accounts, and (2) up to 100% of their vested interest in their Company contribution account. Participants could also take a lump sum distribution of up to 100% of their rollover contribution account at any time.
- G. **Forfeitures** – Forfeitures of non-vested Company matching contributions and discretionary profit-sharing contributions were used to pay Plan expenses and offset Company contributions. At December 19, 2024 and December 31, 2023, there were \$0 and \$7,796 of forfeited non-vested accounts, respectively. During the period ended December 19, 2024, forfeited non-vested accounts totaling \$8,261 were used to pay administrative expenses.
- H. **Administrative expenses** – The Sponsor retained OneAmerica Retirement Services, LLC (“OneAmerica”) to serve as the Plan’s recordkeeper. Monthly service and ancillary fees for distributions, loans and QDROs were passed on directly to the participant who incurs the event. Fiduciary fees for the Plan’s investment manager were paid directly by the Sponsor.
- I. **Plan termination** – The Plan fully liquidated as of December 19, 2024, as a result of the termination amendment effective July 27, 2024, subject to the provisions of ERISA. As a result, participants became 100% vested in their account balances as of July 27, 2024.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The accompanying financial statements of the Plan were prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) on an accrual basis. Accordingly, income was recognized when earned and expenses were recorded when incurred.

Management's use of estimates – The preparation of financial statements in conformity with GAAP required the Plan Administrator to make estimates and assumptions that affected the reported amount of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Investment valuation and income recognition – The Plan's investments were stated at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability. Investments in shares of mutual funds were stated at net asset value ("NAV"), which were readily determinable fair values of those shares as they were published daily and were the basis for current transactions. The investment in a common collective trust was stated at unit value, or the equivalent of net asset value, which was a practical expedient for estimating fair value. The common collective trust had no unfunded commitments as of December 31, 2023, and could be redeemed daily with no redemption notice period or other redemption restrictions.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation/depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties – The Plan provided for various investment fund options which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities were exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of benefits – Benefit payments to participants were recorded when paid.

Subsequent events – Plan management has evaluated subsequent events through March 14, 2025, which is the date the financial statements of the Plan were available to be issued.

(3) Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(3) Fair value measurement (continued)

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan held no investments as of December 19, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

(5) Party-in-interest transactions

Recordkeeping responsibilities were performed by OneAmerica; therefore, transactions with this party qualified as a party-in-interest transaction. Fees for the period ended December 19, 2024 in the amount of \$35,076 paid to OneAmerica qualify as party-in-interest transactions.

(6) Income tax status

The Internal Revenue Service issued a determination letter dated December 28, 2016, stating that the Plan was designed in accordance with the applicable Internal Revenue Code ("IRC") requirements as of that date. The Plan Administrator and the Sponsor believe that the Plan was operating in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of and for the period ended December 19, 2024.
