Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Head Start of Lane County 403(b) Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Head Start of Lane County 403(b) Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Head Start of Lane County 403(b) Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Head Start of Lane County (the "Sponsor") is the plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Eligible employees include all employees of the Sponsor, who work more than 20 hours a week. Employees are eligible to participate in the Plan immediately on the date of hire. As of July 1, 2019, an employee who normally works less than 20 hours per week is excluded, however, if any such employee actually completes 1,000 hours of service in an eligibility computation period (first twelve months following employment commencement date), then such employee will no longer be part of this excluded class in subsequent plan years. Employees who are employed on the last day of the year are also eligible for the discretionary nonelective contribution.

Contributions

Each year, participants may contribute up to the maximum allowed by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Sponsor matches a discretionary percentage of base compensation that a participant contributes to the Plan. Additional discretionary nonelective contribution amounts may also be contributed to the Plan. During the year ended June 30, 2024, the Sponsor made matching contributions of \$353,188 and a discretionary contribution of \$397,137 to the Plan.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor matching contributions, and allocations of (a) the Sponsor's discretionary nonelective contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Sponsor's contribution portion of a participant's account is based on the number of years of service.

Sponsor contributions vest according to the following schedule:

	Vesting %

Participants are considered to have completed one year of service for the purposes of vesting upon the completion of a year of employment without regard to hours of service worked.

Forfeitures

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$25,345 and \$70,117, respectively. These accounts will be used to reduce future Sponsor discretionary nonelective contributions or pay for plan expenses. There were \$70,117 forfeitures used for the year ended June 30, 2024.

Investment Options

Participant contributions and Sponsor matching and discretionary nonelective contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Notes Receivable From Participants

Participants may borrow from their American United Life Insurance Company account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance (reduced by certain participant loans outstanding at the time the new loan is taken or anytime within 12 months prior to the date of the new loan). Loan transactions are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Interest rates on existing loans are 5.25%. Principal and interest are paid ratably through payroll deductions.

Participants may borrow directly from their Lincoln National Life Insurance Company account and use their plan account balance as collateral for the loan. Amounts used as collateral for the participant loans are invested in the fixed annuity investment option for Lincoln National Life Insurance Company. Interest rates on existing loans are 4.50% - 7.00%. The collateral must be equal to 100% of the loan, and payments on the loan are made outside of the Plan.

Notes receivable totaling \$242,333 and \$204,399 were collateralized by participant accounts as of June 30, 2024 and 2023, respectively.

Payment of Benefits

On termination of service, a participant or beneficiary may elect to receive an amount equal to the value of the participant's account in the form of a lump-sum distribution or substantially equal installments over a period of years not to exceed the participant's life expectancy. Hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. In-service distributions are permitted from the employee's entire account upon attaining age 59 1/2.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan invests in mutual funds held in pooled separate accounts, which are reported at fair value. Fair value of mutual funds held in pooled separate accounts is estimated using the net asset value ("NAV") per unit by the issuer of the pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition (Continued)

The Plan's Fully Benefit-Responsive Investment Contracts (FBRIC's), are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 3: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended June 30, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln National Life Insurance Company and American United Life Insurance Company, (the Custodians of the Plan).

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023.

Mutual funds held in pooled separate accounts: Fair value is estimated using the net asset value ("NAV") per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

Note 5: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan invests in FBRIC's with Lincoln National Life Insurance Company and American United Life Insurance Company in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. Lincoln National Life Insurance Company and American United Life Insurance Company maintain the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln National Life Insurance Company and American United Life Insurance Company are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GICs are carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate at Lincoln National Life Insurance Company is based on a formula agreed upon with the issuer but ranges from 2.60% to 3.50%. Lincoln National Life Insurance can credit a rate higher than the minimum guarantee at any time. American United Life Insurance establishes a rate for the subsequent year 35 days prior to the beginning of the year. At June 30, 2024, the average yield and crediting interest rate at American United Life Insurance Company was 2.00%.

Certain events limit the Plan's ability to transact at contract value with Lincoln National Life Insurance Company and American United Life Insurance Company including plan termination and other events as specified in the GICs. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GICs do not permit Lincoln National Life Insurance Company and American United Life Insurance Company to terminate the agreement prior to the scheduled maturity date.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Tax Status

The Plan's terms have been drafted in reliance on the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all their Sponsor contributions.

Note 9: Related-Party Transactions and Party-in-Interest Transactions

The Plan invests in fixed and variable annuity contracts managed by Lincoln National Life Insurance Company and American United Life Insurance Company. Lincoln National Life Insurance Company and American United Life Insurance Company are the custodians, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred and paid by the Plan for the investment management services were \$2,982 and additional fees were offset against earnings.

The Plan contracts with Wells Fargo to provide investment advisory services to the Plan. Fees incurred and paid by the Plan for the investment management services were \$33,310 for the year ended June 30, 2024.

The plan administrators who are plan participants make contributions and receive benefits in the same manner as all other participants of the Plan.

Notes receivable from participants issued by Lincoln National Life Insurance Company that are collateralized by participant accounts represent transactions with parties in interest.

Notes receivable from participants issued by American United Life Insurance Company also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 10: Subsequent Events

The Plan has evaluated subsequent events through March 12, 2025, which is the date the financial statements were available to be issued and determined no subsequent events require recognition or disclosure in the financial statements.
