### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of 403(b) Thrift Plan of Jefferson Hills Corporation (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 30, 2023, and December 31, 2022, and the related statements of changes in net assets available for benefits for the period then ended November 30, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

**Note 1. Description of the Plan**

The following description of the 403(b) Thrift Plan of Jefferson Hills Corporation (the Plan), formerly known as Jefferson Hills Corporation Matching 403(b) Plan, provides only general information. Participants should refer to the plan document and *Summary Plan Description*, which are available from the plan administrator, for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Jefferson Hills Corporation (the Organization) for the benefit of its employees who are eligible on the first day of employment. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). AIG Federal Savings Bank (AIG) and Mutual of America Life Insurance Company (Mutual of America) are the trustees of the Plan. The Variable Annuity Life Insurance Company (VALIC) and its subsidiaries, VALIC Retirement Services Company and VALIC Financial Advisors, Inc. (collectively, AIG Retirement Services) and Mutual of America Life Insurance Company (Mutual of America) are the insurance companies for the Plan.

**Contributions**

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions of up to 100% of eligible compensation. Employee rollover and catch-up contributions are also permitted. Employees who have one year of service, as defined, are eligible for Organization contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. During 2023 and 2022, the Organization made matching contributions of 100% of employees' salary deferral amount on the first 4% of each participant's compensation, subject to certain limitations as described in the Plan. The Plan also allows for discretionary contributions by the Organization. There were no discretionary contributions for the period ended November 30, 2023 and December 31, 2022. Contributions are subject to certain limitations.

**Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his contributions, as well as the Organization's contributions, into any of the separate investment accounts or investment contracts with an insurance company and may change the allocation daily.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Organization's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Organization contribution portion of their accounts, plus earnings thereon, is determined under the following schedule based on years of service:

The nonvested balance is forfeited upon termination of service. Forfeitures are available to reduce the Organization's future contributions to the Plan.

***Payment of Benefits***

Upon termination of service, an employee may elect to receive a lump-sum payment, partial distributions, installment payments (joint and survivor annuity: 50%), or purchase of an annuity contract equal to the value of his or her account. Participants may withdraw amounts from their accounts subject to certain limitations imposed by the Plan. Such withdrawals are also subject to certain taxes and penalties as assessed by the Internal Revenue Service (IRS).

***Forfeited Accounts***

At November 30, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$9,981, respectively. These accounts were used to reduce future organization contributions to participants. Also, in 2023 and 2022, the Organization contributions were reduced by \$10,444 and \$31,003, respectively, from forfeited nonvested accounts.

***Plan Loans***

VALIC issues loans to plan participants outside the scope of the Plan. Participants pledge as security a portion of their VALIC account balance, which represents 100% of the outstanding loan balance. The pledged assets are invested in the Loan Collateral and Escrow Funds and earn an effective interest rate equal to 3.0%. The amount pledged as collateral at November 30, 2023 and December 31, 2022, was \$0 and \$37,928, respectively. Other amounts pledged as collateral, \$0 and \$64,559, related to loans that are considered in default by VALIC at November 30, 2023 and December 31 2022, respectively. The amounts in default have been deducted from the collateral included in the investments. As the Plan still holds the assets of the participants associated with the defaulted notes, these amounts are considered to be plan assets and continue to accrue interest at 3.0%. When the participant has a distributable event, the amount of the defaulted collateral balance, plus any accrued interest, will be deducted from their account prior to distribution.

The Employee Benefit Security Administration (EBSA) has expressed concern that the pledging of collateral of a participant's balance could be considered a prohibited transaction; however, formal guidance has yet to be issued by the EBSA.

***Plan Termination***

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. See Note 8 for details on the Plan being terminated in 2023.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments.

Separate accounts are valued at estimated fair value as determined by AIG Retirement Services and Mutual of America, the insurance companies for the Plan. Loan collateral and escrow funds are valued based on the amortization of each loan as provided by AIG Retirement Services.

Fixed interest accounts are subject to a market value adjustment if amounts are withdrawn prior to termination of the contract; thus, the guaranteed interest accounts are not benefit-responsive and are valued at contract value, which approximates fair value, as provided by AIG Retirement Services.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the *Internal Revenue Code of 1986*, as amended. The Plan has not requested or obtained a determination letter, as the Internal Revenue Service does not currently provide that service for 403(b) plans. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

***Transfers Between Fair Value Hierarchy Levels***

Transfers in and out of Level 1 (quoted market prices), Level 2 (other significant observable inputs) and Level 3 (significant unobservable inputs) are recognized on the actual transfer date.

**Note 3. Certification of Plan Insurance Companies**

The Organization has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AIG Retirement Services and Mutual of America, the trustees and insurance companies for the Plan have certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of November 30, 2023 and December 31, 2022
- Net investment income (loss) as shown in the statements of changes in net assets available for benefits and related disclosures for the period ended November 30, 2023 and year ended December 31, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The fixed accounts are part of the general account of AIG Retirement Services, an insurance company for the Plan, and the separate accounts are investments managed by the insurance companies. The insurance companies assess a daily charge against the separate accounts, which is deducted from each investment, and is reflected in the unit value of the investments held by the Plan and included in net appreciation in fair value of the investments. During 2023 and 2022, the Plan paid administration fees to the insurance companies totaling \$9,382 and \$12,550, respectively.

The Plan incurs additional expenses related to general administration and record keeping. The plan sponsor pays these expenses and certain accounting and auditing fees relating to the Plan and provides administrative services, at no cost, to the Plan.

**Note 5. Disclosure About Fair Value of Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the period ended November 30, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

***Level 3 Valuation Process***

Fair value determinations for Level 3 measurements of securities are the responsibility of the plan administrator. The plan administrator challenges the reasonableness of the assumptions used and reviews the methodology to ensure the estimated fair value complies with accounting standards generally accepted in the United States.
