We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events

affecting them may differ significantly from those expected. There are no significant estimates impacting the financial statements for the year ended June 30, 2024.

The financial statement disclosures are neutral, consistent and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. Management provided a trust statement prepared by the custodian of the Plan. In order to present financial statements that reconcile to the Form 5500, certain reclassification adjustments were proposed; these adjustments were agreed to by management.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, are presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Catholic Charities of the Diocese of Pittsburgh, Inc. and its Subsidiary Corporations Money Purchase Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audits of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP); and
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Catholic Charities of the Diocese of Pittsburgh, Inc. and its Subsidiary Corporations Money Purchase Plan (the "Plan") is provided for general information purposes only. Plan participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan, established effective July 1, 1991 and restated effective July 1, 2021, is a defined contribution, money purchase plan adopted by Catholic Charities of the Diocese of Pittsburgh, Inc. (the "Sponsor"). All eligible salaried and hourly employees who have completed one year of 1,000 hours of service and attained the age of 21 are covered under the Plan. A person who has one year of service of prior employment in the non-profit health, hospital or social service fields within the last three years prior to the date of hire with the Sponsor becomes eligible to participate in the Plan if such person is scheduled to work at least 50% of the regularly scheduled hours or 1,000 hours of service per year, whichever is less.

Contributions - The Sponsor makes monthly contributions to the Plan equal to 5.7% of monthly compensation of participants, subject to annual limitations prescribed by the Internal Revenue Code (IRC). This contribution satisfies the minimum funding standard requirements as provided by the IRC. Employees make no contributions under the Plan.

Participant Accounts - Each participant's account is credited with the Sponsor's contribution and an allocation of the Plan's earnings or losses thereon and is decreased by any account distributions. Allocations are based on the participant's earnings or account balances as defined by the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants may direct their share of employer contributions and any related earnings into various investment options, including a guaranteed investment contract maintained by the Principal Life Insurance Company and various mutual funds and common collective trusts.

Vesting - Participants become fully vested in their accounts upon completion of five years of vesting service (vesting in 20% increments per year). Participants also become fully vested upon attaining the early retirement age, which is defined by the Plan as age 55.

Payment of Benefits - Distributions are permitted upon termination, death, hardship (as defined in the plan agreement) or reaching age 59½. Benefit payments must begin by age 73 if the participant is not actively employed by the Sponsor. Benefits are reflected when they have been approved for

payment and are paid by the Plan. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or the participant may receive benefit payments in the form of an annuity.

At June 30, 2024 and 2023, there were no amounts allocated to accounts of individuals who have withdrawn from the Plan but have not been paid.

Administrative Expenses - Administrative expenses are paid by the Sponsor or the Plan, as provided by the plan agreement.

Basis of Accounting - The financial statements are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets at the dates of the financial statements and the reported changes in assets available for benefits during the reporting periods. Actual results could differ from those estimates.

Forfeitures - Forfeited balances of terminated participants' nonvested accounts are available to offset administrative expenses or employer contributions to the Plan, as defined in the plan agreement. Forfeitures of approximately \$23,000 and \$7,400 in 2024 and 2023, respectively, were used to offset administrative expenses and to reduce employer contributions.

Investment Valuation and Income Recognition - Investments are stated at fair value. The unrealized appreciation (depreciation) of investments is determined by the change in current market value from the beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized appreciation (depreciation) of investments is determined by the change in the current market value from the beginning of the year (if held since the beginning of the year) to the date of sale, or from the date of purchase to the date of sale. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Gains and losses (realized and unrealized), are reported in net appreciation (depreciation) in fair value of investments in the statement of changes in assets available for benefits. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priorities to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Non Fully Benefit-Responsive Investment Contracts: The Plan invests in non fully benefit-responsive investment contracts. The guaranteed investment contracts are carried at fair value, which approximates contract value and is estimated by discounting cash flows based on current yields of similar investments with comparable durations considering the creditworthiness of the issuer (level 3 measurement).

Common Collective Trusts: Collective trust funds are valued at net asset value of units of a common collective trust, which is a practical expedient to estimate fair value and is excluded from the fair value hierarchy. Investments are redeemable on a daily basis without restriction. There are no unfunded commitments to these funds at June 30, 2024.

Mutual Funds: Mutual funds are valued using a quoted price in an active market (level 1 measurement).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Subsequent Events - Management has evaluated subsequent events through March 17, 2025, the date the financial statements were available to be issued.

2. INVESTMENTS

A summary of the changes in the fair value of the Plan's level 3 assets, which are limited to guaranteed investment contracts, for the years ended June 30, 2024 and 2023 is as follows:

The guaranteed investment contracts that matured on June 30, 2024 and 2023 were reinvested in new guaranteed investment contracts or other investments of the Plan, as directed by the participants in the maturing contracts.

During the years ended June 30, 2024 and 2023, the Plan's investments (including investments bought, sold and held during the year) appreciated in value by \$494,661 and \$369,566, respectively.

3. PLAN TERMINATION

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The assets of the Plan will be distributed by the custodian in accordance with the custodian agreement in a uniform and nondiscriminatory manner.

4. INCOME TAX STATUS

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan with a cash or deferred arrangement. The Internal Revenue Service has determined and informed the plan sponsor by a letter dated June 30, 2020 that the form of the pre-approved plan is acceptable for use by employers under IRC Section 401. The Plan was amended and restated effective July 1, 2021; however, the plan administrator believes that the Plan continues to be designed and operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes there is no liability related to uncertain tax positions at June 30, 2024 or 2023. The Plan is no longer subject to tax examinations for the years ended before June 30, 2021.

5. CERTIFIED FINANCIAL INFORMATION

Principal Life Insurance Company, the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments, as shown in the statements of assets available for benefits as of June 30, 2024 and 2023.
- Net investment income, as shown in the statements of changes in assets available for benefits for the years ended June 30, 2024 and 2023.
- The schedule of assets held for investment purposes at June 30, 2024, as shown on the accompanying schedule.

6. RELATED PARTIES AND PARTIES-IN-INTEREST

Principal Life Insurance Company served as the custodian of the Plan during the years ended June 30, 2024 and 2023.

Certain plan investments in collective trusts and guaranteed investment contracts are managed by Principal Life Insurance Company, the custodian. Additionally, the Plan paid certain administrative fees for custodial services. Fees paid by the Plan for custodial services were not significant for the years ended June 30, 2024 and 2023 and are not considered prohibited transactions under Section 408(b) of ERISA regulations.

Neither the Sponsor nor employees of the Sponsor involved in the administration of the Plan receive compensation from the Plan.
