Notes to Financial Statements

Note 1: Description of Plan

The following description of the Galfab Holdings, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, as established on September 22, 2017, is a defined contribution plan covering all eligible employees of Galfab Holdings, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees of the Company are eligible to participate in the Plan after having completed three months of service, as defined by the Plan, provided the employee is not covered under a collective bargaining agreement and is not a nonresident alien. Employees may enter the Plan immediately upon their fulfillment of the eligibility requirements.

Contributions

Each year, participants may contribute a portion of their eligible compensation, as defined by the Plan, as either pre-tax or after-tax Roth deferral contributions not to exceed the maximum allowable by the Internal Revenue Service (IRS). The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer three percent of eligible compensation to the Plan unless the participant makes an affirmative election otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan provides for the Company to make discretionary profit sharing and discretionary matching contributions. There were no profit sharing or matching contributions made during 2020.

Participants direct the investment of the contributions to their account into various investment options offered by the Plan, which are held under an investment contract with The Voya Retirement Insurance and Annuity Company (Voya).

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's voluntary deferral and rollover contributions and allocations of the Company's (a) discretionary matching contributions, if any, (b) the Company's discretionary profit sharing contributions, if any, and (c) an allocation of the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are 100% vested in their voluntary deferral and rollover contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing and matching contributions, if any, plus actual earnings thereon is based on years of continuous service, as defined by the Plan.

Participants vest in Company discretionary profit sharing contributions at a rate of 20% per year beginning with their second year of service and become fully vested after six years of credited service. Participants vest in Company matching contributions at a rate of 25% after one year of service and become fully vested after four years of credited service. Participants become fully vested upon normal retirement age, death or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%, which is a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on notes receivable from participants outstanding at December 31, 2020 ranged from 4.25% to 6.25%. Principal and interest are repaid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, as defined, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account or partial withdrawals, provided the withdrawal is at least \$200. The Plan also allows for in-service distributions for participants who have attained the age of 59½ from participant's vested account balances and earnings thereon, provided the minimum withdrawal is \$200. In addition, the Plan allows for hardship withdrawals from a participant's elective deferral accounts for specific situations as defined by the Plan.

If a terminated participant has a vested account balance of less than \$5,000, exclusive of rollover contributions from another qualified plan, and the participant fails to timely elect to distribute their account, the participant's entire vested account will be rolled over to an IRA selected by the Plan administrator, provided the amount is at least \$200.

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans. Written amendments to the Plan to reflect these operational changes will also be adopted at a later date in accordance with applicable law and IRS guidance.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Payment of Benefits (Continued)

At December 31, 2020 and 2019, there were no amounts owed to former participants whose employment had been terminated and who requested payout of their account balances.

Forfeitures

Forfeitures are portions of participant's accounts that participants surrender by terminating employment prior to becoming fully vested. Forfeitures of nonvested accounts may first be used to pay administrative expenses, and any remaining amounts will be used to reduce Company discretionary contributions. At December 31, 2020 and 2019, there were no forfeited nonvested accounts.

CARES Act

The Plan has adopted certain provisions of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") that was signed into law on March 27, 2020, which were immediately available, for Coronavirus-related distributions, suspended participant loan payments and increased loan limits, and waiver of required minimum distributions that were due during 2020. Written amendment to the Plan to reflect these operational changes was adopted during 2022.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of changes in net assets during the reporting period. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan invests in an investment contract with Voya. The investment contract is comprised of several funds within a pooled separate account and a guaranteed interest rate fixed account from which participants of the Plan may choose to invest their account balance. Participants hold units of participation in the individual fund or fixed account in which their account balances are invested.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition (Continued)

The Plan's investments in the funds within the pooled separate account under the investment contract with Voya are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan's investment in the fixed account under the investment contract with Voya is stated at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of units of participation are recorded on the trade-date basis. Interest income is recorded on accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2020 and 2019. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Excess Contributions Payable

At December 31, 2020 and 2019, amounts payable to participants totaling \$5,745 and \$7,919, respectively, for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2020 and 2019 excess contributions to the applicable participants in August 2021 and March 2020, respectively.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to participants based on their respective account balances in the related funds and are included as a reduction in investment income.

Subsequent Events

The Plan has evaluated subsequent events through November 8, 2024, which is the date the financial statements were available to be issued. See Note 12.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2020 and 2019.

Pooled separate account under the investment contract with insurance company: Valued at the net asset value (NAV) per unit, as provided by the Custodian, and is used as a practical expedient to estimate fair value. The NAV per unit is based on the fair value of the underlying investments adjusted by a daily asset charge as determined by the contract issuer.

Note 4: Guaranteed Interest Account

The Plan invests in a guaranteed interest rate fixed account, the Voya Fixed Account (Fixed Account) under an investment contract with Voya. The Fixed Account is classified as a fully benefit-responsive investment contract which is carried at contract value. Voya maintains the contributions to the fixed account in a general account. The account is credited with earnings based on the rate of return determined by price breaks as specified in the contract. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The fixed account is included in the accompanying financial statements at contract value (Note 2), which represents contributions made to the fixed account under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments in the fixed account at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The value of the fixed account investment at December 31, 2020 and 2019 was \$10,095 and \$4,042, respectively. The crediting interest rate is determined at the discretion of the issuer, but may not be less than 1%. The interest rate is reviewed on a six-month basis for resetting.

The ability of the Plan or its participants to transact at contract value with the issuer could be limited if the Plan decides to withdraw from the investment contract. The Plan administrator has indicated there is no intent to withdraw from the contract in the near term. The contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date. No such termination has occurred.

Note 5: Information Prepared and Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2020 and 2019, and total investment income and interest income on notes receivable from participants for the year ended December 31, 2020, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Voya, the Custodian of the Plan.

Note 6: Tax Status

The Company has adopted a Volume Submitter 401(k) Profit Sharing Plan (Volume Submitter Plan) sponsored by FIS Business Systems LLC. The Volume Submitter Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

During 2021, the Plan's independent auditor's identified an operational error noting the lack of participant deferrals being computed and withheld on incentive and bonus pay. In January 2024, the Plan administrator made a self correction under the IRS's Employee Plans Compliance Resolution System to correct for this operational error. Amounts contributed to the affected participant accounts in January 2024 totaled \$1,353. See Note 12.

Additionally, in November 2024, the Plan administrator will file an amended Form 5500 for the 2020 Plan year.

No provision for income taxes is included in the financial statements related to the foregoing matters because the Plan administrator believed the Plan continued to be qualified to maintain exclusion from tax for Plan participants.

Note 7: Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under the ERISA regulations. Fees paid by the Plan to the Custodian for administrative expenses aggregated \$2,025 for the year ended December 31, 2020. In addition, certain administrative functions are performed by employees of the Company, for which no compensation is received from the Plan for their services.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary contributions. The Company initially expressed its intent to terminate the Plan on November 1, 2021, subsequent to its sale of business to an unrelated third party. See Note 12.

Note 9: Risks and Uncertainties

The Plan invests in a pooled separate account and a guaranteed interest rate fixed account under an investment contract with an insurance company. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Prohibited Transactions

Under DOL Reg. 2510.3-102(b), the Company is required to remit the participant salary deferral contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Company's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Company. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for payrolls during the Plan year ended December 31, 2018, totaling \$18,615, and payrolls during the period from September 22, 2017 through December 31, 2017, totaling \$3,504, were not remitted until several days after the earliest day reasonably segregated. These transactions constitute prohibited transactions as defined by ERISA. Although the Plan's former management originally represented that such corrections were made to the Plan on October 15, 2020, that did not happen. Furthermore, based on lost earnings computations performed in January 2024, and guidance provided by outside ERISA counsel, no corrective contributions to the Plan related to the aforementioned delinquent participant contributions were deemed necessary.
