## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
the Phoenix Services, LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Phoenix Services, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Phoenix Services, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Phoenix Services, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### 1. The Plan

The following description of the Phoenix Services, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of Phoenix Services, LLC and Atlas Industrial Resources, LLC, and affiliated employers (collectively, the "Company") who are not covered by a collective bargaining agreement with the Company and have completed three months of service and attained 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

**Plan Amendments** – On March 27, 2020, President Trump signed into law the "Coronavirus Aid, Relief, and Economic Security Act" ("CARES Act"). The CARES Act, among other things, includes several relief provisions available to tax-qualified retirement plans and their participants. The Company implemented several provisions of the CARES Act. The Plan has until December 31, 2025, to amend the Plan documents, as necessary, for the CARES Act provisions.

**Contributions** – Each year, participants may make a pre-tax or after tax (Roth) contribution to the Plan, deferring varying percentages of compensation as specified by the Plan document, subject to Internal Revenue Service ("IRS") regulations. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions to the Plan. At the discretion of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit, defined contribution or individual retirement plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan has a provision for a safe harbor employer matching contribution equal to 100 percent of the participant's elective deferrals that are not in excess of 5% of the participant's eligible compensation, as defined by the Plan document. Profit sharing contributions may be permitted at the discretion of the Company. These contributions, if made, are allocated to all eligible participants based on the ratio of the participant's compensation to the total compensation of all eligible participants. The Company may also make qualified matching contributions determined by the Company in its sole discretion, to satisfy certain plan provisions.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

**Participant Accounts** – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's contributions, and the participant's share of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are vested immediately in their contributions and the Company's matching contributions plus actual earnings thereon. Vesting in the Company's profit sharing contributions is based on a four-year graded vesting schedule. Participants will become 100 percent vested in the Company's profit sharing contribution upon termination of employment due to death or disability or if employed after reaching retirement age.

**Notes Receivable from Participants** – Prior to January 1, 2017 (see Note 2), participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans are secured by the vested balance in the participant's account. Participants must have had a minimum vested account balance of \$2,000 to be eligible to take a loan. The number of loans a participant could have outstanding at once was one. All loans to participants are considered notes receivable of the Plan and will bear a reasonable rate of interest as determined by the Plan agreement. All loans are to be repaid within five years unless used to acquire a principal place of residence, in which case the loan may be repaid within a period of no more than 15 years. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** – Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Generally, any benefit due shall be paid as soon as administratively feasible.

In-service withdrawals of a participant's vested account balance are permitted for participants who have attained the age of 59-1/2 or normal retirement age. Other in-service withdrawals may be permitted in accordance with Plan documents.

Hardship withdrawals are permitted by the Plan where the participant can demonstrate an immediate and heavy financial need, as defined by the Plan agreement.

**Forfeited and Suspense Accounts** – At December 31, 2022 and 2021, forfeited and suspense accounts totaled \$20,893 and \$67,297, respectively. These accounts may be used to reduce future employer contributions or pay Plan expenses. During 2022 and 2021, estimated employer contributions were reduced by approximately \$176,000 and \$30,000, respectively, to be paid from these accounts. During 2022 and 2021, \$177 and \$-0- from these accounts were used to pay Plan expenses.

## 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** – Effective January 1, 2017, a revised Adoption Agreement became effective that removed the Plan's loan provision. As a result, effective January 1, 2017, new participant loans are no longer permitted by the Plan. Outstanding notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees and administrative expenses are recorded when they are incurred. If a participant ceases to make loan repayments and Plan management deems the participant loan to be in default based upon the terms of the Plan document, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### 3. Information Certified by Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2022 and 2021, was obtained by management and agreed to or derived from information certified as complete and accurate, by Ascensus, the recordkeeper of the Plan, as agent for Ascensus Trust Company, the custodian of the Plan.

### 4. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, defines fair value as the price that would be received from selling an asset or paid to transfers a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. ASC 820 establishes three levels of inputs that may be used to measure fair value as follows:

*Level 1:* quoted prices in active markets for identical assets or liabilities;

*Level 2:* inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities;

*Level 3:* unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission (“SEC”). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* Valued at NAV at year-end, based on information provided by the trustee and using the audited financial statements of the trust at year-end. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and is used as a practical expedient to estimate fair value.

## 5. Investment Contract

The Plan has an investment in the MetLife GAC-25053 Class 0 Fund (the “Fund”), which is a common collective trust fund. The Fund generally invests in bonds with short-to-intermediate term maturities, and insurance contracts which aim to provide price protection. In addition, the Fund maintains a wrapper contract issued by insurance companies and other financial institutions designed to allow the portfolio to maintain a constant NAV and to protect the portfolio in extreme circumstances. Participants may generally redeem units on a daily basis at NAV. NAV represents contributions made to the collective trust fund plus earning less participant withdrawals and administrative expenses.

Certain events may limit the ability of the Plan to transact at NAV with the Fund. Such events include Plan sponsor events that cause a significant withdrawal from the Plan, such as a Plan level liquidation, and the availability of uncommitted cash and liquid investments available on the requested redemption date. The plan administrator believes that no events are probable of occurring that would limit the Plan’s ability to transact at NAV with participants.

### 6. Related-Party Transactions and Party in Interest Transactions

Plan investments are managed by the custodian and recordkeeper of the Plan, for which fees are charged and, therefore, these transactions qualify as party in interest transactions. Additionally, loans to participants are also considered party in interest transactions. Although the above transactions are party in interest transactions, they are exempt from the prohibited transaction rules of ERISA.

The Plan sponsor failed to remit certain participant contributions in a timely manner for one payroll period during 2022, as required by Department of Labor Regulation 2510.3-102 and is considered a prohibited transaction. Contributions not corrected as of December 31, 2022, totaled \$3,725.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### 8. Income Taxes

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. Management believes that the Plan has had certain operational failures and was not being operated in accordance with the Plan documents. Therefore, uncertainties have existed regarding the Plan's tax qualification status. During 2022 and 2021, the Company improperly remitted certain employee and employer contributions to the Plan which have not been fully corrected as of the report date. Additionally, certain non-discrimination testing required by the IRS for the year ended December 31, 2022 has not been corrected for adjustments resulting from the improper remittance of contributions. Due to circumstances related to the above errors certain required filings with the IRS and Department of Labor have not been made timely. As of the date of the report, management is in the process of correcting these errors. Management believes that other than the operational errors referred to above, the Plan is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Certain adjustments that may result from the uncertainties discussed above have not been recorded in the accompanying financial statements.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan investments include a variety of investments that may directly or indirectly invest in securities with contractual cash flows. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

### 10. Subsequent Events

The Plan was amended and restated effective September 1, 2023 to change the Plan administrator to Pentegra Services, Inc. The amendment and restatement, effective September 1, 2023, among other things, changed the eligible age to participate to age 18, added a loan feature to the Plan and removed the requirement for a True-Up of employer contributions. In addition during 2023, the custodian of the Plan was changed from Ascensus Trust Company, LLC to Empower Trust Company, LLC and effective September 5, 2023 Plan assets totaling approximately \$13,000,000 were transferred to the new custodian. Concurrent with the change, the record keeper changed from Ascensus, LLC to Empower Retirement, LLC. On July 24, 2023, the Plan was amended to implement certain hardship distribution provisions of the Bipartisan Budget Act of 2018, including that elective deferrals will not be suspended on account of hardship distributions. Effective January 1, 2024 the Plan was amended to include on the first day of each Plan year, an escalation of the automatic deferral amount of 1% of compensation up to a maximum of 10% of compensation.

Plan management has evaluated all subsequent events through March 18, 2025, the date the financial statements were available to be issued.
