Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Herdrich Petroleum Corporation 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended June 30, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Note 1 Description of Plan

The following description of the Herdrich Petroleum Corporation 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all full-time employees of Herdrich Petroleum Corporation (the Company) who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

Contributions. Participants may contribute up to the maximum annual dollar limit set by law of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers 24 investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Each year, the Company may contribute to the Plan an amount that is at the discretion of the board of directors of the Company. The Company contributed \$402,013 to the Plan for the year ended June 30, 2024.

Participants' Accounts. Each participant's account is credited with the participant's contributions and an allocation of the Company's contribution and Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits. On termination of service with a vested account balance exceeding \$5,000 (excluding amounts attributable to rollovers), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, single-sum payment of a portion of the account balance, or in monthly, quarterly, semi-annual or annual installments over a period of not more than the participant's assumed life expectancy. On termination of service with an account balance of \$5,000 or less, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits in-service and hardship withdrawals under certain conditions.

Forfeited Accounts. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$18,728 and \$47,288, respectively. These accounts will first be used to pay Plan administrative expenses and then allocated as an additional discretionary nonelective contribution. In the 2024 Plan year, \$423 and \$16,145 from forfeited nonvested accounts was used to pay plan administrative expenses and audit fees. In addition, \$2,067 and \$10,337 of forfeited nonvested account balances were used to fund corrections of errors noted in the prior year audit and fund an additional discretionary nonelective contribution in the 2024 Plan year.

Note 2 Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through February 26, 2025 which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Under the modified cash basis of accounting, contributions are recognized as income when funded by the Plan sponsor and investment income is recognized when received rather than when it is earned and expenses are recognized when paid rather than when the obligation is incurred. The investment transactions are shown based on the cash method of accounting and investments are shown at fair value.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded when received. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 3 Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices or inputs that are observable and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Insurance Company Pooled Separate Accounts: These accounts are valued on net unit basis as determined by Empower on the last day of business of the Plan year. The fair values of these investments are determined by references to the respective fund's underlying asset, with Empower specifying the source(s) to use for the underlying investment asset process.

In accordance with Accounting Standards Codification Subtopic 820-10, these investments measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy.

Note 5 Guaranteed Investment Contract with Insurance Company

The Plan has a group annuity contract with Empower Annuity and Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. As described in Note 2, Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Empower Annuity and Insurance Company of America. Such events include the following: (a) amendments to the plan documents (including complete and partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The average yield earned by the Plan is derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for the year ended June 30, 2024 was 1.33%. The actual average based on earnings for the year ended June 30, 2024 was 1.33%.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Note 7 Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

Note 8 Related-Party Transactions and Party in Interest Transactions

Certain plan investments are funds managed by the Empower Trust Company LLC, the custodian of the Plan, and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the plan for investment management services are included in net appreciation of the investments, as they are paid through revenue sharing, rather than direct payment. The Plan paid \$23,332 of administrative fees to Empower Annuity Insurance Company during the year ending June 30, 2024. Other than Plan expenses paid from forfeited nonvested accounts as described in Note 1, the Plan Sponsor pays directly other fees related to plan operations.

Note 9 Tax Status

On November 14, 2022, the Internal Revenue Service stated that the prototype plan adopted by the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes the plan is qualified and the related trust is tax-exempt.

The plan administrator elected to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 10 Self-Correction Program

There were errors discovered during the 2023 fiscal year audit in employer profit sharing contribution allocation, distribution vesting percentage, and participant deferrals. The Company made contributions to the affected participants' accounts to compensate those participants an aggregate of approximately \$12,404 for errors, including lost earnings and interest, due to delays. The plan sponsor has decided to correct the errors under the Self-Correction Program (SCP) established by the IRS Employee Plans Compliance Resolution System. There is no fee to correct the mistakes. There were no errors discovered in the 2024 fiscal year audit.
