Independent Auditor's Report

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Health Imperatives, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Health Imperatives, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF PLAN

The following description of Health Imperatives, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a 403(b) defined contribution plan covering substantially all employees of Health Imperatives, Inc. (the Agency) (the Plan Sponsor). The Agency's Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Agency's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

All employees are eligible to participate in the Plan on their first day of employment with the Agency, or at any time after hire.

Employees may also be eligible for any of the Agency's discretionary matching or discretionary profit-sharing contributions the month after their anniversary date upon attainment of age twenty-one, rendering one-year of service (with at least 1,000 hours) at the Agency, and being employed as of the end of the plan year.

c. Contributions

Each year, participants may contribute a percentage up to 100% of pre-tax annual compensation, as defined in the Plan and subject to statutory limitations, including a catch-up provision for those age 50 years or older as of the end of the plan year. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct investment of their contributions into various investment options offered by the Plan.

Agency discretionary contributions require annual Board of Directors' approval and are determined annually. The Agency's discretionary matching and discretionary profit-sharing contributions are to be allocated to each participant employed with the Agency on the last day of the plan year. The discretionary contributions formulas are as follows:

- The discretionary matching portion for those participants who made employee deferral contributions during the years ended June 30, 2024 and 2023, is based upon dividing the amount of the approved pension contribution evenly to all eligible participants prorated by number of payroll periods the eligible participant actively participated during the year.
- For the discretionary profit-sharing portion, it is based on the participant's compensation at the time they were actively participating in the Plan as a ratio of total compensation paid to all participants for the years ended June 30, 2024 and 2023.

The Agency made \$66,538 and \$119,923 in discretionary matching contributions during the years ended June 30, 2024 and 2023, respectively. There were no discretionary profit-sharing contributions made for the years ended June 30, 2024 and 2023.

d. Participant Accounts

Each participant's account balance reflects the participant's contributions and allocations of the Agency's discretionary contributions, plan earnings or losses, and administrative fees paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations are based on participant earnings or losses or account balances, as defined in the plan document.

e. Vesting

Participants are fully vested in all contributions.

f. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants, or their beneficiaries, who have reached the normal retirement age of 65, with an option for early retirement at the age of 55. The Plan also allows for participants to take in-service distributions upon reaching age 59 ½. Upon termination of service due to death, disability or retirement, a participant may elect to receive a single life annuity, joint and survivor annuities, or in a lump-sum distribution. Participant account balances under \$5,000, upon termination of employment with the Agency, are transferred to an Individual Retirement Account (IRA) or paid out in cash if under \$1,000. Effective January 1, 2024, the Plan Administrator adopted the optional SECURE Act 2.0 provision to increase the limit of involuntary force-out distributions from \$5,000 to \$7,000.

A participant may also request a withdrawal of their own elective deferral contributions upon demonstration to the Plan Administrator that they are suffering a "hardship." Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

g. Notes Receivable from Participants

The Plan provides for participants to borrow up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance with the qualified institution, Empower Trust Company, LLC. The minimum loan allowed is \$1,000. The loans are secured by the balance in the participant's account and bear interest at various maturities which are commensurate with local prevailing rates as determined by the Plan Administrator at the time of the loan. A participant is only allowed to have one loan outstanding at a time. A participant must repay the loan within five years unless the loan is used to acquire a primary residence, in which case it is fifteen years. All loan repayments are paid through payroll deductions.

h. Plan Loans

The Plan also allows for participants to borrow against their account balance directly with Variable Annuity Life Insurance Company (VALIC) with their account balance acting as collateral. As of June 30, 2024, all plan loans, totaling \$32,598, were in default and deemed distributed. As of June 30, 2023, there were \$41,272 of outstanding loans to VALIC and collateralized by participant accounts and were in default status. The loans were secured by the balance in the participant's account and bear interest at 3.00%. These collateralized amounts are reflected in fixed annuity contracts in the accompanying statements of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's variable annuities and mutual funds are stated at fair value. Units held by the Plan in variable annuities are measured at a readily determinable fair value (RDFV) based on each fund's daily net asset value (NAV), which is considered to be the best approximation of fair value. Shares of mutual funds are stated at quoted market prices on public exchanges, which represent the NAV of shares held by the Plan at year-end. Investments in the fixed annuity contracts and guaranteed investment contract are measured at contract value based on the contractual term of the underlying contract. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the qualified institutions. See Note 4 for discussion of fair value measurement.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully-benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of June 30, 2024 and 2023, there were \$6,948 and \$37,407, respectively, of defaulted loans that have been deemed distributed and included in benefits paid to participate in the accompanying statements of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Contributions

Contributions from plan participants are recorded in the year which the participant contributions are withheld from compensation. The Agency's discretionary matching and discretionary profit-sharing contributions are recorded when such contributions are authorized by the Agency's Board of Directors.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Agency and, accordingly, are not reflected in the financial statements of the Plan. The Plan's administration and asset management fees are allocated to the individual participant accounts in accordance with the plan document. The Plan's investment transaction fees are netted with investment returns and are allocated to the individual participant accounts.

Subsequent Events

Subsequent events have been evaluated through March 5, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition for disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VALIC, Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, Empower), the qualified institutions, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of June 30, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

4. FAIR VALUE MEASUREMENT (Continued)

The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price.

Variable annuities: The fair value of accumulation units held by the Plan in variable annuities is based on each account's daily NAV as a RDFV. Variable annuities are not exchange traded. Data for NAVs is available daily to plan administrators and client investors via the VALIC website, and provides sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings and, accordingly, these investments are valued using observable inputs. The variable annuities reflect a structure similar to mutual funds and have a RDFV as reported by VALIC each day that current transactions are recorded. There are no unfunded commitments from participants in the Plan who invest in these accounts.

There have been no changes in the valuation methodologies used at June 30, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FIXED ANNUITY CONTRACTS WITH VALIC

The Plan has short-term and long-term fixed annuity contracts with VALIC. These contracts are credited with participant contributions and investment income and charged for participant withdrawals and administrative expenses. The contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the contracts are fully-benefit-responsive, contract value is the relevant measure attribute for that portion of the net assets available for benefits attributable to the contracts. Contract value, as reported by VALIC, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value. The VALIC long-term fixed annuity contract limits the percentage of the investment for periodic elective transfers to variable investments within the Plan during any twelve-month period. The VALIC short-term fixed annuity contract limits the periodic elective transfers to variable investments until a minimum of ninety days from contribution up to a maximum of 180 days as determined by VALIC.

The VALIC fixed annuity contracts are credited with interest from the general assets of VALIC. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is determined by VALIC with a floor of 3% for participant accounts set up before December 1, 2003, and 2% for participant accounts set up on or after December 1, 2003. Effective January 1, 2011, contracts issued to participants have an indexed guaranteed minimum interest rate.

6. GUARANTEED INVESTMENT CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA

The Plan's guaranteed investment contract is a fully-benefit-responsive investment contract with Empower Annuity Insurance Company of America (EAIC). EAIC maintains the contributions in a separate account used solely to satisfy the claims of the contract holder. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

6. **GUARANTEED INVESTMENT CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA** (Continued)

The guaranteed investment contract is included in the financial statements at contract value as reported to the Plan by EAIC. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average crediting interest rate is set quarterly.

Certain events limit the ability of the Plan to transact at contract value with EAIC. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with EAIC and the Plan participants have a probability of occurring.

7. **TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated March 31, 2017, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions' however, there are currently no audits for any tax periods in progress.

8. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all accrued benefits shall become fully vested and be paid to participants in accordance with the provisions of the Plan.

9. **RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, funds and related transactions with investment funds managed and held by the qualified institutions are considered party-in-interest transactions. During fiscal years 2024 and 2023, the Plan paid administrative fees and asset management fees of \$20,675 and \$21,985, respectively.

10. **RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the accompanying statements of net assets available for benefits.
