Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Umpqua Community Health Center, Inc. 403(b) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Umpqua Community Health Center, Inc. 403(b) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of Umpqua Community Health Center, Inc. 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan Administrator oversees the governance of the Plan. The Plan was originally effective December 30, 2004, and was restated on January 1, 2009, to reflect provisions of final regulations under section 403(b) of the Internal Revenue Code (IRC). The Plan's most recent restatement was effective April 1, 2024.

General

The Plan is a defined contribution plan covering substantially all employees of Umpqua Community Health Center, Inc., doing business as Aviva Health (the Employer). Employees are eligible for elective deferrals immediately. Employees are eligible for non-elective Employer contributions after completing three months of service with at least one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute pre-tax and Roth amounts withheld from compensation, as defined by the Plan, up to the limits provided by the Internal IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer made a matching contribution, equal to a participant's elective deferrals up to a maximum of 3 percent of eligible compensation, for the years ended June 30, 2024 and 2023. Participants must defer at least 3 percent of eligible compensation for the Plan year in order to receive a matching contribution. The Employer may also make discretionary contributions allocated to eligible participants pro-rata based on compensation. No such contributions were made in 2024 or 2023. Contributions are subject to certain Internal Revenue Service limitations.

Effective February 1, 2024, the Plan was amended to include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3 percent of eligible compensation.

Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their employee deferral and rollover contributions, plus actual earnings thereon. Vesting in the Employer's contributions is based on years of service. Employer contributions vest as follows:

Forfeited Accounts

Amounts that are not fully vested when participants terminate from the Plan are forfeited when the participant takes a distribution of their remaining vested balance. These amounts are used to pay Plan administrative expenses or offset future Employer contributions. During the years ended June 30, 2024 and 2023, \$30,004 and \$9,882, respectively, were forfeited from participant accounts. At June 30, 2024 and 2023, unused non-vested forfeitures totaled \$-0- and \$191, respectively. During the years ended June 30, 2024 and 2023, the Plan used \$19,234 and \$18,765, respectively, of forfeitures to reduce the employer's contributions and \$10,926 and \$4,490, respectively, to pay administrative expenses.

Payment of Benefits

Upon retirement, disability, death, or termination of employment, a participant or their designated beneficiary may elect to receive the vested value of their account in a lump-sum payment. Participants age 65 or older may take in-service distributions of all or part of their account balance at any time. Effective April 1, 2024, participants age 59.5 or older may take in-service distributions. Withdrawals from the Plan may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan.

Participant Loans

The Plan does not permit participants to borrow from their account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive insurance contracts, are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements. The Plan's investments in benefit-responsive fixed annuity contracts and guaranteed options is carried at contract value, which represents invested principal plus credited interest. See Note 4 for a discussion of investment contracts.

Investments held by plans qualified under Section 403(b) of the IRC are limited to registered investment companies (mutual funds) and fixed or variable annuity contracts.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is stated on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by Plan assets or may be paid from the balance of available forfeitures or by the Employer at the election of the Plan Administrator. Expenses paid by the Employer are excluded from these financial statements. Investment advisory fees are reported as a reduction to investment income. Other investment related expenses are included in net change in fair value of investments.

Recent Accounting Standard Adopted

On July 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments, and all related amendments* (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant deferral contributions receivable.

The Plan adopted ASC 326 effective July 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 4. Investment Contracts

The Fixed Account Plus is a fixed rate annuity contract guaranteed by The Variable Annuity Life Insurance Company (VALIC) which provides a guarantee of principal and a guaranteed minimum rate of interest for the life of the contract of no less than 1 percent. The crediting rate at June 30, 2024 and 2023 was 3.15 percent and 3.0 percent, respectively. This contract will be transferred to Principal Life Insurance Company over a 5-year period.

4. Investment Contracts, continued

The Plan also has a fully benefit-responsive guaranteed option contract with Principal Life Insurance Company (Principal) valued at contract value. This is a guaranteed general-account backed group annuity contract, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. All assets in the guaranteed option are credited with interest using a declared monthly rate determined by Principal and stated in advance. There is no specific portfolio of assets in which the fund invests. At June 30, 2024 and 2023, the rates of interest contractually guaranteed were 5.15 and 4.85, respectively.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable. There is no charge for cash surrender or withdrawals. The contracts are considered fully benefit-responsive and are reported at contract value.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer contributions.

6. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS. The Plan is required to operate in conformity with Section 403(b) of the IRC to maintain the tax-exempt status for Plan participants.

The Plan has adopted a volume submitter 403(b) Plan sponsored by Northwest Retirement Plans, Inc. The Plan obtained its latest opinion letter on March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

Registered Investment Companies - Quoted market prices are used to value each fund based on the net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are deemed to be actively traded. These funds are required to publish their daily NAV and to transact at that price and are considered to have a readily determinable fair value.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by various fund companies. Fees incurred by the Plan for investment management services are included in net change in fair value of investments. During the years ended June 30, 2024 and 2023, the Plan made a direct payment to VALIC for recordkeeping services in the amount of -\$0- and \$11,386, respectively. Additionally, during the years ended June 2024 and 2023, the Plan made a direct payment to an affiliate of Principal Trust Company for recordkeeping services in the amount of \$25,261 and \$10,636, respectively. The Employer pays directly any other expenses or fees related to the Plan's operations. These transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules of ERISA.

10. Non-exempt Transactions

For the years ended June 30, 2024 and 2023, participant contributions totaling \$3,135 and \$63,325, respectively, were not remitted to the Plan within the appropriate time period by the Employer, totaling \$66,460 at June 30, 2024. These transactions constitute prohibited transactions as defined by ERISA. The Employer is taking the appropriate steps to correct the situation by reimbursing employees for lost earnings and interest subsequent to Plan year-end, and will further implement a procedure to ensure that all future remittances are made within the prescribed time period.
