Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Amsterdam Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 7, 2024 (liquidation basis) and December 31, 2023 (ongoing basis), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through October 7, 2024 (liquidation basis), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from the qualified institution as of October 7, 2024 and December 31, 2023, and for the period from January 1, 2024 to October 7, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by the qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As further discussed in Note 1 to the financial statements, the Board of Directors of the Plan approved a plan of liquidation on August 15, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

1. Description of Plan

The following summary of certain provisions of the Amsterdam Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Effective August 15, 2024, the Board of Directors approved a resolution to terminate the Plan. As of October 7, 2024, all assets of the Plan were distributed directly to the participants or through an annuity purchase. As a result, the Plan terminated October 7, 2024.

The Plan is a noncontributory defined contribution pension plan covering all eligible employees for the following controlled group of employers (collectively known as Employers):

- Amsterdam Nursing Home Corporation (1992)
- Amsterdam Continuing Care Health System, Inc.
- Amsterdam Services Corp (2001).
- Amsterdam House Continuing Care Retirement Community, Inc.

The Plan covers all non-union employees who have completed 1,000 hours in the previous year of service and are age twenty-one or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Assets Held for Investment

All plan assets are held with Lincoln Financial Group Trust Company, Inc. (“Lincoln” or the “Trustee”). Among other duties, Lincoln is responsible for the custody of the Plan’s assets and for the payment of benefits to eligible participants. Plan contributions are invested in certain funds offered by Lincoln as designated by the Plan participants.

Contributions

The Employers may determine an annual contribution-based percentage of the salaries of qualifying employees. In 2024, there was no Employer contribution made to the plan. Contributions are subject to certain limitations of the Internal Revenue Code (“IRC”) Section 415(c)(3). “Base salary” consists of total pay, excluding overtime, bonuses, shift differential and commissions. Employee contributions are not permitted by the Plan.

Participant Investment Account Options

Investment account options available include a fixed income annuity contract and mutual funds. Each participant has the option of directing contributions into any of the investment account options selected by the Sponsor and may change the allocation at any time.

1. Description of Plan (*continued*)

Participant Accounts

Each participant's account is credited with an allocation of the Employers' contributions and plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings of account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting is based on years of continuous service. A participant is 20 percent vested after one year of service, with an increase of 20 percent each year for the next four years.

Payment of Benefits

Upon becoming eligible to receive benefits, the distribution of benefits can be in the form of a single lump-sum payment or a direct rollover.

Administrative Expenses

Administrative expenses may be paid by the Employers or the Plan, at the Sponsor's discretion. Investment related expenses are included in net appreciation in fair value of investments.

Plan Expense Account

The Plan and Lincoln Retirement Services Company, LLC ("LRSC") have entered into a revenue sharing arrangement whereby a portion of the revenue earned by LRSC from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive revenue as a result of this arrangement, and to use the revenue to pay Plan expenses, A Plan Expense Account was setup under the Plan, similar in design to forfeiture accounts, associated with plan administration. The Plan Expense Account balance was \$0 and \$41 at October 7, 2024 and December 31, 2023. For the period from January 1, 2024 through October 7, 2024, \$18,022 from the Plan Expense Account was used to reduce administrative expenses incurred by the Plan.

Forfeitures

When a participant terminates, the nonvested portion of their account, as defined by the Plan, is forfeited. Forfeitures are utilized to pay administrative expenses and then used to reduce the Employers' contributions. At October 7, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$9,297. During the period from January 1, 2024 through October 7, 2024, forfeitures of \$10,348 were used to reduce administrative expenses incurred by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

As a result of the decision to terminate the Plan effective August 15, 2024, and in accordance with U.S. generally accepted accounting principles (“U.S. GAAP”), the Plan’s financial statements as of and for the period from January 1, 2024 through October 7, 2024, are presented using the liquidation basis of accounting. For periods prior to the decision to terminate the Plan, the financial statements were prepared using the ongoing basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. There are no material changes to the 2024 financial statements as a result of the change under the liquidation basis of accounting. The preparation of financial statements in conformity with U.S. GAAP requires the Plan sponsor or plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. These estimates are based on information available at the time the estimates are made. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As a result of the distribution of all Plan assets, no investments were held by the Plan at October 7, 2024. All investments report at fair value as of December 31, 2023 are Level 1.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value based on quoted market prices except for its fixed income annuity account, which is stated at contract value. Mutual funds are valued at the daily closing price as report by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments are recognized upon the sale of the related investments, and unrealized appreciation or depreciation is recognized at year end when the carrying values of the related investments are adjusted to their estimated fair value.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is March 7, 2025.

3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements as of October 7, 2024 and December 31, 2023, and net appreciation in value of investments, and interest and dividends for the period from January 1, 2024 through October 7, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., a qualified institution.

4. Fixed Annuity Contract with Insurance Company

The Plan invests in a fully benefit-responsive guaranteed fixed annuity contract with The Lincoln National Life Insurance Company ("LNLIC"). LNLIC maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. LNLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by LNLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

4. Fixed Annuity Contract with Insurance Company (*continued*)

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Standard & Poor's (A+ as of July 2024), Moody's Investors (A2 as of September 2024, A.M. Best (A as of February 2024) and Fitch Ratings (A+ as of July 2024).

The Lincoln Stable Value Fund is fully benefit-responsive and recorded at contract value on the statements of net assets available for benefits, which amounted to \$312,105 at December 31, 2023. The Plan was not invested in the Lincoln Stable Value Fund at October 7, 2024.

5. Party-in-Interest Transactions

The fixed income annuity investment is managed by LNLIC. LNLIC is the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the trustees for administrative expenses amounted to \$31,991 for the period from January 1, 2024 through October 7, 2024.

6. Income Tax Status

The Internal Revenue Service has determined and informed the plan document preparer by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
