Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Area Residential Care, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Area Residential Care, Inc. Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of Plan

The following description of the Area Residential Care, Inc. Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General and eligibility - The Plan is a defined contribution plan covering qualified employees of Area Residential Care, Inc. (Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (the ERISA).

Non-union employees are eligible to participate in elective contributions if they have completed two months of employment and are 21 years of age. Union employees are eligible to participate in elective contributions if they have completed one year of service with at least 1,000 hours and are 21 years of age. Employees are eligible to participate in employer contributions if they have completed one year of service with at least 1,000 hours and are 21 years of age.

Highly compensated employees, employees with the job classification of Night Monitor, and individuals, who upon being referred by a governmental agency, receive vocational rehabilitation training from the Organization for the purpose of preparing them for placement in private industry regardless of whether such individuals perform services for the Organization during the training program, are excluded from the Plan.

Entry Date - Non-union employees may enter the Plan for elective contributions on the first day of each month immediately following or coinciding with the date they satisfy the Plan’s eligibility requirements. Non-union employees may enter the Plan for employer contributions on the first day of July or January coinciding with or immediately following the date they satisfy the Plan’s eligibility requirements. Union employees may enter the Plan for all contributions on the first day of July or January coinciding with or immediately following the date they satisfy the Plan’s eligibility requirements.

Contributions - Each year, participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Elective deferrals will not be suspended on account of a hardship distribution. For the years ended June 30, 2024 and 2023, the Organization contributed 50% of the first 4% of elective deferrals that a participant contributes to the Plan. Additional amounts may be contributed at the discretion of the Organization’s Board of Directors. For the years ended June 30, 2024 and 2023, an additional discretionary contribution was made in the amount of 2% of each eligible union employee’s compensation and 3% of each eligible non-union employee’s compensation.

Participant Accounts - Each participant’s account is credited with the participant’s contributions and the Organization’s matching contributions, as well as allocations of the Organization’s discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant’s compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options - Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Note 1 - Description of Plan (Continued)

Vesting - Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of credited services as set forth in the following table:

2 years of service	20%
3 years of service	40%

6 years of service	100%

Forfeited Accounts - At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$19,695 and \$1,972, respectively. These accounts may be used to reduce the Plan's administrative expenses or future employer contributions. During the year ended June 30, 2024, administrative expenses of \$-0- and employer contributions of \$17,875 were paid from forfeited non-vested accounts.

Payment of Benefits - Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or installments as defined in the plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined in the plan document. Hardship distributions are not available to Union employees.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Note 2 - Summary of Accounting Policies (Continued)

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management Review - Management has evaluated subsequent events through February 25, 2025, the date which the financial statements were available to be issued.

Note 3 - Investments and Fair Value Measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that cannot be directly observed for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Deposit Account - Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer discretionary nonelective contributions.

Note 6 - Tax Status

The Plan has adopted a pre-approved plan document sponsored by July Business Services., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize as tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and Uncertainties

The investments of the Plan are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the value of such investments, it is reasonably possible that changes in risks in the near term could materially affect investment balances and the amounts reported in the financial statements.

Note 8 - Related-Party and Party-In-Interest Transactions

Certain Plan investments are shares of a money market deposit account managed by Dubuque Bank & Trust Co., a service provider to the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

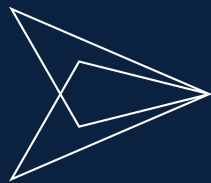
