The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other matter – supplemental schedules required by ERISA**

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (held at end of year) as of June 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

June 30, 2024 and 2023

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the San Francisco Ballet Association Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan, a defined contribution savings plan intended to qualify under Section 401(a) and related provisions of the Internal Revenue Code ("IRC") was established effective July 1, 1988. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, or financial hardship. The Plan covers all nonunion employees of the San Francisco Ballet Association (the "Organization") who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

##### **Plan Administration**

The Organization is the sponsor and administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Organization has delegated certain responsibilities for the operation and administration of the Plan. Recordkeeping services are provided by Empower Retirement (formerly Great-West Life and Annuity Company). Trustee services are provided by Empower Trust Company, LLC and Great-West Trust Company (the "Trustees"), a subsidiary of Empower Retirement. Administrative expenses are generally paid from Plan forfeitures.

##### **Contributions**

Maximum allowed deferral amount was \$23,000 and \$22,500 for calendar years 2024 and 2023. Employees over the age of 50 could also contribute an additional \$7,500 catch-up contribution to the Plan for calendar years 2024 and 2023. Participants may also elect to make Roth contributions utilizing after-tax contributions. Additionally, participants are also allowed to roll over contributions from other qualified employer-sponsored retirement plans. The Organization may elect to make a discretionary matching contribution. For the year ended June 30, 2024, the Organization elected to contribute a matching contribution equal to 50% of the first 6% of employee contributions contributed to the Plan.

The Organization also may elect to make an annual discretionary board approved contribution to eligible participants of the Plan. The discretionary contribution is an integrated allocation contribution based on a participant's compensation in excess of the taxable wage base. The Organization elected not to make a discretionary contribution for the Plan for the year ended June 30, 2024.

##### **Eligibility**

Non-union employees may begin participating in the Plan starting the first day of employment or if later, the Plan entry date which is the first day of each month. Union employees are excluded employees whose employment is governed by a collective bargaining agreement in which retirement benefits were the subject of good faith bargaining.

##### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions (including rollovers from the participant's previous plan) and (a) the Organization's matching contributions, (b) Plan earnings, and (c) the Organization's discretionary contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's contributions plus earnings thereon is based on years of continuous service, as defined. Participants are 100% vested after two years of credited service.

***Notes Receivable from Participants***

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the value of their vested account balance. General purpose loans may have up to five-year maturities, and principal residence loans may have up to 15-year maturities. The loans are secured by the balance in the participant's account and bear interest, which are commensurate with local prevailing rates at the time the loan is issued. The repayment of principal plus interest is generally required by the Plan to be made through payroll deductions. Participants may have one loan outstanding at a time. There were no outstanding loans as of June 30, 2024 and 2023.

***Payment of Benefits***

Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability, or death. In-service distributions, or distributions prior to termination of employment, are also permitted based on reaching the age of 59½. Participant account balances equal to or less than \$1,000 are distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. If the account balance is greater than \$1,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, a series of monthly annuity payments, or postpone payment to a later date and remain in the Plan as described in the Plan documents.

***Forfeited Accounts***

Forfeited nonvested accounts may be used to pay administrative expenses of the Plan or to reduce the Organization's discretionary contributions in accordance with the applicable provisions of the Plan. As of June 30, 2024, and 2023, the forfeited nonvested accounts totaled \$13,252 and \$10,279, respectively. The Organization used \$290 of forfeitures to pay administrative expenses and \$6,072 of forfeitures to reduce the Organization's matching contributions, during the year ended June 30, 2024.

***Administrative Expenses and Other Fees***

Certain administrative expenses of the Plan are paid directly by the Organization. Participants who take loans against the balance in their accounts are charged a loan fee, which is deducted from the participant's remaining accounts. Most investment options have fees which reduce the overall return on assets. The net appreciation of the investments is reflected net of these fees.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, overall market volatility, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Payment of Benefits***

Benefits are recorded when paid.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Money market funds and mutual funds are valued at the net asset value ("NAV") of shares held by the Plan at year-end. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Accounting Standards Codification 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes and ranks the level of market price observability used in measuring fair value. Market price observability is affected by a number of factors, including the type of instrument, the characteristics specific to the instrument, and the state of the marketplace (including the existence and transparency of transactions between market participants). Instruments with readily available actively quoted prices or for which fair value can be measured from actively quoted prices in an orderly market will generally have a higher degree of market price observability and a lower degree of judgment used in measuring fair value.

The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.

*Money market fund:* Valued at the NAV of units held by the Plan at year-end. The fund attempts to stabilize the NAV of its shares at \$1.00 by valuing the portfolio securities using the amortized cost method. The fund calculates a market-based NAV per share on a periodic basis. The fund does not guarantee that its NAV will always remain at \$1.00 per share. Shares can be redeemed on a same day basis from an active market, therefore, the money market fund is classified as Level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

**NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEES**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent certified public accountants not to perform any auditing procedures with respect to the following information certified by

the Trustees, except for comparing such information certified by the Trustees to information included in the Plan's financial statements and supplemental schedule.

- Investments, as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Net investment income, as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of June 30, 2024.

**NOTE 5 - PARTY-IN-INTEREST**

Certain Plan investments were held in mutual funds managed by the Trustees, or their affiliates, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for Plan administrative services and inclusive of such fees amounted to \$35,462 for the year ended June 30, 2024.

Plan participants are able to borrow from their fund accounts. There were no notes receivables from participants as of June 30, 2024 and 2023.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the full value of each participant's account shall become fully vested and nonforfeitable.

**NOTE 7 - TAX STATUS**

The Plan adopted The Great-West Trust Company Defined Contribution Prototype Plan and trust effective March 11, 2015. Effective November 16, 2021, the Plan adopted the Empower Retirement, LLC Defined Contribution Preapproved Plan and trust. The Internal Revenue Service ("IRS") issued an opinion letter dated November 14, 2022, in which it stated that the preapproved plan, as designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, that it continues to be qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress. The Plan tax returns generally remain open for IRS audit for a period of three years from the filing date.

**NOTE 8 - SUBSEQUENT EVENTS**
