INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of

Opinion

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of U.A. Local No. 355 Health and Welfare Plan (the “Plan”) are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC 820”), *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets, or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for the Plan’s investment classes are presented below.

Mutual Funds: Values are determined using quoted prices in active markets (Level 1).

Money Market Mutual Fund: The fair value of the money market mutual fund is based on the total value of all the securities held. Generally, the amortized cost approximates the current fair value. The fund seeks to maintain a net asset value of \$1.00 (Level 2).

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer contributions due and not paid prior to year-end are recorded as employer contributions receivable. Allowance for credit losses is considered unnecessary and is not provided. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Stop-Loss Reimbursements Receivable

Stop-loss reimbursements earned and not yet received prior to year-end are recorded as receivables.

Cash

Cash consists of monies held in demand-deposit checking accounts and money market accounts.

Benefit Payments

Benefit payments are recorded when paid.

Benefit Obligations

Claims payable and incurred but not reported were estimated by the Plan's consultant based on claims and insurance premium experience.

Accumulated eligibility credits are estimated by the Plan's consultant. The Plan provides eligibility for benefits on a skip-month basis whereby hours worked in June provide for August eligibility. In general, hours worked in excess of 140 hours per month can accumulate to a capped amount in an hour bank. Accumulated eligibility credits represent the estimated liability for future benefits based on the participants' accumulated eligibility arising from hours worked through June 30. Accumulated eligibility credits also include estimated insurance premiums and claims owed for the previous May and June work months.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in mutual funds and other investment securities. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Accounting Pronouncements

In June 2016, the FASB issued an Accounting Standards Update ("ASU") amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective July 1, 2023, using the modified retrospective approach. Upon adoption, there was no cumulative-effect adjustment to the opening balance of net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The Plan was established during 1993 as a result of collective bargaining agreements. The Plan provides medical, dental, vision, prescription drug, life, and accidental death and dismemberment benefits.

General eligibility rules under the Plan are as follows:

- a. All active employees covered by collective bargaining agreements negotiated by the union, which require standard contributions to the Plan by contributing employers.
- b. Effective with July 1, 2016, work hours, initial eligibility requires 280 hours to be worked within a consecutive six-month period. Only hours in excess of 280 will be credited to the hour-bank.
- c. Effective with July 1, 2016, work hours, an employee must work or have an accumulated hour-bank reserve of at least 140 hours each eligibility month.
- d. Effective with September 1, 2021, work hours, participants can accumulate up to four months of extended coverage. Also, any hours worked over 140 per month, will be placed in the participants hour bank account up to a maximum of 600 hours.

Medical benefits are provided directly by the Plan or through a service agreement with Kaiser Foundation Health Plan, Inc. Anthem Blue Cross provides preferred provider network services and administers claim payments. Dental benefits are provided directly by the Plan through an administrative contract with Delta Dental Plan of California. Vision benefits are provided through an insurance contract with Vision Service Plan. Life and accidental death and dismemberment benefits are provided under a group insurance policy with ReliaStar Life Insurance Company. SAV-RX provides preferred provider network services for the purchasing of prescription drugs.

The Plan does not provide benefits for retirees; therefore, no post-retirement benefit obligations exist at the financial statement date.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act ("COBRA"), has been adopted by the Plan.

Participants should refer to the Summary Plan Description and recent Plan amendments for more complete information.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated May 6, 1997, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan's administrator believes that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken and has concluded that, as of the June 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by employer contributions and contributions from members electing COBRA coverage. The monthly contribution rate is specified in the collective bargaining agreements.

6. DUE TO OTHER ENTITIES

Contributions made by employers are initially received into a cash transit account that is owned by this Plan. Contributions due to this Plan, as well as to numerous other entities, are received into the transit account. Monthly contributions received are reconciled to remittance transmittals and are allocated to each entity. At the beginning of the following month, transfers are made out of the transit account to each entity's cash account for contributions received on their behalf during the previous month. As of June 30, 2024 and 2023, approximately \$91,400 and \$104,300 respectively, which was due to the other entities, was held in the transit account.

The Plan has significant cash balances at financial institutions which throughout the year regularly exceed the federally insured limit of \$250,000. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations, and cash flows.
