Opinion

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements for the Retired Machinist's Health Plan (the "Plan") are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General - Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ASC 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods - In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan's investment classes are presented below.

Mutual Funds: The Plan's mutual funds are valued using quoted prices in active markets (Level 1).

Money Market Fund: The fair value of the money market fund is based on the total market value of the securities held using the amortized cost method. The fund seeks to maintain a net asset value of \$1.00 (Level 2).

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions

Effective December 1, 2020, the Board of Trustees (the "Trustees") approved ending the retiree subsidy program thereby ending the employers' obligation to contribute to the Plan.

Participant Contributions

Participant contributions are recognized as income in the same month as benefit coverage is provided.

Deferred Revenue

Contributions from certain participants received in August and prior months, for eligibility in September and subsequent months, are recorded as deferred revenue.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations. Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Benefit Obligations

Premiums payable were calculated based on actual premiums paid subsequent to year-end for August and prior eligibility.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in mutual funds and a money market fund. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Accounting Pronouncements Currently Adopted

In June 2016, the FASB issued an Accounting Standards Update ("ASU") amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effect September 1, 2023, using the modified retrospective approach. Upon adoption, there was no cumulative-effect adjustment to the opening balance of net assets available for benefits.

2. DESCRIPTION OF THE PLAN

CMTA-IAM Joint Retiree Health & Welfare Trust (the "Trust") was created to administer health and welfare benefits to retired employees of employers in the California Metal Trades Industry. The Trust provides these benefits through the administration of the Plan. The Trust and the Plan are subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

To be eligible for Plan benefits, retirees must be receiving a pension from the Automotive Industries Pension Fund or other plans approved by the Trustees. Effective January 1, 2016, to be eligible for Plan benefits, retirees must have retired under a collective bargaining agreement with District Lodge 190, and (a) are receiving benefits from the Automotive Industries Pension Fund or IAM National Plan, or (b) are at least 55 years of age and make the proper self-payment for coverage. In addition, retirees may not enroll in the Plan both as a retiree and as a dependent and will not be allowed to re-enroll for coverage under the Plan once the coverage has been canceled. Participants in the Plan receive benefits through service agreements with Kaiser Foundation Health Plan, Inc.; United Healthcare Insurance Company; or Health Net. All other benefits are paid out of the assets of the Plan. Dependents receive the same coverage as retirees.

Benefits are funded by contributions from monthly co-payments from retirees. Retiree benefits are not prefunded or vested. Retiree coverage shall be limited to funds available for retiree benefits, as determined by the Trustees. If contributions are inadequate to maintain retiree benefits, the Trustees have the right to reduce benefits and/or increase co-payments or to terminate coverage. Effective December 1, 2020, the Board of Trustees approved ending the retiree subsidy program, therefore, retirees are responsible for the entire health care cost.

Effective January 1, 2012, the Trustees approved implementation of Health Reimbursement Accounts ("HRAs") for eligible Plan participants, which are funded by employer contributions. Each individual account is credited a set amount every six months. Each individual has a "benefit card" that contains their HRA balance and can be used to pay for qualified medical expenses. HRA balances are forfeited the month following termination. The Trustees approved ceasing funding of the HRA program effective December 1, 2020. The final funding to the HRA program was made on July 1, 2020. This program may be terminated by the Trustees at any time, in which event, the HRAs would revert to the general assets of the Plan.

The following summarizes the activity, rounded to the nearest \$1,000, in the HRA accounts for the years ended August 31, 2024 and 2023 which is included in the accompanying financial statements:

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated February 24, 1967, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related Trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of August 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. FUNDING POLICY

The Plan is financed by contributions from participants. The contribution rates are established annually by the Trustees, based in part upon studies and recommendations by the Plan's consultant, subject to the terms of the applicable collective bargaining agreements. Effective December 1, 2020, the Board of Trustees approved ending the retiree subsidy program, thereby ending the employers' obligation to contribute to the Plan.

6. CASH CONCENTRATIONS

The Plan places its cash with financial institutions. The balances are insured by the Federal Deposit Insurance Corporation ("FDIC") for up to \$250,000 per institution. Cash balances regularly exceeded the insured deposit limits. Cash at August 31, 2024 and 2023, consisted of the following:

8. RELATED-PARTY TRANSACTIONS

Certain members of the Plan's Board of Trustees are also members of the Boards of Trustees of Automotive Industries Pension Plan, Automotive Industries Individual Account Retirement Plan, Automotive Industries Welfare Plan, Automotive Industries Apprentice Fund, and Machinists Retiree Health Investment Plan.

Certain participant contributions for the Plan are withheld from the pension benefit checks paid by the Automotive Industries Pension Plan (the "Pension Plan"), which are then transferred to the Plan on a monthly basis. During the years ended August 31, 2024 and 2023, the Pension Plan withheld and transferred to the Plan approximately \$1,924,000 and \$1,993,000, respectively. As of August 31, 2024 and 2023, \$640,992 and \$334,791 were due from the Pension Plan, respectively.

In addition, the Plan shares certain operating expenses with the plans listed above. As of August 31, 2024 and 2023, the Plan's amount due to the related plans totaled \$66,293 and \$39,486, respectively.
