Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that,

individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule of Assets (Held at End of Year) as of June 30, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was

derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of Diversified Family Services (Organization) Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Organization is a Pennsylvania non-profit organization formed to provide a variety of professional human services and support which strengthen families. The Plan was established for the purpose of providing retirement benefits to the employees of the Organization. The accompanying financial statements include only the activity and financial position of the Plan and are not intended to reflect the Organization as a whole.

General

The Plan is a defined contribution plan covering substantially all hourly and salaried employees of the Organization. The Plan was established April 1, 1995 and restated on July 1, 2021. No eligibility or benefit changes occurred as a result of the plan restatement. As part of the restatement, the Organization made The Fiduciary Studio LLC as the ERISA 3(16) Administrator. Under this Agreement, the 3(16) Administrator will perform some, but not all, of the fiduciary duties charged to the Plan Administrator under ERISA. The Organization retains the fiduciary duty of providing complete and accurate data, material, documents, and other information to The Fiduciary Studio LLC, as well as selecting responsible Plan vendors.

Eligibility

A person becomes eligible to make elective deferrals to the Plan and to participate in the employer discretionary contribution upon becoming employed by the Organization and attaining one year of service or 1,000 hours. Entry dates for contributions are the first day of the first month or the first date of the seventh month of the Plan year.

Contributions

Participants may elect to contribute to the Plan, on a salary-deferral basis, the maximum amount of their pretax compensation permitted by law. Participants may contribute 100%

of their compensation subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Organization's contribution is discretionary, determined annually, and approved by the Organization's Board of Directors. The Organization's discretionary contributions are allocated based on a percentage of compensation to participants. The employer discretionary contribution for the years ended June 30, 2024 and 2023 was \$265,000 and \$335,000, respectively.

Participant Accounts

Participants direct the investment of their contributions and the Organization's contributions into various investment options offered by the Plan.

Each participant's account is credited with any salary deferral contributions, an allocation of the Organization's discretionary contributions, Plan earnings and losses, forfeitures, and administrative expenses. Allocation of the Plan's earnings and losses are based on the proportion that each participant's account bears to the total of all participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their elective deferral contributions plus actual earnings thereon. Plan participants become fully vested in employer discretionary contributions according to the vesting schedule below or at the earliest of the following dates: a) the date of the participant's death, or b) the date the participant incurs total disability. The vesting schedule is as follows:

Participant Loans

The Plan does not permit participants to borrow from their accounts.

Benefit Payments

Plan benefits are generally paid to participants at retirement, death, or disability. Normal retirement is at age 65; however, participants may take in-service distributions when they are 59.5 years old. The Plan also permits participants to take hardship distributions as defined by the Plan and applicable federal regulations. Participants or their beneficiaries may elect to receive an amount equal to the value of the participant's account in either a lump sum amount or in annual installments over a fixed period of time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participant account balances that do not exceed \$5,000 are distributed in a single lump-sum payment.

Forfeited Accounts

If a participant is not vested upon termination, the nonvested portion of their account balance contributed by the employer and the earnings thereon are forfeited. Forfeited amounts are re-allocated to the account balances of the remaining participants. At June 30, 2024 and 2023, forfeited amounts of \$0 and \$26,498, respectively, were re-allocated to remaining participants.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts,

because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are included in the financial statements at fair value as of June 30, 2024 and 2023, except for fully benefit-responsive investment contracts, which are reported at contract value.

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining fair value, the Plan considers the principal and most advantageous market in which it would transact and considers the assumption that market participants would use when pricing the asset or liability.

The cost of investments sold or distributed is determined using the specific identification method. Investment purchases and sales of securities are accounted for on a trade-date basis. Interest and dividends are recorded when earned.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Investment Management Fees and Operating Expenses

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as

a component of net appreciation (depreciation) in fair value investments in the accompanying statements of changes in net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of June 30, 2024 and 2023.

Administrative Expenses

Certain administrative and recordkeeping expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. At any time, the Plan may elect to have all such expenses paid by the Plan participants.

Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than quoted market prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable for the asset or liability and can be corroborated by observable market data for substantially the full term of the asset or liability.

Level 3 – Inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in methodologies used at June 30, 2024 and 2023.

Mutual funds are valued at the closing price reported on the active market on which the individual securities are traded.

4. Interest in Investment Contracts

The Plan has a group annuity contract with the Great-West Fixed Account – Series Class I (administered by Empower). Under the terms of the contract, Plan assets are held in the guaranteed investment accounts. The guaranteed investment accounts are credited with earnings and charged for Plan withdrawals and administrative expenses charged by Empower. While the contracts are in place, Empower are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, the contract, which is fully benefit-responsive, is included in the financial statements at contract value when held. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at June 30, 2024 and 2023 was \$67,892 and \$63,761. If the contract is surrendered completely, a market value adjustment may be applied to the balance in the general account.

The crediting interest rate and effective annual yield was 1.00%, 1.05%, 1.15%, 1.20%, 1.25%, 1.30%, 1.35%, and 1.40% from July 1, 2022 through September 30, 2022, October 1, 2022 through December 31, 2022, January 1, 2023 through March 31, 2023, April 1, 2023 to June 30, 2023, July 1, 2023 through September 30, 2023, October 1, 2023 through December 31, 2023, January 1, 2024 through March 31, 2024, and April 1, 2024 through June 30, 2024, respectively. The crediting interest rate is reset by Empower on a quarterly basis. Changes in future interest crediting rates will not affect the amount reported on the statements of net assets available for benefits.

Empower is responsible for maintaining the balances due to each of the eligible participants in the Plan. The net assets available for benefits include assets available to current eligible employees as well as terminated employees who have not yet been paid their benefit by the Plan. Empower is also responsible for the proper payouts of benefits to eligible terminated employees per the terms of the Plan documents.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3)

transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff, or the sale or discontinuance of all or any part of the Plan sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification.

5. Certification of Financial Information by the Plan's Custodians

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net (depreciation) appreciation in fair value of investments and dividends and interest for the years ended June 30, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian of the Plan, Empower Trust Company, LLC.

6. Income Tax Status

The Plan is a non-standardized Pre-approved plan. The Pre-approved plan received an opinion letter from the Internal Revenue Service on June 30, 2020 that stated that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Further, the Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

7. Related-Party and Party-In-Interest Transactions

Certain Plan investments are managed by the custodians or third-party administrator. Empower Trust Company LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as related party-in-interest transactions. Fees paid by the Plan for custodian and recordkeeping services were \$3,305 and \$4,879 for the years ended June 30, 2024 and 2023, respectively. The Organization provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Although it has not expressed an intent to do so, Diversified Family Services (Organization) has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

11. Subsequent Events

Subsequent to year-end, the Organization amended their Plan to allow for in-service distributions at the attainment of normal retirement age if the participant is 100% vested in the source from which the withdrawal is taken effective August 19, 2024 and to exclude catch-up contributions effective October 21, 2024.
