### 1. Description of Plan

The following description of Instapage 401(k) Plan (the Plan) provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering eligible employees who are employed by Instapage, Inc. (the Company) and have attained 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

airSlate, Inc. adopted the Instapage 401(k) Plan effective January 1, 2024. Effective March 1, 2024 the Plan merged with the airSlate 401(k) Plan. All Plan assets were transferred to the airSlate 401(k) Plan by November 25, 2024.

#### Contributions

Each year, participants may contribute pre-tax and Roth deferrals up to 100% of eligible annual compensation, as defined and subject to certain limitations under the Internal Revenue Code (IRC). The Plan includes an automatic enrollment provision whereby all eligible employees are automatically enrolled at 3% of pre-tax annual compensation unless they elect otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans, as defined. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for discretionary Company profit sharing contributions, none of which were made for the period ended November 25, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Company's profit sharing contribution, if any, and Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable from Participants

Participants are permitted to have one loan outstanding at any time and may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Loan terms can range from one to five years. For the purchase of a primary residence, the plan administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear interest at a fixed interest rate of the Prime rate plus 1% as of the date the loan application was submitted. Principal and interest is paid ratably through payroll deductions. There were no loans issued or outstanding as of November 25, 2024 and December 31, 2023.

#### **Vesting**

Participants are vested immediately in their contributions and Company contributions, plus actual earnings thereon.

#### **Payment of Benefits**

On termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

## 2. **Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities, at the date of the financial statements. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Investments are valued daily. Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants, if any, are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of November 25, 2024 and December 31, 2023.

### **Administrative Expenses**

Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Company. Administrative expenses paid by the Company are excluded from these financial statements.

Most investment options have fees which reduce the overall return on assets. The net appreciation of investments is inclusive of these fees.

### **Benefits Payable to Participants**

Benefits are recorded when paid.

### **Subsequent Events**

The Plan has evaluated subsequent events through March 10, 2025, the date the financial statements were available to be issued.

### **3. Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes since December 31, 2023. There were no Plan assets measured at fair value at November 25, 2024.

*Mutual funds:* Valued at the quoted net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 6. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

On September 6, 2023, the Company merged with Alofi Merger Sub, Inc., a wholly-owned subsidiary of airSlate, Inc. The Company was the surviving corporation of the merger and became a wholly-owned subsidiary of airSlate, Inc. airSlate, Inc. adopted the Plan effective January 1, 2024. Effective March 1, 2024, the Plan merged with the airSlate 401(k) Plan. All Plan assets were transferred to the airSlate 401(k) Plan by November 25, 2024.

#### 7. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan, which received a favorable advisory letter dated November 18, 2020, stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

#### 8. Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by the custodian. Benefit Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid by the Plan to the Plan recordkeeper (Guideline, Inc.) and the custodian totaled \$1,032 for the period January 1, 2024 through November 25, 2024.


