### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Tustin Group 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the three months ended March 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. DESCRIPTION OF PLAN**

The following description of The Tustin Group 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information of the Plan's provisions.

**Plan Termination and General**

The Tustin Group was acquired by Astra Service Partners, LLC in August 2023. The Astra Service Partner's retirement plan is part of the Orion Group 401(k) Retirement Plan. All the Plan's assets were distributed according to participant elections in March 2024. Plan assets were distributed by March 28, 2024 and were transferred into the Orion Group 401(k) Retirement Plan.

The Plan was a defined contribution plan established January 1, 1994 covering employees of Tustin Mechanical Services (the Company). Effective January 1, 2019, the eligibility for the Plan was employees who have completed 1,000 hours of service in a twelve month period, and reached age eighteen or older. The employee could enter the Plan on the first day of the month following the date that the eligibility requirements are met. The Company was a member of a controlled group and the affiliated employers have adopted the Plan as participating employers. The participating employers were Tustin Mechanical Services, LLC, Tustin Water Solutions, LLC, Tustin Energy Solutions, LLC, Tilley Fire Equipment Company, and Tustin Security Solutions, LLC (together, the Company). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year participants could have contributed a percent of pretax annual compensation, as defined in the Plan, subject to limitations imposed by the Internal Revenue Code. The Plan also allowed elective deferral contributions to be made as Roth contributions. The Plan included an auto-enrollment provision whereby all eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation for the first two plan years, increasing 1% each year thereafter up to a maximum of 6%. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed their accounts into various investment options offered by the Plan. The Plan was a safe harbor plan. The safe harbor company matching contribution was 100% of the first 1% of contributions to the Plan and then 50% of the next 5% of contributions. The safe harbor contributions and Plan earnings thereon were fully vested, and allowed the Plan to maintain "safe harbor" status. Contributions were subject to certain limitations. The Plan adopted an amendment during 2024 to terminate the Safe Harbor feature, but continued contributions at the same formula for the regular match.

In addition to the safe harbor matching contribution, the Company each year could elect to make a discretionary contribution to the Plan's profit sharing feature at the option of the Company's Board of Directors. For the three months ended March 31, 2024 and the year ended December 31, 2023, the Company did not elect to make a discretionary contribution.

**1. DESCRIPTION OF PLAN (continued)**

**Participant Accounts**

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants were immediately vested in their contributions and the employer safe harbor match plus actual earnings thereon. Vesting in the Company's discretionary contributions was based on years of continuous service. A participant was fully vested in the discretionary profit sharing after six years of service. Participants were fully vested upon retirement, disability, death or termination of the Plan.

**Notes Receivable from Participants**

Participants could borrow from the vested portion of their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balance, whichever is less. Loan terms ranged from one to five years. A participant was allowed to have up to two loans at a time. The loans were secured by the balance in the participant's account and bared interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest were paid ratably through payroll deductions.

**Payment of Benefits**

The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account. For termination of service due to death, disability or retirement (age 65), a participant could have received the value of the vested interest in his or her account as a lump-sum distribution. If a participant terminated employment and the participant's account balance was never greater than \$5,000, the Plan Administrator could authorize the benefit payment without the participant's consent. Participants were entitled to receive in-service distributions of their salary deferral account once they attained age 59½, and of their employer contribution account once they attained age 65. The Plan provided for hardship withdrawals under the provisions of the Internal Revenue Code.

**Forfeitures**

The non-vested portion of accounts of participants who terminate employment could be applied to reduce the employer's matching contribution. The amount of unallocated forfeitures as of March 31, 2024 and December 31, 2023, was \$0 and \$2,126, respectively. No forfeitures were used to reduce employer contributions during the three months ended March 31, 2024.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes capital gain dividends and the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

**3. FAIR VALUE MEASUREMENTS**

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described below.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2024 and December 31, 2023.

*Interest Bearing Cash:* Valued at the quoted prices for similar assets in active markets.

*Insurance Company General Accounts:* Valued using inputs other than quoted prices that are observable for the asset or liability.

*Registered Investment Companies (Mutual Funds):* The account value is based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan's federal Form 5500, *Annual Report of Employee Benefit Plan*, for the previous three years remains subject to examination by the Internal Revenue Service.

**8. DELINQUENT PARTICIPANT CONTRIBUTIONS**

In October 2024, it was discovered that the Plan did not remit several deferral contributions timely into the participant accounts in 2023. This was corrected in December 2024. The approximate amount of lost earnings owed to the Plan was \$1,895. The plan corrected these delinquent contributions outside of the voluntary fiduciary correction program (VFCP).

In September 2023, it was discovered that the Plan did not remit some deferral contributions into the participant accounts in 2022. This was corrected in September 2023. The approximate amount of lost earnings owed to the Plan is \$81. The plan corrected these delinquent contributions outside of the VFCP.
