I was unaware that I needed to file a Form 5500 in 2023. I incorrectly presumed that since the business had closed in 2021 and I had filed a plan termination notification with the ABA Retirement Funds Program (which they confirmed), that no further filings were necessary. Had I known a final Form 5500 showing a \$0.00 balance was needed, I certainly would have filed it timely. I am happy to provide any other information required.

Please accept this explanation, our apologies and our request for an abatement of all accrued DOL and IRS penalties.
