## **1. Description of Plan**

The following description of the Constantia Flexibles America Company 401(k) Plan (the “Plan”) provides only general information. Participants may refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan, which provides retirement benefits to full-time employees of Constantia Blythewood, LLC, Constantia Colmar, LLC, Constantia Flexibles Sales, LLC, and Constantia Flexibles America Company (collectively the “Company”) who meet the eligibility requirements of the Plan as described below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan has implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the “CARES Act”), which allows certain eligible individuals to suspend required minimum distributions, and delay the commencement date for required minimum distributions. Management has retroactively adopted the required plan amendments for the remaining provisions of the CARES Act at the time of this report, which is within the IRS guidelines of the December 31, 2025 deadline.

### **Eligibility**

The Company’s employees, who are age eighteen or older, are eligible to participate in the Plan upon completion of one month of service with the Company. If an employee meets these requirements, they may enter the Plan on the first day of the month coinciding with or immediately following the date the eligibility requirements are satisfied.

### **Contributions**

Participants may contribute any percentage greater than or equal to 1% of their pretax compensation to the 401(k) portion of their account and any percentage greater than or equal to 1% of their after-tax compensation to the ROTH 401(k) portion of their account within the Plan, subject to contribution limitations specified by applicable laws and regulations. Participants may also contribute amounts representing distributions from other qualified employee benefit plans and individual retirement accounts.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three (3%) percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

**Contributions (continued)**

The Company is required, in accordance with the Plan's documents, to make safe harbor matching contributions equal to the sum of 100% of the amount of each participant's elective deferrals that do not exceed 3% of each participant's pretax compensation and 50% of the next 2% of compensation that a participant contributes to the Plan. The Company may also make either discretionary matching contributions determined as a percentage of participant salary deferrals, or discretionary profit-sharing contributions, which are contributed to eligible participants. The amounts of these contributions, if any, are determined by the Company's board of directors. There were neither discretionary matching contributions nor discretionary profit-sharing contributions for the years ended December 31, 2023 and 2022.

**Participant Accounts**

Each participant's account is credited with the participant's elective deferral contributions, the appropriate amount of employer matching contributions, if any, an allocation of the Company's discretionary contributions, if any, and an allocation of Plan's earnings or losses. Participants' accounts are charged with an allocation of administrative expenses incurred by the Plan. Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and vested after one year of service in Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's non-elective and discretionary employer contributions of their accounts is based on the following schedule:

**Investment Options**

The Plan allows individual participants, upon enrollment, to self-direct their accounts by investing in one or more of the mutual funds and a common/collective trust fund selected by the Plan administrator. Participants should refer to investment provider information for a detailed description of the Plan's investment options.

**Participant Notes Receivable**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are required to be repaid over a reasonable period of time not to exceed the earlier of five years or retirement age, unless the note is for the purpose of purchasing a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at a nondiscriminatory rate established by the Plan administrator at the time of the loan. All loans outstanding at December 31, 2023 bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. A participant may have no more than one note due to the Plan at any time. Delinquent note receivables are reclassified as participant distributions based on the terms of the Plan document.

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, participants, or their beneficiaries, may elect to receive their vested portion of Plan assets under several payout options specified in the Plan. Hardship distributions are permitted upon demonstration of financial hardship. Participants who have attained 59½ years of age are permitted to withdraw all or part of their vested accounts as in-service distributions.

**Forfeited Accounts**

Forfeitures are retained in the Plan and may be used to reduce future employer contributions. For the years ended December 31, 2023 and 2022, there were no forfeited non-vested accounts.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer discretionary contributions.

## **2. Basis of Presentation and Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States (“GAAP”).

### **Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

### **Risks and Uncertainties**

The Plan may invest in investment securities that are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that these changes could materially affect the amounts reported in the accompanying 2023 statement of net assets available for plan benefits.

### **Administrative Expenses**

The Plan pays record keeping and certain professional fees. All other professional fees are paid by the Company.

## **3. Trustee Certification**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2023 and 2022, related to investments, participant notes receivable, net appreciation (depreciation) in fair value of investments, and interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company (the “Trustee” of the Plan).

#### **4. Fair Value Measurements**

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. All of the Plan's mutual fund investments were valued using Level 1 inputs, which are based on quoted market prices of the shares held by the Plan.

The Plan's investments include the Galliard Stable Return Fund C, a common/collective trust that invests in a variety of fully benefit-responsive investment contracts. This common/collective trust is valued at the net asset value ("NAV") of units of the accounts. The NAV, as provided by the issuer, is used as a practical expedient to estimate fair value. The NAV of the account is based on the fair value of the underlying investments held less the account's liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the account, the account provider reserves the right to temporarily delay withdrawal from the account in order to ensure that security liquidations will be carried out in an orderly business manner.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in different fair values at the reporting date.

Gains and losses (realized and unrealized) included in the changes in net assets available for plan benefits are reported in the net appreciation (depreciation) in fair value of investments.

#### **5. Income Tax Status**

The Company has adopted the Plan based on a pre-approved plan document sponsored by Fidelity Management and Research Company. Fidelity Management and Research Company has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, that states that the form of the pre-approved plan is acceptable under Section 401 of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the IRS opinion letter on the pre-approved plan. The Company and the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**5. Income Tax Status (continued)**

During 2023, operational errors were discovered relating to employee contributions that resulted in an underpayment of contributions to the Plan. Management determined that the impact of the errors on the Plan's 2023 financial statements is not significant. Management determined and made the necessary corrections subsequent to December 31, 2023.

It is uncertain what impact these operational issues may have on the Plan's tax-exempt status, but the Plan administrator believes all Plan errors have been fully corrected through the IRS and DOL voluntary correction programs, and there is ultimately no threat to the Plan's tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2023 and 2022. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Party-in-Interest Transactions**

Certain Plan investments are shares of registered investment companies managed by affiliates of the trustee. Net of revenue credits, the Plan paid approximately \$39,000 and \$22,000 for record keeping and certain professional fees during the years ended December 31, 2023 and 2022, respectively.

These transactions qualify as party-in-interest transactions but are exempt from the prohibited transaction rules of ERISA.

**7. Subsequent Events**

The Plan evaluated events and transactions after December 31, 2023 through February 10, 2025, the date the financial statements were available to be issued, for subsequent events. There were no subsequent events to report.
