NOTES TO FINANCIAL STATEMENTS

DESCRIPTION OF THE PLAN

The following brief description of the Battlefield Farms, Inc. Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Effective January 2, 2024, the Trustee of the Plan determined that the Plan would be terminated due to the sale and wind down of the Plan Sponsor. The Custodian was notified on January 2, 2024. Plan management has distributed all Plan assets as of July 5, 2024.

Prior to termination, the Plan was a defined contribution plan covering all employees of Battlefield Farms, Inc. and Ultimate Transportation Logistics, LLC who had completed one year of service and were at least eighteen years of age. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan adopted certain Coronavirus Aid, Relief, and Economic Security Act (CARES Act) provisions during the 2020 plan year, and had been formally amended as of December 31, 2022.

Contributions

Each year, participants were able to contribute a percentage of their annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified plans (rollover). For the 2023 Plan year, the Company made a matching contribution of a percentage of the base compensation that each participant contributed to the Plan. No matching contributions were made for 2024. At the end of the 2023 Plan year, the Company made a discretionary contribution in the amount of \$500,000, which was held in a holding account until allocated to participants after year end. Participants directed the investment of all contributions into various investment options offered by the Plan. Participants were able to change their investment options periodically. Contributions were subject to certain IRS limitations. Contributions from Plan participants were recorded in the year in which the employee contributions were withheld from compensation.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary profit sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of a participant's account was based on a sum of periods of service. A participant was 100% vested after six years of vesting service. Additionally, upon the determination to terminate the Plan (see **General** note), participants were 100% vested.

Notes Receivable from Participants

Participants may have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at the Prime rate. Principal and interest were paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant was able to elect to receive benefits under several options as defined in the Plan. For termination of service for other reasons, a participant was able to receive the value of the vested interest in his or her account as a lump-sum distribution, if elected.

Forfeited Accounts

At July 5, 2024, there were no forfeited nonvested accounts. At December 31, 2023, forfeited nonvested accounts totaled \$41,176. These accounts were used to pay administrative expenses and allocated to participants.

SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

Due to the termination of the Plan (see **General** note), the financial statements of the Plan are prepared on the liquidation basis of accounting for the Plan year ended July 5, 2024. The financial statements of the Plan are prepared on the accrual basis of accounting for the Plan year ended December 31, 2023.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may have differed from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the **FAIR VALUE MEASUREMENTS** note for further discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the reporting period.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of July 5, 2024 and December 31, 2023.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements and these costs were not reimbursed by the Plan. Fees related to administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through March 20, 2025, which is the date the financial statements were available to be issued.

INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified by Principal Life Insurance Company (Principal), the custodian, and was not subjected to any auditing procedures performed:

- a. Total investments, as shown in the accompanying Statements of Net Assets Available for Benefits, of \$0 at July 5, 2024 and \$12,740,102 as of December 31, 2023.
- b. Net investment income, as shown in the accompanying Statement of Changes in Net Assets Available for Benefits, of \$779,848 for the period of January 1 to July 5, 2024.

FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability; and

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 5, 2024 and December 31, 2023.

Pooled separate accounts are carried at fair value. Pooled separate accounts invest in mutual funds, which provide publicly-quoted price inputs used in determining the net asset value (NAV) of the pooled separate account. The NAV of a pooled separate account is not publicly quoted but is available to current investors and plan participants. The fair value of shares of an underlying mutual fund equals the number of shares held by the pooled separate account multiplied by the closing net asset value per share quoted by the underlying fund. The NAV of the pooled separate accounts, as provided by Principal Life Insurance Company, is the basis for current transactions, and the pooled separate accounts can be redeemed at NAV as of the measurement date.

RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Company contributions to the Plan or benefits accrued or paid by the Plan for participants were not considered party in interest transactions.

The Plan allowed for transactions with certain parties who performed services or had fiduciary responsibilities to the Plan, including the Company. The Plan investments were managed by Principal Life Insurance Company. The Plan was audited by Hantzmon Wiebel LLP. Transactions with these parties qualify as party in interest transactions. Fees paid by the Plan for services provided by these parties amounted to \$54,776 for the period from January 1 to July 5, 2024.

TAX STATUS OF THE PLAN

The Plan was a non-standardized pre-approved plan and had not requested a determination letter on the adoption agreement but rather relied upon the Internal Revenue Service opinion letter dated June 30, 2020, issued on the prototype plan. Although the Plan had been amended since receiving the determination letter, the Plan Administrator believes the Plan was designed and was operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur and that such changes could have materially affected participants’ account balances and the amounts reported in the statement of net assets available for benefits.
