1. DESCRIPTION OF THE PLAN:

The following description of the Northern Ohio Laborers' Profit Sharing Annuity Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which provides benefits for eligible participants who are members of Laborers International Union of North America Laborers Local 758, Local 500, and Local 480 (Unions). Employees may enter the Plan upon completion of 100 work hours in employment for which contributions are required to be paid within a 12-consecutive month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

In accordance with the collective bargaining agreement, employers are required to make monthly contributions at a fixed dollar amount per hour based on hours worked by participants.

Vested participants may make rollover contributions from another qualified plan to their accounts. No other employee contributions are permitted.

Vesting

A separate accounting is maintained for each participant. This separate accounting includes the participant's share of the employer's monthly contribution based on hours worked, investment gains and losses, as well as administrative expenses.

Participants are 100% vested upon completion of at least 100 hours of service in a Plan year with a contributing employer, and have a balance in their account. At June 30, 2024 and 2023, non-vested forfeiture amounts totaling \$66,618 and \$3,971, respectively, were available to offset administrative expenses.

The Plan provides that when the participants reach 100 hours of service in the Plan, the participants will direct the investment of their vested balances among the investment options established as part of the overall fund. If the participant fails to make an election, his balance will be invested in a default investment model based on the participant's age. Non-participant directed accounts are not material to the financial statements.

Notes receivable from participants

The Plan was amended effective November 14, 2019 to remove the participant loan provision from the Plan. The outstanding participant loans relate to loans issued by a predecessor plan prior to the amendment. The remaining participant loans are secured by the balances in the participants' accounts and bear interest at rates fixed by the Board of Trustees at the date the loans were issued. As the loans were used to acquire the principal residence of the participant, the remaining loans have 30 year terms with the final payment due in September 2037.

1. DESCRIPTION OF THE PLAN (CONTINUED):

Benefits

Upon termination of service due to death, disability, retirement or termination of employment where benefits are vested, the participant may elect to receive one of the standard forms of payment: a joint and survivor annuity, an annuity contract, or a lump sum payment.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Employer contributions are accrued based upon employers' reporting of hours worked by participants.

Employer contributions receivable

Employer contributions receivable represents amounts due from employers that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate revenue recognition for amounts due but erroneously unreported by employers.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Employer's contribution receivable from Northwestern Ohio Administrators, Inc.

Employer's contribution receivable from Northwestern Ohio Administrators, Inc. (NWOA), administrative manager for the Plan, represent employer contributions received by NWOA and maintained in NWOA's cash concentration until such time as they are transferred to the Plan's cash account. Interest is earned on amounts maintained in the cash concentration account.

Notes receivable from participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of June 30, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be default the participant loan balance is reduced and a benefit payment is recorded.

Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent events

The Plan has evaluated subsequent events through March 10, 2025, the date the financial statements were available to be issued.

3. TAX STATUS:

The Internal Revenue Service has determined and informed the Plan by a letter dated June 15, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and related trust is tax-exempt.

4. PLAN TERMINATION:

In the event the Plan is terminated, any obligations of the Plan would be paid and all remaining net assets would be distributed to participants in the manner specified in the Plan document.

5. INVESTMENTS:

The Plan's investments are held and administered by a trustee, Empower Retirement, LLC., in an account under agreements which grant discretionary power as to investment decisions within prescribed limits designated by the Board of Trustees. All vested participants direct the investment of their account balances into options provided by the Plan's investment advisor. These options provide varying degrees of risk and expected returns. If the participant fails to make an investment election, the participant's account balance is invested in the Qualified Default Investment Alternative (QDIA).

6. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing prices as reported by the funds. The funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at cost, which approximates fair value.

6. FAIR VALUE MEASUREMENTS (CONTINUED):

7. GUARANTEED INVESTMENT CONTRACT WITH EMPOWER RETIREMENT, LLC.:

The Plan has a traditional fully benefit-responsive, guaranteed investment contract with Empower Retirement, LLC. (Empower) as an investment option of the Plan. The total amount invested in this option at contract value totaled \$3,708,616 and \$4,122,054 at June 30, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a semi-annual basis for resetting.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

7. GUARANTEED INVESTMENT CONTRACT WITH EMPOWER RETIREMENT, LLC. (CONTINUED):

The contract meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without consent of the issuer.

8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

This Plan is related through common management and trustees with NWOA which provides administrative services to the Plan. Included in the statements of changes in net assets available for benefits are gross administrative fees charged by NWOA.

The Plan pays fees for several arrangements with service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
