INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
CBP Recyclers Profit Sharing Plan

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the CBP Recyclers Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of June 10, 2024 and December 31, 2023, the related Statement of Changes in Net Assets Available for Benefits for the period ended June 10, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure Under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure Under ERISA (qualified institution).

Management obtained a certification from a qualified institution as of June 10, 2024 and December 31, 2023 and for the period ended June 10, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

NOTE 1 DESCRIPTION OF PLAN

The following description of the CBP Recyclers Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a multiple employer defined-contribution plan sponsored by Penn Recycling, Inc. All employees of the participating employers in the Plan, which comprise Penn Recycling, Inc.; Baltimore Scrap Corp.; Coatesville Scrap Iron and Metal Co., Inc.; Union Scrap Processing, Inc.; Union Transportation, LLC; Rubicon Recycling Inc.; Valley Recycling, LLC; American Recycling, LLC; Madison Salvage and Recycling, LLC; Canton Metal Recycling, LLC; Metaltech Recycling LLC; Pick-N-Pull of Auburn, Inc.; JKLM Corp.; and Clear Salvage, LLC (collectively referred to as the Company), who complete six months and 500 hours of service and who are at least 21 years old, other than those whose employment is governed by a collective bargaining agreement, are eligible to participate in the Plan. For purposes of participation, the entry date for eligible participants is the first day of the quarter in the Plan year coinciding with or following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In 2023, the Plan sponsor was acquired by a subsidiary of Sims Metal. Participants had the option to rollover their account balances into the acquiring company's 401(k) plan or receive another form of distribution. Effective June 10, 2024, the Plan was terminated.

PARTICIPATING EMPLOYERS

The Plan provides for participation by companies outside the controlled group of Penn Recycling, Inc. Each participating employer is required to use the same Custodian as provided by the Plan. The transfer of any participant among any participating employer does not affect the rights of the participant under the Plan. Any participating employer shall be permitted to discontinue or revoke its participation in the Plan at any time.

CONTRIBUTIONS

Participants may make before-tax contributions, not to exceed Internal Revenue Code limitations. The Plan permits rollover contributions from other qualified retirement plans.

The Company provides a matching contribution that matches 50% of each participant's salary deferral contribution up to a maximum of 6% of each participant's eligible compensation.

The Company may elect, at its sole discretion, to make additional profit-sharing contributions. The Company made no additional contributions for the period January 1, 2024 to June 10, 2024 and for the year ended December 31, 2023.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, the Company's matching and discretionary contributions, and an allocation of any Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants invested in life insurance policies are charged for their portion of insurance premiums. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

VESTING

Participants are immediately vested in their voluntary contributions. Vesting in the Company's matching and profit-sharing portion of their accounts is based on years of credited service and a graded vesting schedule, with 100% vesting after six years of credited service, retirement, disability (as defined by the Plan), or death.

INVESTMENT OPTIONS

Upon enrollment in the Plan, participants may direct their contributions to specified investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

PAYMENT OF BENEFITS

Upon termination of service, a participant is entitled to receive a lump-sum amount equal to the vested option of the participant's account.

FORFEITED ACCOUNTS

There were no forfeited non-vested accounts at June 10, 2024, and forfeited non-vested accounts totaled \$8,579 at December 31, 2023. Forfeitures, when available, will be used to pay Plan expenses. Any remaining forfeitures will be used to reduce the Company's matching

contributions. During the period ended June 10, 2024, \$8,958 was used to offset administrative fees, and no forfeitures were used to reduce the Company's matching contributions.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

ACCOUNTING STANDARDS CODIFICATION

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

BASIS OF ACCOUNTING

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

VALUATION OF INVESTMENTS

Investments are stated at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Summary Plan Description.

RISK AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through March 17, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan's investments were held by the Custodian, Voya Retirement Insurance and Annuity Company, at June 10, 2024 and December 31, 2023 and for the period from January 1, 2024 to June 10, 2024. Financial information related to investments in pooled separate accounts and investments at contract value included in the accompanying financial statements is based on information certified as complete and accurate by the Custodian. The 2023 information, which was not audited by the Plan's independent auditors, is summarized below:

NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Market Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Codification are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at June 10, 2024 and December 31, 2023.

Pooled Separate Accounts: This investment is valued using the net asset value (NAV) per unit. NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

Life Insurance Policies: This investment is not actively traded, and significant other observable inputs are not available. The life insurance policies are valued at their cash surrender value, which approximates fair values based on unobservable inputs using valuation methodologies to determine fair value including discounted cash flows or other simulated techniques.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 GUARANTEED INVESTMENT CONTRACT

The Plan has an investment in the Voya Fixed Account, which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by the Custodian, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with the Custodian. Such events include the following: (a) amendments to the Summary Plan Description (including

complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the Custodian to terminate the agreement prior to the scheduled maturity date.

NOTE 6 **TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with Section 401 of the Internal Revenue Code. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of June 10, 2024.

NOTE 7 **RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Custodian of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management fees, administrative fees, and custodial fees to parties in interest. The Plan paid approximately \$13,700 to parties in interest for the year ended June 10, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
