Opinion

Notes to Financial Statements

1. Description of the Plan

The following brief description of the 401(k) Savings Plan for Peter Marino Architects (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan and was adopted by Peter Marino Architect, PLLC (the Company or Employer) to provide deferred tax benefits, savings, and Company contributions to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan, adopted by the Company effective July 1, 1988, was restated on January 1, 2016.

Eligibility

The Plan covers all employees, exception union employees and non-resident aliens, who are at least 18 years of age and who have completed one year of service with 1,000 hours. Upon meeting eligibility requirements, employees may become Participants on the first day of each Plan year and the first day of the fourth, seventh and tenth months of each Plan year.

Participant Contributions

Participants may elect to contribute, on a pre-tax basis, up to 100% of their eligible compensation, as defined by the Plan, through payroll deductions, not to exceed the limit under the Internal Revenue Code (IRC). In addition, eligible Participants are permitted to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Company Contributions

The Company provides a matching contribution equal to 50% of the first 6% of the Participant's eligible compensation. The Company may also make discretionary nonelective contributions on an annual basis. To receive an allocation of such contributions, a Participant generally must be employed on the last day of the Plan year or have earned at least 500 hours of service during the Plan year. There were no discretionary nonelective Company contributions for the 2019 Plan year.

Participant Accounts

Each Participant's account is credited with the Participant's salary deferral contributions, and any Company contributions, and his/her share of the Plan's income (loss). The Plan's income (loss), with respect to each investment fund, is allocated based on the proportion that each Participant's account balance invested in such fund compared to the total of all Participants' account balances invested in such fund. All investments are participant directed.

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from Participants are secured by the balance in the Participant's account and bear a rate of interest equal to the prime rate plus 1%. Principal and interest payments occur ratably through regular payroll deductions over a period not to exceed five years or ten years for the purchase of a primary residence. Participants are only allowed to have one loan outstanding at a time.

1. Description of the Plan (cont.)

Vesting

Participants are immediately vested in the value of their salary deferrals and rollovers, as well as any discretionary nonelective Company contributions, plus related investment earnings (losses). Company matching contributions vest 20% after 1 year of service and 20% per year in each of the subsequent three years and are 100% vested after five years of continuous service.

Payment of Benefits

Participant accounts may be withdrawn upon retirement, death, disability, or termination of employment. Participants may elect to have distributions paid in a lump-sum and are either paid directly to the Participant or rolled over to another qualified retirement plan. Installments are permitted only for required minimum distributions or upon retirement. The Plan also allows for in-service withdrawals upon attaining age 59½, along with withdrawals in the event of a financial hardship.

Plan Expenses

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Plan administrator. These expenses may include, but are not limited to, legal fees, accounting fees, recordkeeping fees, investment related expenses and other fees for services provided to the Plan.

Forfeitures

The Plan allows forfeitures to be used to reduce Company contributions or pay Plan expenses. At December 31, 2019 and 2018, there was \$34,099 and \$26,699 of forfeited non-vested account balances, respectively. During the year ended December 31, 2019, no forfeitures were used.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income (Loss) Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for information on fair value measurements.

2. Summary of Significant Accounting Policies (cont.)

Investment Valuation and Income (Loss) Recognition (cont.)

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income (loss) is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan Participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2019 and 2018. If a Participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to Participants are recorded upon distribution.

3. Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below.

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2019 and 2018.

3. Fair Value Measurements (cont.)

Pooled Separate Accounts – The fair value of the pooled separate accounts is based on the NAV of the accounts calculated based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The Plan's investments at fair value as of December 31, 2019 are made up entirely of pooled separate accounts, which are measured at the NAV as a practical expedient. In accordance with Subtopic 820-10, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets at December 31, 2019 that are classified in the fair value hierarchy.

4. Tax Status

The Plan is based on a Prototype Non-Standardized Profit Sharing Plan with CODA (Prototype Plan) sponsored by Strategic Pension Services, LLC, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the Prototype Plan was designed in accordance with the provisions of the IRC. The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100% vested in their Company contributions.

6. Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan invests in products provided by MassMutual and Reliance, who are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also defined by ERISA as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

8. Subsequent Events

Management has evaluated subsequent events through March 18, 2025, which is the date the financial statements were available to be issued.

The Plan was subsequently amended and restated effective January 1, 2021 to make Fidelity Management Trust Company (Fidelity) the recordkeeper and custodian. Prior to December 31, 2020, \$31,201,195 of investments were liquidated and held as non-interest bearing cash prior to the re-investment of funds on January 11, 2021 into Fidelity.

As a result of this restatement, the age requirement was removed, the Company matching contribution became a safe harbor match (100% of the first 3% of the Participant's eligible compensation, then 50% of the next 2% of the Participant's eligible compensation), the vesting provisions for the Company matching contribution became 100% immediately, and participants can have two loans outstanding at a time. No other significant changes were made as a result of this restatement. Additionally, the Plan was amended on October 9, 2021, to change the time when participants may make changes to their deferral elections (from each calendar quarter to the beginning of each payroll period).

The Plan was restated again effective January 19, 2022. No significant changes were made as a result of this restatement. Additionally, the Plan was amended effective September 26, 2022, to change the entry dates (from quarterly entry dates to immediate entry upon eligibility).

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's financial statements.

The Plan was amended effective January 1, 2024, which removed all service requirements for employees to become eligible to participate in the Plan. The Plan was subsequently amended on February 26, 2024 to add a service requirement of 3 months for employees to become eligible to participate in the Plan.
