***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Knapé & Vogt Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Knapé & Vogt Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of Knap & Vogt Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Knap & Vogt Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### **Note A – Description of Plan**

The following description of the Knappe & Vogt Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit sharing and 401(k) plan covering substantially all employees of Knappe & Vogt Manufacturing Company (the Company), the Plan's sponsor. Eligible employees can become participants in the retirement savings and employer matching contribution portion of the Plan on the first full pay period that starts after the first of each calendar month which occurs immediately after the participant has completed thirty days of employment. A participant becomes eligible for the employer discretionary contribution on the first day of the month after completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may elect to make contributions to the Plan through payroll deductions from each participant's compensation, as defined, subject to statutory limitations. The Plan also allows participants to transfer funds from other eligible retirement plans into the Plan.

The Company must make a safe harbor matching contribution of 100% of the first 3% of participant contributions deferred by each employee and 50% of the next 2% deferred. Safe harbor matching contributions were \$744,838 and \$717,404 for the years ended June 30, 2024 and 2023, respectively.

The Company may also make a discretionary contribution for any plan year allocated based on participant compensation. To receive a portion of the discretionary contribution, a participant must be employed on the last day of the plan year. The Company elected not to make a discretionary contribution for the years ended June 30, 2024 and 2023.

#### **Plan Operations**

The Company has appointed Principal Trust Company (Trustee) to serve as Trustee and the Company to act as plan administrator. The Trustee is responsible for transactions and the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan, ensures that all government and participant reporting requirements are fulfilled, and approves all distributions from the Plan to participants. The Plan's fiduciary committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment strategy, and monitors investment performance.

#### **Note A – Description of Plan (Continued)**

##### **Participant Accounts**

Individual accounts are maintained for each participant, with benefits limited to the amount contributed to the participant's account plus or minus any allocation of income, expenses, gains, or losses. Allocations to participant accounts are based on compensation or account balances, as specified by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose, as listed in the accompanying Schedule of Assets (Held at End of Year).

In previous years, certain life insurance policies were transferred to the Plan from the Knappe & Vogt Manufacturing Company Profit Sharing Plan. The Plan does not allow for the purchase of additional life insurance policies; however, the Trustee will continue to maintain existing policies. Upon distribution of their accounts, participants may either receive an in-kind distribution of the insurance policies or cancel the insurance policies and receive the cash surrender value. Benefits paid to beneficiaries upon the death of the participant are paid at the policy's face value and may be reinvested into the Plan.

##### **Loans to Participants**

Under certain conditions, a participant may obtain a loan from the Plan. A participant may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000, reduced by the participant's largest outstanding loan balance in the previous 12 months or one half of the participant's nonforfeitable interest in the Plan. The loan will bear a reasonable interest rate, be adequately secured, and not exceed a period of five years unless the loan is for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions.

##### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company's matching contributions plus actual earnings thereon. For employees hired after June 30, 2007, vesting in the employer discretionary contribution accounts is based on years of continuous service, as follows:

#### **Note A – Description of Plan (Continued)**

##### **Vesting (Continued)**

Employees who were participants in the Knappe & Vogt Manufacturing Profit Sharing Plan on July 28, 2006, the date of change in control of the Company, became 100% vested in the employer discretionary profit sharing accounts regardless of years of service. A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

##### **Payment of Benefits**

On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or periodic installments, at least annually, over a period not longer than the joint life expectancy of the participant and the participant's spouse or beneficiary. In-service withdrawals are permitted upon attaining age 59½ or in case of a financial hardship.

##### **Costs and Expenses Vesting**

Certain investment management fees, insurance premiums, and administrative expenses are paid by the Plan and are based on reasonable and customary rates. Certain other costs and expenses incurred in connection with the operation of the Plan are borne by the Company.

##### **Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to pay reasonable administrative expenses of the Plan or reduce employer contributions. Forfeitures of \$1,316 and \$559 were used to pay plan expenses for the years ended June 30, 2024 and 2023, respectively. Forfeitures of \$21,361 and \$21,498 were used to reduce matching contributions for the years ended June 30, 2024 and 2023, respectively. There was no balance in the forfeiture account at June 30, 2024. The balance in the forfeiture account at June 30, 2023 was \$253.

#### **Note B – Summary of Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

### ***Note B – Summary of Accounting Policies (Continued)***

#### **Investment Valuation and Income Recognition**

Investments are reported in the Plan's financial statements at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Investment fee rebates include income received from mutual funds and may be used to pay certain eligible expenses.

#### **Investment Contracts**

Contract value is the relevant measurement attributable for that portion of the assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document; therefore, an allowance for credit losses is not considered necessary at June 30, 2024 and 2023.

#### **Life Insurance Policies**

The increase or decrease in cash surrender value of life insurance policies is income or losses due to the change in value of the policies held during the year.

#### **Benefits**

Benefits are recorded when paid.

### ***Note B – Summary of Accounting Policies (Continued)***

#### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through March 19, 2025, which is the date the financial statements were available to be issued.

### ***Note C – Fair Value Measurements***

The Plan's investments, except fully benefit-responsive investment contracts, are reported at fair value in the accompanying statements of assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets.
- quoted prices for identical or similar assets and liabilities in markets that are not active.
- other inputs that are observable or can be corroborated by observable market data.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

#### **Note C – Fair Value Measurements (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price by the mutual fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Life insurance policies:* Valued at cash surrender value on the last business day of the plan year, as reported by Equitable Financial Life Insurance Company, the issuer of the policies. Management evaluates the valuation of the policies and accepts the issuer's valuation without adjustment. Information regarding unobservable inputs is not provided to plan management by the issuer, and therefore, is not included herein.

#### **Note D – Risks and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of assets available for benefits.

#### ***Note E – Guaranteed Investment Contract with Insurance Company***

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling \$9,367,311 and \$9,240,095 as of June 30, 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with interest at stated rates and is charged for participant withdrawals and administrative expenses. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% or greater than 3%. The crediting rate was 1.55% and 1.75% as of June 30, 2024 and 2023, respectively. The crediting rate is reviewed periodically for resetting. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the plan document (including complete or partial termination or merger with another Plan), 2) changes to the Plan's prohibition on completing the investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other events (for example, divestitures or spin off of a subsidiary) that cause significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are likely to occur. The obligation is backed by the general assets of the insurance company that writes the investment contract.

#### ***Note F – Information Certified by Trustee***

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, increase in cash surrender value of life insurance policies, investment fee rebates, and interest income on notes receivable from participants, for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

#### ***Note G – Party-In-Interest Transactions***

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$181,957 and \$187,154 for the years ended June 30, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates. In addition, the Plan maintains notes receivable from participants. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### ***Note H – Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

### ***Note I – Tax Status***

The Plan obtained its latest determination letter dated April 19, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### ***Note J – Subsequent Amendments***

The Plan has been amended and restated effective July 1, 2024 to incorporate all amendments since July 1, 2015, add a Roth contribution feature, an automatic enrollment feature, and reflect changes for the Setting Every Community Up for Retirement Enhancement ("SECURE") Act and the SECURE Act 2.0.
