### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of HR Butler MEP Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022 and the related statement of changes in net assets available for benefits for the year ended December 31, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Plan Description

The following description of HR Butler MEP Retirement Plan (the "Plan"), prior to the Plan's termination further described in Note 6, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a multiple-employer defined contribution plan sponsored by T.R. Hedge & Associates, Inc. (the "Plan Sponsor") and includes participating employers who have completed adopting resolutions (the "Participating Employers"). The Plan covers substantially all employees of the Participating Employers who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In connection with the Participating Employers adopting the Plan, the Participating Employers may transfer assets from a plan previously sponsored by them to the Plan. See Note 6 for additional information.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions in 2022 and 2023 were paid after the time frame required by the Department of Labor. The Participating Employers remitted these contributions during 2022, 2023, and 2024 and will remit related lost earnings to the stand-alone plans in 2024 and 2025.

The Plan provides for employer safe harbor matching contributions of 100 percent of the participant's contribution up to the first 3 percent of compensation deferred and 50 percent of the participant's contribution in excess of 3 percent of compensation up to a maximum of 5 percent of compensation. All Participating Employers follow the same employer matching contribution formula outlined in the Plan.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the participating employer's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Vesting***

Participants are immediately 100 percent vested in employee salary, rollover, and employer safe harbor match contributions and any income or loss thereon. Vesting in employer contributions made prior to December 31, 2017, plus actual earnings thereon, is based on years of service. Participants vest in these contributions made by the Participating Employers 20 percent after two years of service and an additional 20 percent per year thereafter until they become fully vested after six years of service.

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The Plan Sponsor must approve any such hardship withdrawals.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Nationwide Trust Company, FSB or its affiliates. Nationwide Trust Company, FSB is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In addition, each Participating Employer has the right to cease participation in the Plan. Upon termination of the Plan, participants become 100 percent vested in their account balances. See Note 6 for more information on the spin-off of account balances to stand-alone plans, effective December 31, 2023.

### Note 2 - Summary of Significant Accounting Policies

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, except as noted below. The fully benefit-responsive investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### *Participant Notes Receivable*

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### *Benefit Payments*

Benefits are recorded when paid.

#### *Administrative Expenses*

Various administrative costs are paid by the Participating Employers.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including January 15, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Nationwide Trust Company, FSB (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements are based solely on information certified by the Custodian.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following table presents information about the Plan's assets measured at fair value on a recurring basis at December 31, 2022. The Plan did not hold any assets at December 31, 2023.

During 2023, three participating employers resolved to leave the Plan. As such, contributions were suspended for the participants of those employers, and net assets of \$2,156,861 were transferred out of the Plan.

Effective December 31, 2023, the Plan Sponsor elected to terminate the Plan. All participating employers were set up on stand-alone plans with Transamerica Corporation, the new recordkeeper and custodian. Assets of \$10,243,900 were transferred out of the Plan on December 29, 2023 to the stand-alone plans.

### Note 7 - Investment Contract

The Plan has a benefit-responsive investment contract with Nationwide Life Insurance Company (NLIC). NLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 0 percent. When establishing interest crediting rates for this product, NLIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the Plan Sponsor to settle an amount different than contract value paid either within 90 days or over time. As part of the plan spin-off discussed in Note 6, the investment contract was liquidated at contract value.
