Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Steinhafels, Inc. Profit Sharing 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of Steinhafels, Inc., Steinhafels Warehouse, Inc., and Mid America Bedding, Inc. (Company) who are age 18 or older and meet certain service requirements with the exception of members of a collective bargaining unit, leased employees and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees must complete 60 days of service to be eligible to make 401(k) deferral contributions and receive discretionary matching contributions. To be eligible for discretionary profit-sharing contributions, an employee must complete one year of service.

Contributions: Participants may elect to make pre-tax and Roth contributions through payroll deductions in accordance with annual limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Upon fulfilling eligibility requirements, an employee will be automatically enrolled in the Plan at a 5% deferral rate. In addition, all eligible employees who currently do not contribute will be subjected to the automatic enrollment process each year. Employees can opt out of participating or choose different deferral percentages. The elective deferral percentage of participants who are automatically enrolled (and have been participating in the Plan for at least one month) will automatically increase each July 1 by 1% to a maximum of a 15% deferral rate unless an alternate election is made.

The Company may make discretionary matching contributions. A participant must be employed on the last day of the quarter to receive a matching contribution. For the fiscal year ended June 30, 2024, the Company made a matching contribution equal to 25% of the first 5% of eligible compensation that a participant contributed to the Plan.

Discretionary profit-sharing contributions are determined by the Board of Directors and are allocated pro-rata to eligible participants as a uniform percentage of compensation. To receive an allocation, a participant must work 1,000 hours and be employed on the last day of the Plan year. The Company did not make a profit-sharing contribution for the year ended June 30, 2024.

Participants direct the investment of both employee and Company contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common/collective trust funds as investment options for participants.

Notes to Financial Statements

Note 1. Description of Plan (cont.)

Participant Accounts: Each participant's account is credited with the participant's contributions, Company contributions, allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution (and earnings thereon) is based on years of service:

Matching contributions: A participant vests over a modified vesting schedule: 1 year-50%; 2 years-100%.

Profit sharing contributions: A participant vests over a modified vesting schedule: 1 year-10%; 2 years-20%; 3 years-40%; 4 years-60%; 5 years-80%; 6 years-100%.

Participants become 100% vested in Company contributions upon death while in the employment of the Company, upon disability, upon attaining normal retirement age or upon termination of the Plan.

Notes Receivable from Participants: In the event of hardship, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and have an interest rate equal to the prime rate in effect at the inception of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Upon termination of service due to death, disability, separation, or retirement, a participant may elect to receive a lump-sum distribution or installment payments equal to the value of their vested account balance. In addition, in-service withdrawals are allowed for participants who are 100% vested and have reached age 59½, or in cases of financial hardship or disability.

During 2024, the Plan Sponsor documented its intent to amend the Plan to adopt specific provisions of the SECURE 2.0 Act.

- Effective March 16, 2024, participant withdrawals for qualified emergency expenses and domestic abuse situations are permitted.
- Effective April 3, 2024, the small balance force-out limit was increased from \$1,000 to \$7,000.

Forfeited Accounts: At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$3,358 and \$21,194, respectively. These accounts will be used to pay Plan expenses, reduce future Company contributions, or be allocated as additional contributions to the remaining participants. For the year ended June 30, 2024 forfeited nonvested accounts of \$53,379 were used to reduce Company contributions.

Note 2. Summary of Accounting Policies

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Refundable: Amounts payable to participants for contributions in excess of the IRS's allowed amounts are recorded as a liability with a corresponding reduction in contributions. The Plan distributed the excess contributions to the applicable participants in October 2024.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year-end.

Common/Collective trust fund: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company (the trustee of the Plan).

Note 5. Related-Party Transactions and Party in Interest Transactions

Principal Trust Company is the non-discretionary custodian as defined by the Plan. For the year ended June 30, 2024, administrative, recordkeeping, and custodial fees of \$101,492 were paid to Principal Trust Company. These transactions qualify as exempt party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any Company contributions.

Note 7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
