Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mt. Washington Pediatric Hospital 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mt. Washington Pediatric Hospital 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

NOTE 1 DESCRIPTION OF PLAN

The following description of the Mt. Washington Pediatric Hospital 403(b) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by the Mt. Washington Pediatric Hospital, Inc. (the Corporation). All employees of the Corporation are immediately eligible to participate in the Plan upon hire. Leased employee or a common law employee are exempt from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer a percentage of their annual compensation to the Plan provided that (a) the election does not exceed 80% of the participant's annual compensation and (b) does not exceed annual Internal Revenue Service (IRS) limits. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions up to annual limits set by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

Effective January 1, 2024 the Plan was amended to allow for Roth elective deferrals and direct Roth Rollovers.

Any employee hired after January 1, 2017 will be automatically enrolled at 2% of eligible compensation upon meeting eligibility requirements and will have their deferral percentages increased 1% annually until it reaches 10% of eligible compensation, unless they opt out of the automatic enrollment and increase. This auto increase will occur on July 1 of each year. Any employee who is a participant in the University of Maryland Medical System Corporation Pension Plan (the Pension Plan) as of December 31, 2022, and whose accruals under the Pension Plan are frozen as of December 31, 2022 and has elected not to participate in the Plan or has a salary reduction election of less than 2% of compensation, shall as soon as administratively feasible after January 1, 2023, automatically be deemed to have elected to reduce their compensation by an amount equal to 2%. These participants will also be subject to the automatic increase provisions of the Plan. Any employee who is a participant in the Pension Plan as of December 31, 2022 and whose accruals under the Pension Plan are frozen as of December 31, 2022 and has a salary reduction of 2% or more as of December 31, 2022, shall have their salary reduction increased by 1% each Plan year until the employee has reached a maximum automatic deemed election of 10% of compensation or the employee submitted an affirmative election.

Contributions (Continued)

The Corporation may make a discretionary matching contribution or a discretionary contribution to the Plan in an amount established each year at the discretion of the Board of Trustees. To be eligible to receive the discretionary contributions, an employee must have completed two continuous years of service, completed 1,000 hours of service during the Plan year, must be employed at the end of the Plan year, and must be hired prior to January 1, 2017. If a participant terminated due to death, disability, or retirement, they will still be eligible for the discretionary matching contribution. During the year ended June 30, 2023, the Corporation did not make a discretionary matching contribution. No employee shall be eligible to participate in the discretionary contribution feature of the Plan after June 30, 2023 and no employee shall be eligible to participate in the discretionary matching contribution feature after June 30, 2022. Effective July 1, 2022, no discretionary contribution shall be made with respect to salary reduction contributions made with respect to compensation paid on or after July 1, 2023.

Effective July 1, 2023 no employer discretionary contributions shall be made.

The discretionary contribution for the July 1, 2022 to June 30, 2023 Plan year will be based on the following percentage of the participants' eligible compensation received during the year based on the participants' years of continuous employment with the Corporation.

Less than 2	0%
2 to 4	0.5%
5 to 9	0.75%
10 or More	1.0%

Any employee hired after January 1, 2017 will be eligible for a nondiscretionary matching contribution upon completing one year of service and reaching the age of 21. The nondiscretionary matching contribution will be equal to 100% of a participant's salary reduction not in excess of 4%. Effective January 1, 2023, any employee hired prior to January 1, 2017 will become eligible to participate in the nondiscretionary matching contribution. Effective May 1, 2024, employees no longer have to reach the age of 21 to receive the nondiscretionary matching contribution.

An additional discretionary contribution was made for the July 1, 2022 to June 30, 2023 Plan year on behalf of certain participants. This contribution will be 100% vested at all times.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of prime on the first day of the quarter during which the loan is taken plus 1%. Loans must be paid back in five years, unless the loan was for the purchase of the participant's principal residence. Principal and interest are paid through payroll deductions based upon an established amortization schedule.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Corporation's contribution, and an allocation of Plan earnings and losses and administrative expenses. Allocations are based on the participant's compensation, participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All accounts are participant directed.

Vesting

Participants are vested immediately in their contributions and the Corporation's discretionary and discretionary matching contributions, plus actual earnings and losses thereon.

The nondiscretionary matching contribution vests at 0% in the first two years of employment, 25% after two years, 50% after three years, 75% after four years, and 100% at five years. Employees will be 100% vested upon death.

Payment of Benefits

Participants or their beneficiaries are eligible for distributions upon the participant's termination, death, disability, or retirement. The Plan also allows for in-service withdrawals for hardships and for participants who have reached the age of 59½. Distributions will be made in the form of lump sum amounts, partial distributions, or installments. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participants account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited Accounts

The Plan provides that forfeitures of nonvested Corporation contributions, if any, shall be applied to pay administrative expense or reduce future Corporation contributions. Forfeitures of \$50,000 and \$-0- were used to reduce the Corporation's contributions during the years ended June 30, 2024 and 2023, respectively. No forfeiture were used to pay administrative expense during the years ended June 30, 2024 and 2023. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$55,430 and \$79,366, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants and Corporation contributions are recorded in the year in which participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of the Plan are paid from excess revenue sharing, by the forfeiture account, or by charging participants' accounts. Included in administrative expenses are fees paid to the investment managers and auditors, as well as for Plan administration. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. The Plan received \$22,986 and \$28,283 in ERISA spending account revenue, for which \$27,579 and \$49,082 was used to pay Plan expenses during the years ending June 30, 2024 and 2023, respectively. The net of this activity has been recorded as other income (loss) on the statements of changes in net assets available for benefits. As of June 30, 2024 and 2023, the ERISA spending account totaled \$4,282 and \$8,514, respectively.

Subsequent Events

The Plan has evaluated subsequent events through March 18, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENTS

Empower Annuity Insurance Company, Empower Trust Company, LLC, and Prudential Bank & Trust, F.S.B., the qualified institutions of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of June 30, 2024. Empower Annuity Insurance Company was the qualified institution as of and for the years ended June 30, 2024 and 2023, Prudential Bank & Trust, F.S.B. was the qualified institution as of and for the period July 1, 2022 to March 31, 2023, and Employer Trust Company, LLC was the qualified institution as of June 30, 2024 and 2023, for the year ended June 30, 2024, and for the period April 1, 2023 to June 30, 2023.

NOTE 4 FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account: Valued at NAV of units, which are valued daily by the qualified institution at accumulation unit value based on the estimated value of the underlying investments, held by the Plan at year-end. If a participant transfers money out of the fund, there is a 90-calendar day waiting period before money can be transferred back into the fund.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company. Empower Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) the Plan is terminated (2) a breach of material obligation under the contract, (3) the class of business to which the agreement belongs is no longer commercially desirable, and (4) the Plan has not paid expenses and has not made alternative arrangement with the insurance company for paying expenses.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Corporation contributions.

NOTE 7 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are units of a fully benefit-responsive investment contract and a pooled separate account managed by Empower Annuity Insurance Company and Empower Trust Company, LLC, the qualified institutions of the Plan, and therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

NOTE 9 RISK AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
