*Summary of Principal Plan Provisions*

Effective Date:

The Plan was established effective January 1, 2014, and amended January 1, 2023.

Eligibility:

Participation begins on the January 1 or July 1 coincident with or next following the first anniversary following the date of hire. Participants must be at least 21 years old. Employees who are Highly Paid are restricted from entry unless they are the Managing Partner, office manager, and staff accountant.

Retirement Dates:

The **Normal** Retirement Date is the first day of the month coincident with or next following the participant's 62<sup>nd</sup> birthday with at least 5 Years of Service.

There is no **Early** Retirement Date.

Retirement Benefit:

The annual Normal retirement benefit is calculated in two pieces:

- a) Prior to January 1, 2023, 4.0% of Highest Three Years' Average Earnings plus 0.65% of Highest Five Year's Average Earnings in excess of Covered Compensation, the quantity times years of service earned prior to January 1, 2023, up to 35 years.
- b) On or after January 1, 2023, 10% of Highest Three Years' Average Earnings times years of service earned on or after January 1, 2023

Accrued Benefit:

The Accrued Retirement Benefit at any point in time is calculated according to the Normal retirement benefit shown above, but only service earned through the time of calculation is used. Service prior to January 1, 2009 is excluded.

All benefits are limited by §415(b) maximum of 10% per Year of Participating Service since the Effective Date of the Plan.

Vesting:

Participants become 20% vested after the second Year of Service. Each additional Year of Service credits the participant with another 20% of vesting until the 100% limit is reached after the sixth year. Service before the establishment of the Plan is included in this determination.

Death Benefit:

Post-retirement death benefits are limited to those implicit in the selection of the form of annuity. The Pre-retirement death benefit is the Accrued Benefit earned up through the date of death, payable as a lump sum.

Form of Annuity Payment:

The normal form of payment is a life annuity for non-married Participants. The normal form for married Participants is a joint-and-100% survivor annuity calculated as the actuarial equivalent of the life annuity. A lump sum form of benefit is also available.
