Dear Representatives of the Department of Labor:

The Black Hawk Casino, formerly known as the Sac & Fox Casino, a wholly owned venture of the Sac & Fox Nation, a federally recognized Indian tribe ("Black Hawk"), recently discovered errors in certain plan and plan sponsor identification information contained in a previously filed Form 5500 for the Sac & Fox Medical Plan (the "Plan").

As a result of this discovery, Black Hawk undertook an audit of the Forms 5500 previously filed for the Plan. This audit revealed certain unintentional administrative/clerical errors in the previously filed Forms 5500 which included, among other things, incorrect reporting of the plan number, incorrect reporting of the name of the plan sponsor and incorrect reporting of the plan sponsor employer identification number.

Black Hawk regrets that these Forms 5500 contained incorrect information and desires to correct these erroneous filings. Accordingly, accompanying this correspondence and submitted herewith for filing are amended Forms 5500 for the above referenced Plan for each of the following Plan Years: 2011; 2012; 2013, 2014; 2015 and 2016.
