Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Lawley Motors, L.L.C. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA section 103(a)(3)(C) [ERISA section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Lawley Motors LLC 410(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provision.

General

The plan is a 401(k)-profit sharing plan covering all of the full-time employees of Lawley Motors LLC., Sierra Vista Car Guys, LLC, K & S Motors LLC, and Lawley Ventures LLC, who have completed one year of service and are age nineteen (19) years or older. The plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

Contributions

The plan provides that participants may contribute a percentage of pre-tax annual compensation, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants can direct the investment of their contributions into various investment options offered by the Plan. The plan currently offers thirty-five different investment options. Matching contributions made by the employers are discretionary. The employers made a matching contribution of 15% of the participants' contribution totaling \$91,426 for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) plan earnings. Allocations are based on participant earnings or account balances as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$100,000 or 50 percent of their account balance. The loans are secured by the balance in the participant account and bear interest at rates from 4.25 percent to 8 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant whose vested account balance exceeds \$5,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with an account balance of more than \$1,000 but less than or equal to \$5,000 that do not request a lump-sum distribution will have their account balance automatically rolled over to an individual retirement account (IRA). Participants with an account balance of less than \$1,000 must receive a lump-sum distribution.

Forfeited Accounts

As of December 31, 2024, and 2023, forfeited non-vested accounts totaled \$5,477 and \$4,239 respectively. The Plan did not use any of the forfeitures account to pay for plan expenses for the year ended December 31, 2024.

NOTE 2: SUMMARY OF SIGNIFICANT POLICIES

Basis of Accounting

The financial statements of the plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make payments and the plan administrator deems the participant note to be in default, the note balance is reduced, and the benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

NOTE 3: INFORMATION CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of compliance pursuant to 29 CFR 2520.103-5 (C) (Certification and 29 CFR 2520.103-8 (Limitation on Scope) of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule of assets held at year end, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and the related investment income and interest income for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Retirement, LLC, the custodian of the Plan.

NOTE 4: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for the identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Empower Insurance Company issues to Plan Sponsors, group annuity contracts or funding agreements that include variable investment offerings, through Pooled Separate Accounts.

These unregistered Pooled Separate Accounts are divided into investment divisions called "Sub-Accounts". Each Sub-Account invests in shares of an underlying mutual fund.

Sub-Account values are measured in terms of "Accumulation Units". The Accumulation Units of a Sub-Account are assigned a unit value daily, at the end of each day the New York Stock Exchange (NYSE) is open for trading, as of the close of the NYSE on that day (called a "Valuation Day"). To determine the current Accumulation Unit Value for a Sub-Account the prior Valuation Day's Accumulation Unit is multiplied by the Net Investment Factor. The "Net Investment Factor" is used to measure the investment performance of a Sub-Account from one Valuation Day to the next.

The Net Investment Factor for each Sub-Account equals the net asset value (NAV) per share of the underlying Fund held in the Sub-Account at the end of the current Valuation Day, divided by the net asset value (NAV) per share of the underlying Fund held in the Sub-Account at the end of the prior Valuation Day, minus any daily mortality and expense risk administration charges, if applicable.

The preceding methodology described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6: TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter the plan administrator and the plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more than likely than not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan, and concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recording of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions: however, there are currently no audits for any periods in progress.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that change in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8: RELATED PARTY AND PARTY-IN- INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate accounts managed by the Great Western Life Insurance Company. Empower Retirement LLC, a wholly owned subsidiary of the Great Western Life Insurance Company, is the custodian and record keeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Account transactions with the plan, while considered party-in-interest transactions under ERISA are permitted under the plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.

NOTE 9: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to terminate the plan subject to the provisions of the Employee Retirement Income Act of 1974 (ERISA). In the event of a plan termination all participants will become 100% vested in their employer accounts.

NOTE 10: SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through March 15, 2025, the date the financial statements were available to be issued.

The employers of the Plan sold their businesses in 2024. The existing plan may be merged into the new employer plan or terminated. Possible effects of this merger/termination have not yet been determined.
