INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Milwaukee Drivers Health and Welfare Trust Fund
Milwaukee, Wisconsin

Opinion

We have audited the accompanying financial statements of the Milwaukee Drivers Health and Welfare Trust Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

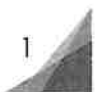

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED JUNE 30, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Milwaukee Drivers Health and Welfare Trust Fund (the Plan) provides general information only. Participants should refer to the trust agreement for a more complete description of the Plan's provisions.

General - The Plan was established on June 11, 1958 as a result of collective bargaining agreements between the Teamsters Local No. 344 (the Union) and the United Parcel Service and numerous other employers to provide health benefits for eligible participants and their dependents. The Plan is a multiemployer plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides health benefits (hospital, surgical, major medical, dental, vision, disability and life insurance) covering employees who work the qualifying period as described in the Plan and for whom contributions have been made by contributing employers. Benefits are expensed when paid.

Life and accidental death and dismemberment benefits for active members are provided through an insurance contract with Union Labor Life Insurance Company. All other benefit payments are self-insured.

The Plan has a stop-loss agreement with Union Labor Life Insurance Company. The policy covers medical claims paid by the Plan in excess of \$750,000 on each covered person for the years ended June 30, 2024 and 2023. There were excess reimbursements for years ended June 30, 2024 and 2023.

For a complete description of all amendments adopted during the year, participants should refer to the Plan document.

Eligibility - A person becomes initially eligible on the first day of the month following:

- A period of five consecutive weeks during which the employer contributes to the Plan on the participant's behalf or the month in which the employer has contributed on the participant's behalf for each week of the month.

To remain eligible, contributions must be paid on an employee's behalf each week of the month. Contributions received in the current work month earn active participants eligibility two months in advance.

Previously eligible employees may continue coverage by making self-contributions under the conditions described in the Plan.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Retiree Premiums - Retiree medical monthly premiums are based on a descending scale based on years of service and type of coverage.

The cost of the postretirement benefit obligations are shared by the participating employers and retirees. As of June 30, 2024 and 2023, retirees are projected to contribute 29% and 30%, respectively, of the estimated cost of providing their postretirement benefits.

Basis of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer Contributions Receivable - Contributions receivable represents amounts received subsequent to year end for work performed through June. Therefore, no allowance for doubtful accounts is recorded.

Property and Equipment - Property and equipment is stated at cost. Major additions are capitalized while maintenance and repairs, which do not improve or extend the lives of the respective assets, are expensed currently. Depreciation is calculated on the straight-line method over the estimated useful lives of five to seven years for furniture and equipment. Depreciation expense was \$23,541 and \$12,144 for the years ended June 30, 2024 and 2023, respectively.

Plan Termination - Although they have not expressed any intent to do so, the Board of Trustees (Trustees) has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets will be distributed to the participants after all expenses incurred by the Plan are paid.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Estimated Liability for Future Claims - The estimated liabilities for benefit claims incurred but unpaid and extended eligibility were prepared by the actuary to the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Postretirement Benefits - The postretirement benefit obligations represent the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to June 30th. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligations are the portion of the expected postretirement benefit obligations that are attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The recognition of federal subsidies receivable under the Medical Modernization Act of 2003 is determined by an actuary and is calculated by estimating a per capita amount applying prescription drug trends for retiree prescription drug plan federal subsidies that the plan is eligible to receive. The Plan has been determined to be actuarially equivalent to the Medicare Part D Standard Benefit and is eligible for the subsidy.

Retirement rates vary based on the contribution plan each contractor has. The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses - The Plan's expenses are paid by the Plan as provided by the Plan document. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

New Accounting Pronouncement Adopted - During the year ended June 30, 2024, the Plan adopted the provisions of Accounting Standards Update (ASU) 2016-13, *Financial Instruments – Credit Losses* (Topic 326). This ASU replaced the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The ASU requires employee benefit plans to immediately recognize the estimated expected credit losses over the life of a financial instrument, including contributions receivable due from employers. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events.

The Plan adopted the ASU effective July 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

NOTE 3. FUNDING POLICY

The Trustees established a funding policy and method in order to promote the purpose of the Trust Fund and to ensure compliance with ERISA. Each employer contributes to the Plan such amounts and at such times is required by the applicable provisions of the respective collective bargaining agreements, or such other agreements as are approved by the Trustees. The weekly contribution rates vary by participating local. The revenue of the Plan is dependent on continued activity of the employers of the Plan.

NOTE 4. RELATED PARTY AND PARTIES IN INTEREST TRANSACTIONS

The Plan leases office space from the Union. The lease was signed requiring payments of \$516 per month through December 31, 2011. The lease was extended after December 31, 2011 on a month to month basis at the same rate under the terms of the lease. Rent expense is \$6,192 for the years ended June 30, 2024 and 2023. The Plan also reimburses the Union for clerical services (wages and fringe benefits) paid by the Union on behalf of the Plan. Reimbursements were \$306,889 and \$351,250 for the years ended June 30, 2024 and 2023, respectively. The Plan shares other common administrative expenses with the Milwaukee Drivers Pension Fund (the Pension Fund). Reimbursed administrative expenses to the Pension Fund were \$2,708 and \$8,608 for the years ended June 30, 2024 and 2023, respectively. There were no amounts owed to related parties for the years ended June 30, 2024 and 2023.



NOTE 4. RELATED PARTY AND PARTIES IN INTEREST TRANSACTIONS (CONTINUED)

As disclosed in Note 2, the Plan pays certain administrative, investment and professional fees to various service providers. These transactions are party in interest transactions under ERISA.

NOTE 5. ESTIMATED LIABILITY FOR FUTURE CLAIMS

The estimated liabilities for current health claims payable, benefit claims incurred but not yet reported and eligibility credits, are prepared by the actuary of the Plan. The estimates are based on hours worked prior to July 1, 2024 and 2023.

NOTE 6. BENEFIT OBLIGATIONS

The Plan's deficiency of net assets over benefit obligations at June 30, 2024 and 2023 relates primarily to the postretirement benefit obligations, the funding of which is not covered by the contribution rate provided by the current bargaining agreement.

The calculation of the obligations do not, in and of itself, imply that there is any legal liability to provide the benefits valued, nor is there any implication that the Plan is required to implement a funding policy to satisfy the projected expense.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates were one percentage point higher than the ones used, it would increase the obligations as of June 30, 2024 and 2023 by \$77,619,432 and \$78,332,272, respectively.

Claims that have been processed and approved for payment at year end, but not paid and claims incurred but not reported are not considered liabilities under U.S. generally accepted accounting principles and, therefore, are not presented as liabilities or claims and premiums paid in the accompanying financial statements but are recorded on the Form 5500 as a liability.

NOTE 8. CONCENTRATION OF RISK

Approximately 95% of the employer contributions are from one employer for the years ended June 30, 2024 and 2023.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 10. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs). The three levels of the fair value hierarchy are described as follows:



NOTE 10. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Stock - cooperative: Value is determined based on the cost per share of the stock. Stock is generally redeemed at face value.

Mutual funds: Value is determined based on the closing price reported in the active market in which the individual assets are traded.

Cash and equivalents: Money market funds are valued using amortized cost which approximates fair value.

Common collective trust (Loomis Sayles Credit Asset Trust): Value is determined by the net asset value (NAV) of the shares held by the Plan at year end. The majority of the underlying investments are term loans which are normally valued at the average of the means of one or more bid and ask quotations obtained from a pricing service or other sources determined to be independent and believed to be reliable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended June 30, 2024 and 2023, there were no transfers in or out of Levels 1, 2 or 3.

NOTE 11. FAIR VALUE OF INVESTMENTS THAT CALCULATE NET ASSET VALUE

Authoritative guidance on fair value measurements permits the Plan to measure the fair value of an investment entity that does not have a readily determinable fair value based upon the NAV per share or its equivalent of the investment. This guidance does not apply if it is probable that the investment will be sold at a value different than NAV.

NOTE 11. FAIR VALUE OF INVESTMENTS THAT CALCULATE NET ASSET VALUE (CONTINUED)

The Plan's investment in investment entities is subject to the terms of the respective private placement memoranda and governing agreements. Income or loss from investments in these investment entities is net of the Plan's proportionate share of fees and expenses incurred or charged by these investment entities. To diversify its investment risk, the Plan looked for different investment vehicles where the return did not necessarily correlate to general market returns as what was previously invested.

The Plan's risk of loss in these entities is limited to its investment. The Plan may increase or decrease its level of investment in these entities at its discretion. The Plan typically has the ability to redeem its investment from these entities on a daily or quarterly basis but longer lock-up periods can apply to certain investments.

NOTE 12. TAX STATUS

The Trust established under the Plan to hold the Plan's net assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC), and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service (IRS), and the Plan sponsor believes that the Trust, as amended, continues to qualify and operate in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.



NOTE 13. SUBSEQUENT EVENTS

Subsequent events have been evaluated through February 28, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
