### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Dutch Gold Honey, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). #### **Note 1 - Description of Plan**

The following description of the Dutch Gold Honey, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan is a defined contribution profit sharing plan covering substantially all employees of Dutch Gold Honey, Inc., Gamber Glass Container, Inc., and DGH Logistics, Inc. (the Companies). The Plan does not allow for employee contributions. To be eligible to receive the profit sharing contribution, employees must complete one year of service (equal to 1,000 hours worked during the given plan year) and be age 21 or older. Employees eligible to participate may enter the Plan at the beginning of each plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

Each year, the Companies make a standard percentage contribution to all eligible employees based off their wages in the plan year. To be eligible to receive the profit sharing contribution, an employee must have been employed as of June 30<sup>th</sup> of the plan year. The profit sharing contribution is deposited into participant accounts in the quarter following the end of the plan year. The Companies made a contribution of \$2,069,302 and \$1,904,928 relating to the plan years ended June 30, 2024 and 2023, respectively.

##### **Participant Accounts**

Each participant's account is credited with the allocations of (a) the Companies' contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Vesting in the employer contributions, plus actual earnings thereon, is based on the following vesting schedule:

##### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and can only do so for the purpose of purchasing their primary residence, to prevent an eviction from their primary residence, or repair their primary residence or an immediate relative of the participant as a result of a natural disaster. Participants may only have one outstanding loan at a time. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, retirement, or upon termination of employment, a participant's vested account will be paid as soon as administratively possible in a lump-sum payment.

##### **Forfeited Accounts**

Forfeited nonvested accounts, if any, shall be applied to reduce future employer contributions or offset plan expenses for such plan year. Forfeited nonvested accounts of \$15,689 and \$85,931 will be used to reduce the year-end profit sharing contribution. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$15,689 and \$85,931, respectively.

#### **Note 2 - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Fee rebates received back from mutual fund companies totaling \$4,438 and \$4,180 for the years ended June 30, 2024 and 2023, respectively, were credited back to the accounts of the participants invested in those funds and are included in other income on the statement of changes in net assets available for benefits.

### **Note 3 - Information Certified and Provided by Fulton Bank, N.A. and Matrix Trust Company**

Effective July 1, 2023, the Plan's assets, including investments, accrued investment income, and notes receivable from participants, previously held by Fulton Bank, N.A. (the trustee of the Plan), were transferred to Matrix Trust Company (the custodian of the Plan). This information in the statement of net assets, held at June 30, 2024 and 2023, as well as net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended June 30, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Fulton Bank, N.A. for the year ended June 30, 2023 and by Matrix Trust Company for the year ended June 30, 2024.

Plan asset and investment activity not certified by the custodian includes life insurance policies with cash surrender values of \$17,657 and \$18,174 as of June 30, 2024 and 2023, respectively.

### **Note 4 - Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Registered investment companies are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Life insurance policies are measured at their cash surrender value, less any surrender charges and outstanding loan policies.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 - Tax Status

The Companies adopted a nonstandardized, pre-approved profit sharing plan sponsored by Fulton Bank, N.A. The nonstandardized, pre-approved profit sharing plan has received an opinion letter from the IRS, dated June 30, 2020, stating that the nonstandardized, pre-approved profit sharing plan is qualified under the appropriate section of the Internal Revenue Code (IRC). The nonstandardized, pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

#### **Note 5 - Tax Status (continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. Federal, state, or local tax authorities for years before June 30, 2021.

#### **Note 6 - Plan Termination**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

#### **Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 8 - Related Party Transactions and Party-In-Interest Transactions**

All transactions, which may be considered party-in-interest transactions, relate to normal management and administrative services, and the payment of fees related thereto. Fees paid by the Plan for investment management and custody services amounted to \$79,914 and \$74,281 for the years ended June 30, 2024 and 2023, respectively.

#### **Note 9 - Subsequent Events**

Plan management has evaluated subsequent events through February 17, 2025. This date is the date the financial statements were available to be issued. No material events subsequent to June 30, 2024 were noted.
