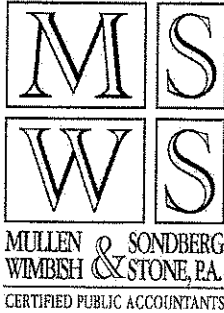

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Arc of Frederick County Tax Deferred Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Arc of Frederick County Tax Deferred Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 *CFR* 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 *CFR* 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Arc of Frederick County Tax Deferred Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 - Description of Plan

The following description of The Arc of Frederick County Tax Deferred Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Arc of Frederick County Tax Deferred Savings Plan was established January 1, 1995 and was restated effective July 1, 2016. The Plan covers substantially all employees of The Arc of Frederick County, Inc. (the Employer). Under the provisions of the Plan, an employee may become eligible to participate in the Plan immediately and receive employer discretionary contributions after completing two months of service. Per Plan provisions, there is no service requirement for employee elective deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Eligible Participants may elect to defer up to 100% of his or her compensation and have such deferrals contributed by the Employer to his or her account under the Plan. In any or all plan years, the Employer may make a discretionary non-elective contribution to the Plan. This non-elective contribution is allocated to all participants pursuant to Plan provisions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participant contributions are subject to the annual Internal Revenue Code limits as adjusted each year. The Employer discretionary non-elective contribution amounted to \$623,343 and \$804,007 for the years ended June 30, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with (a) the participant's salary deferrals, (b) the Employer's contribution, (c) Plan earnings, and (d) an allocation of administrative expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into the various investments offered by the Plan.

Vesting

Participants are immediately fully vested in their elective contributions and employer discretionary non-elective contributions plus actual earnings thereon.

Payment of Benefits

Upon severance of employment or after attainment of age 65, a participant may elect to receive either a lump sum distribution amount equal to the value of the participant's vested interest in his or her account, or annual installments that do not exceed the life expectancy of the participant or beneficiary. Eligible distributions may also be rolled over to another qualifying plan or IRA. Hardship withdrawals are permitted in accordance with Internal Revenue Service regulations.

Note 1 - Description of Plan (Cont.)

Forfeitures

All employer and employee contributions are fully vested immediately. As such, no forfeitures exist.

Notes Receivable from Participants

Under certain circumstances, as outlined in the Plan document, the Plan allows employees to obtain loans from the Plan up to Internal Revenue Code limits. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. These loans are secured by the vested portion of the participants' account and bear an interest rate that is commercially reasonable. This is considered to be the prime rate plus 1%. Loans outstanding at June 30, 2024 and 2023 bear interest from 4.25% to 9.50%. Repayment of loans is provided through automatic payroll deduction.

Administrative Expenses

The administrative expenses related to the Plan's custodian are paid by the Plan and amounted to \$36,325 and \$25,411 during the years ended June 30, 2024 and 2023, respectively. The Employer pays all other administrative expenses of the Plan including investment management services, audit fees, and recordkeeping services.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. This basis of accounting involves the application of accrual accounting; consequently, revenues and gains are recognized when earned, and expenses and losses are recognized when incurred.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. Benefits paid to terminated participants for the years ended June 30, 2024 and 2023 were \$225,359 and \$261,526, respectively.

Note 2 - Summary of Accounting Policies (Cont.)

Participant Loans

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. As of June 30, 2024 and 2023, the participant loan balances outstanding totaled \$179,389 and \$151,801, respectively. The Plan administrator has determined all notes receivable are fully collectible from the participants' vested account balances; consequently, no amounts have been recorded as an allowance.

Contribution Receivable

Contributions for the employer discretionary matching contribution are recorded in the year in which the contributions were deemed earned and designated by the plan sponsor. All contributions are participant directed unless directed by the Plan based on requirements determined by the plan document. The plan administrator has determined that all contribution receivables are fully collectible; consequently, no amount has been recorded as an allowance for doubtful accounts in the accompanying statement of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the guaranteed investment contract which is reported at contract value). Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined-contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of changes in net assets available for benefits is prepared on a contract value basis for fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

New Accounting Pronouncements

In June 2016, the FASB issued *ASU 2016-13, "Financial Instruments – Credit Losses"* (*Topic 326*) which significantly changed how entities will measure credit losses for most financial assets and certain other instruments that aren't measured at fair value through net income. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity's exposure to credit risk and the measurement of credit losses. Financial assets held by the Plan that are subject to the guidance in *FASB ASC 326* were employer contributions receivable and participant contributions receivable.

The Plan adopted the standard effective July 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in new and enhanced disclosures only.

Note 3 - Fair Value Measurements

Certain Plan investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820, "Fair Value Measurements and Disclosures," establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy assigns the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 3 - Fair Value Measurements (Cont.)

The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs that are unobservable and supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In addition, under *FASB ASC 820* the fair value of certain investments may be measured using the net asset value (NAV) per share (or its equivalent). Such investments are not classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value as of June 30, 2024 and 2023:

Pooled separate accounts: Valued at the net asset value of the pooled separate accounts, as reported by the Custodian and calculated in a manner consistent with generally accepted accounting principles for investment companies. The net asset value is calculated based on the values of the underlying mutual funds, domestic stocks, international stocks, and other fixed securities held by variable annuity contracts. As permitted by *FASB ASC 820*, net asset value is used as a practical expedient to estimate fair value and is not included in the fair value hierarchy. The total fair value of the Plan's variable annuities as of June 30, 2024 and 2023 was \$8,921,467 and \$6,761,912, respectively.

Note 4 - Investment Contracts with Insurance Companies

The Voya Retirement Insurance and Annuity Company Fixed Account is a benefit responsive contract available as an investment option to Plan participants. Voya Retirement Insurance and Annuity Company maintain the contributions in a general account. The account is credited with a specific guaranteed rate of interest and additional amounts if declared by Voya Retirement Insurance and Annuity Company. The fixed account is charged for participant withdrawals and administrative expenses. The fixed account is included in the financial statements at contract value as reported to the Plan by Voya Retirement Insurance and Annuity Company. Participants may ordinarily direct the withdraw or transfer of all or a portion of their investment at contract value.

Note 4 - Investment Contracts with Insurance Companies (Cont.)

There are no reserves against contract value for credit risk for the contract issuer or otherwise. The fair value of the investment contracts at June 30, 2024 and 2023 amounted to \$124,424 and \$377,629, respectively.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to scheduled maturity date. Under the terms of the contract, the guaranteed minimum rate is 1.00%

The value shown, is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value of the withdrawal request.

Note 5 - Data Obtained from the Custodian

Investment Data

The information included in the accompanying financial statements and supplementary schedule was obtained from data that has been certified as complete and accurate by the custodian, Voya Retirement Insurance and Annuity Company, for the years ended June 30, 2024 and 2023.

Schedule of Assets Held for Investment Purposes

The accompanying Schedule H, line 4i - Schedule of assets (held at end of year) represents a detailed listing of all investments held by the Plan as of June 30, 2024.

Note 6 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the net value of each participant's account would be distributed in accordance with the Plan's provisions.

Note 8 - Tax Status

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Effective July 1, 2016, the Plan adopted a non-standardized form of prototype plan. The prototype plan obtained its latest opinion letter on March 31, 2017 from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letters have been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Reportable Transactions

A reportable transaction is a transaction, or series of transactions, exceeding five percent of the current value of the Plan's assets at the end of the year. During the Plan years ended June 30, 2024 and 2023, there were no reportable transactions.

Note 10 - Party-in-Interest Transactions

Voya Retirement Insurance and Annuity Company is the Custodian as defined in the Plan, and, therefore qualifies as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$36,325 and \$25,411 for the years ended June 30, 2024 and 2023, respectively.

Note 11 - Subsequent Events

The Plan has evaluated the impact of significant subsequent events. Except as described below, there have been no subsequent events through February 27, 2025, the date the Plan's financial statements were available to be issued, that require recognition or disclosure.

Effective January 1, 2025, the Plan was formally amended to allow all employees to be eligible to participate in the Plan.
