Subject: Request for Waiver of DFVCP Fee – Form 5500-SF Filing for Antionette Brookins & Associates Family Counseling

Dear Sir/Madam,

I am writing to formally request a waiver of the Delinquent Filer Voluntary Compliance Program (DFVCP) fee for the late Form 5500-SF filings for plan years 2021 and 2022 under Antionette Brookins & Associates Family Counseling Corp, EIN 833848085.

Due to unforeseen circumstances, I was unaware that these filings were required, as I had relied on a payroll processing company, Paychex, to handle all compliance-related filings. During this period, my business was significantly impacted by COVID-19, leading to financial and operational challenges, including losing my business location and a change of address. As a result, I did not receive notices regarding the filing requirements in a timely manner.

When I became aware of the outstanding filings, I immediately contacted Paychex. They informed me that the forms for the years in question had already been filled out, but they were uncertain why they had not been submitted on my behalf. Once I was aware of the oversight, I immediately rectified the issue by registering with EFAST2 and submitting the necessary Form 5500-SF filings. I deeply value compliance and acted in good faith to resolve the matter as soon as I became aware.

Given these circumstances, I respectfully request that the DFVCP fee be waived. My failure to file on time was unintentional and due to factors beyond my control, including issues with the payroll processing company. I kindly ask for your consideration in this matter and would be happy to provide any additional information if needed.
