1. DESCRIPTION OF PLAN

The following description of the Carefree Practice Resources, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) plan. The Plan is a defined contribution plan established January 1, 1999, by Carefree Practice Resources, LLC (the “Company”). The Plan is a qualified plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

The Plan covers all employees of the Company who have completed six (6) months of service, have worked 500 hours, and are age twenty-one (21) or older.

Contributions

Employees are permitted to make salary deferral contributions to the Plan under a 401(k) arrangement. The Plan provides for employer “Safe-Harbor Matching” contributions equal to 100% of deferrals that do not exceed 4% of compensation. Participants are 100% vested in employer contributions designated as “Safe-Harbor Matching” contributions.

After an employee completes the eligibility requirement, they are entitled to receive an allocation of the employer safe-harbor matching contribution. The Plan does impose an hour-service requirement and employees are not required to be employed on the last day of the Plan year to receive an allocation of the employer safe-harbor matching contribution.

The Company may also contribute an employer-matching contribution determined annually at the discretion of the Company’s management. The matching contribution, if any, is allocated to the participants’ accounts based upon the participants’ compensation as a percentage of the total. The matching contribution is not to exceed 4% of the participants’ compensation, and the participant must be employed on the last day of the Plan year and have completed at least 1,000 service hours. The Company elected to not make matching contributions for the year ended December 31, 2021.

The Company may also contribute a discretionary contribution determined annually at the discretion of the Company’s management. The discretionary contribution, if any, is allocated to the participants’ accounts based upon the participants’ compensation as a percentage of the total. The Company has elected to not make discretionary contributions for the year ended December 31, 2023.

Participants are vested in employer-matching and employer discretionary contributions after six (6) years as outlined in the table below:

Employees who are not employed on the last day of the Plan year do not receive an allocation of the employer-matching contribution or discretionary contribution, if any, regardless of hours worked. The Plan does not permit participant nondeductible contributions. The Plan accepts qualified rollover contributions and is currently funded.

#### Participant Accounts

The participant's accounts are set up in self-directed, individual accounts administered by Principal Life Insurance Company and Principal Trust Company ("Principal"). Participant individual accounts are valued on a daily basis. Contributions and Plan earnings or losses are credited (charged) to the participants as soon as the amounts are received by the investment funds.

The benefit to which a participant is entitled is limited to the vested amount in the participant's account.

#### Vesting

Participants are immediately vested in their contributions and employer contributions are subject to a six-year graded vesting schedule, plus actual earnings.

#### Forfeited Accounts

Forfeited accounts will be used to reduce future employer contributions. No forfeited accounts were used to reduce employer contributions for the years ended December 31, 2023 and 2022.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have two outstanding loans at any given time. The loans are secured by the balance in the participant's account. A participant may not request a loan of less than \$1,000.

Loan terms range from one to five years and bear interest at a rate comparable to local prevailing rates as determined by the Plan trustee. Principal and interest are paid ratably through monthly payroll deductions.

Loans are treated in default if any scheduled payment remains unpaid more than 90 days.

#### Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination, a participant may elect to receive a lump-sum amount equal to the value of his or her vested benefit. The Plan does not allow for hardship distributions to participants. Payment of benefits is recorded when paid.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's policy is to have its financial statements prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments

Subsequent Events

Subsequent events were evaluated through February 18, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Amounts allocated are credited to a participant's account in the form of accumulation units. The value of an accumulation unit of any investment account is determined at the close of each business day and is directly related to the net asset value of the shares of the underlying investment adjusted for any dividends or distributions received by Principal and the daily equivalent of any fee charged by Principal pursuant to the contract. The value of each accumulation unit is published each business day. Each investment account is invested by Principal exclusively in shares of a specific mutual fund or other investment entities as directed by the participant. The updated NAV, daily accrual amounts, as well as dividend and capital gain distribution factors are received from the fund companies offered under the pooled separate account.

*Common collective trusts* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a benefit-responsive insurance contract with Principal Life Insurance Company. The principal of the investment is guaranteed as long as the contract is in force. This contract provides a fixed crediting interest rate, and a financially responsible entity guarantees liquidity at contract value prior to maturity for any and all participant-initiated benefit withdrawals, loans, or transfers arising under the terms of the plan, which allows access for all participants. The investment options in the guaranteed interest accounts (“GIA”) are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The average yield earned by the guaranteed investment contract was as follows:

The Internal Revenue Service (“IRS”) has determined and informed the Company by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan’s tax Counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related Trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that it is no longer subject to income tax examinations for the years prior to 2020.

6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes a third-party administrator. Advising, recordkeeping and broker fees were paid by the Plan in accordance with the Plan document. The Plan’s investments were held by Principal, which is the Trustee and custodian as defined by the Plan; therefore, these transactions, as well as forfeiture balances, qualify as exempt party-in-interest transactions.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company, the Trustee of the Plan.
