INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Rushing Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 1, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended August 1, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Rushing Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2023, and for the period ended August 1, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Rushing Company 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Rushing Company 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

August 1, 2024 and December 31, 2023

NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN

The provisions of The Rushing Company 401(k) Plan (the Plan) were effective March 6, 2006. The Plan has been amended and restated to comply with current legislation. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

In May 2024, the Plan Sponsor was acquired by IMEG Corp. (IMEG). As a result, employees who previously participated in the Plan began participating and making contributions to the IMEG 401(k) Plan (IMEG Plan) (see Note 7).

General

The Plan was a defined contribution plan covering substantially all employees of The Rushing Company LLC (the Company). There were no age or service requirements to begin 401(k) deferral contributions or receive employer safe-harbor non-elective contributions. Employees must have completed 1,000 hours of service during a Plan year, and be employed on the last day of the Plan year, to receive any discretionary contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees were responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Contributions

Participants may have elected to contribute up to 100% of their annual pre-tax or Roth after-tax compensation, as defined in the Plan document, within statutory limits. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified pension plans. Participant contributions were paid to the Plan after each pay period.

The Company made non-elective safe-harbor contributions equal to 3% of eligible compensation. Contributions were funded to the Plan each pay period.

The Company could make discretionary matching and profit contributions each year. During 2024, no such contributions were authorized.

NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)

Participant Accounts

Individual participant accounts were maintained by the Plan's third party administrator. Each participant's account was credited or charged with the participant's contribution, allocations of the Company's contributions, investment earnings and losses, and administrative expenses. Loan and distribution fees were deducted from the respective participant's accounts. Allocations were based on participant compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment Options

Participants directed their employee and employer contributions among the Plan's investment options, which included various mutual funds and a guaranteed interest account held in a group annuity contract.

Vesting

Participants were immediately vested in their own contributions and Company safe-harbor contributions, plus actual earnings thereon. Vesting in any Company discretionary matching or profit sharing contributions plus actual earnings thereon was based on years of credited service, as defined in the Plan document, with 25% vesting after each year of service and 100% vesting after four years of service. Upon normal retirement (65), death, or disability, participants became fully vested in all benefits.

Notes Receivable from Participants

Participants could borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes receivable could not exceed five years, except for the purchase of a primary residence. The notes receivable were secured by the balance in the participant's account and bore interest at rates commensurate with local prevailing rates as determined by the third party administrator at the time of issuance. Interest rates ranged from 3.5% to 8.5% on notes receivable outstanding as of July 31, 2024. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Benefits could be distributed upon retirement, death, disability, or other termination of employment. Benefits equal to the participant's vested account balance could be paid in a lump sum or installments, depending on certain factors as described in the Plan document and at the participant's election. Under certain hardship circumstances or attainment of age 59½, participants could request a lump-sum distribution of certain vested account balances prior to retirement.

Forfeited Accounts

Upon termination, participants' non-vested account balances were forfeited. Forfeitures could be used to pay Plan administrative expenses or reduce future employer contributions. At August 1, 2024, forfeited non-vested account balances totaling approximately \$25,000 were transferred out of the Plan. At December 31, 2023, forfeited non-vested account balances totaled approximately \$23,000.

NOTE 1 – ORGANIZATION AND DESCRIPTION OF THE PLAN (continued)

Subsequent Events

The Plan has evaluated subsequent events through March 13, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following were significant accounting policies used by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affected certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value, except for the fully benefit-responsive contract which was reported at contract value (Note 4). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determined the Plan's valuation policies utilizing information provided by the investment custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest was recorded on the accrual basis. Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balances, plus accrued by unpaid interest, if any. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of December, 31 2023. If a participant ceased to make loan repayments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees for individual transactions such as distributions and loans were deducted from the respective participant's account. Investment related expenses, and revenue sharing fees or credits, were included in net appreciation or depreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan were deemed to be actively traded.

The Plan's investments reported at fair value consisted solely of mutual funds which were valued as of December 31, 2023 using level one measurement.

NOTE 4 – CONTRACT WITH INSURANCE COMPANY

The Plan held a traditional guaranteed interest contract with Empower Annuity Insurance Company of America. This contract met the fully benefit-responsive investment contract criteria and was reported at contract value, which is the relevant measure for these insurance contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represented contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract was terminated in 2024 in conjunction with the sponsor change resulting from the merge into the IMEG Plan. The contract value of the investment contract was \$85,095 at December 31, 2023.

The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate was established by the contract issuer and could not be less than 1%. The crediting rate was reviewed on a quarterly basis for resetting. The contract permitted the insurance company to terminate the agreement with 90 days advance written notice prior to the scheduled maturity date.

NOTE 4 – CONTRACT WITH INSURANCE COMPANY (continued)

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

The contract permitted the insurance company to terminate the agreement with 90 days advance written notice prior to the scheduled maturity date. In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events included the following:

1. The Plan or trust failed to meet the requirements of Code section 401(a) of the Internal Revenue Code;
2. The sponsor failed to provide information to the issuer necessary to perform under the contract and failed to remedy the failure within 31 days from the notification date;
3. The Plan trust is amended in a way that adversely affects the issuer's obligations under the contract;
4. All contracts in this class of business were amended, changed or altered due to changes in any applicable laws and the issuer determined that its obligations under the contract or ability to maintain this class of business were thereby materially affected;
5. The assets held or the participants covered under contract were less than the amount required for the contract to be a group annuity under any applicable insurance law;
6. The sponsor changed such that it is no longer considered to be an entity which is authorized or eligible to sponsor the contract;
7. No contributions were made to the issuer during any consecutive 12 month period;
8. At any time the contributions or balances were less than the amount required for this class of business under the issuer's underwriting standards in effect as of the contract effective date.

NOTE 5 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants that is disclosed in the accompanying financial statements, including investments held and notes receivable from participants at December 31, 2023, and net appreciation in fair value of investments, dividends and interest for the period ended August 1, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, "Empower") the custodians of the Plan.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by Empower and affiliates. Therefore, transactions with Empower and its affiliates qualified as party-in-interest transactions. Fees were paid by the Plan to these parties for administrative services. Additionally, these parties received group annuity contract charges to offset their Plan administration costs.

NOTE 7 – PLAN MERGER AND TRANSFER OF ASSETS TO ANOTHER PLAN

Effective August 1, 2024, the Plan was merged with the IMEG Plan (see Note 1). Assets of approximately \$10,471,000 (including approximately \$88,000 in notes receivable to participants) were transferred to the IMEG Plan.

NOTE 8 – TAX STATUS

The Plan operated under provisions of a Pre-Approved Plan which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the Pre-Approved Plan, as then designed, was acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. The Plan Administrator believed that the Plan was designed and was being operated in compliance with the applicable provisions of the IRC, and therefore, believed that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. GAAP required the Plan Administrator to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan allowed participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
